PAC CONTRIBUTIONS UP 10 PERCENT FOR '92 RACES AT 18-MONTH MARK

WASHINGTON -- A review of PAC activity for the first 18 months of the 1991-92 election cycle shows that contributions to federal candidates have risen 10 percent over 1990 levels.

According to a report issued today by the Federal Election Commission, PAC's contributed \$112.1 million to federal candidates between January 1, 1991 and June 30, 1992. Of that total, \$102.9 million was given to candidates seeking election in 1992. During the first 18 months of 1989-90, the total contributed by PAC's was \$101.6 million, with \$93.8 million of the total going to 1990 candidates.

The increase in PAC giving may be due to an unusual combination of factors at work in the 1992 elections: redistricting, a high number of retirements, two open-seat senate races in California, and a set of senate seats which have, in the past, been highly competitive.

Of the \$112.1 million contributed, incumbents received \$91.6 million, challengers were given \$8.2 million, and open seat candidates, \$12.3 million. Of the \$101.6 million contributed during 1989-90, incumbents received \$86.3 million, challengers, \$7.2 million, and open seat candidates, \$8.1 million.

Historically, PAC's contribute the bulk of their monies during this time period to incumbents. A twelve-year overview of the percentage of PAC contributions given during similar 18-month periods to House incumbents, challengers and open seat candidates is attached to this release. The figures listed are only for PAC contributions given to candidates seeking election in those cycles.

PAC's raised \$283.6 million and spent \$247.7 million during the period covered by the FEC report. Cash remaining to begin the last six months of the election year was \$138.7 million. Independent expenditures totalled \$2.6 million, all but \$500,000 of which was spent for or against 1992 candidates. Presidential candidates benefitted from \$1.5 million, leaving almost \$600,000 spent for or against Congressional candidates. A similar amount was spent in 1989-90.

The following pages provide comprehensive data on PAC financial activity for the first 18 months of the 1991-92 election cycle and comparable summary statistics for six previous election cycles. Rankings of the "Top 50" PAC's follow the tables.
