SUBJECT: Debt Settlement Plan #24-02: Northstar Leadership PAC

(C00386573)

Northstar Leadership PAC ("Committee") has submitted a debt settlement plan ("DSP" or "plan") for Commission approval. The DSP discloses that the Committee has cash on hand totaling \$9,583.37, owes a total of \$36,432.25 to one creditor, and has offered that creditor a settlement of \$7,083.37. We recommend the Commission approve the debt settlement plan because it satisfies the regulatory factors the Commission considers in evaluating such plans.

I. THE COMMISSION SHOULD APPROVE THE COMMITTEE'S DEBT SETTLEMENT PLAN

A. The Debt Settlement Plan Meets the Six Factors Under Section 116.7

The Commission reviews debt settlement plans to ensure that neither excessive nor prohibited contributions result from the creation and settlement of a committee's debts. Debts Owed by Candidates and Political Committees, 55 Fed. Reg. 26378 (June 27, 1990). The

Id. at 2-3. After filing the DSP, the Committee filed its 2023 Year End Report which discloses cash on hand of \$9,586.42. Commission considers six factors in evaluating debt settlement plans: (1) information provided by the Committee and its creditors; (2) the amount of each debt that remains unpaid and the length of time each debt has been overdue; (3) the amount and percentage of each debt that would be forgiven under the plan; (4) the total amount of debts and obligations owed by the terminating committee to all creditors, compared to the total amount of cash on hand and other amounts available to pay those debts and obligations; (5) the year-to-date expenditures and receipts of the terminating committee; and (6) whether the total percentage that was or will be repaid on any loans made by the candidate to the terminating committee is comparable to the total percentage that was or will be paid to other creditors. 11 C.F.R. § 116.7(f)(1)-(6).

Application of the Six Factors.

With respect to the first factor, the Committee must submit information that supports the plan. 11 C.F.R. § 116.7(f)(1); see also id. § 116.7(e) (listing required information). The supporting information must include information about the origination and satisfaction of the debt, including 1) the terms of the initial extension of credit, 2) the candidate's or the committee's efforts to satisfy the debts, and 3) the creditor's use of remedies to satisfy the debt. *Id.* § 116.7(e)(1)(i)-(iii).

The Committee submitted information in support of the DSP. The plan discloses that the Committee owes \$36,432.25 to FLS Connect, LLC for rent and consulting services. FLS Connect represents that it invoiced the Committee monthly for payment. FLS Connect represents that the terms under which it extended credit to the Committee were similar to those under which it extended credit to its non-political debtors of similar risk and obligation size. FLS Connect states that it did not agree to provide the committee additional time to pay beyond the original due dates. FLS Connect states that it invoiced the Committee monthly for past due amounts and that it periodically contacted the Committee's treasurer to request payment for overdue invoices. FLS Connect states that it eventually ceased subletting space to the Committee. Attachment at 5; 11 C.F.R. § 116.7(e)(1)(i), (iii).

The president of FLS Connect signed the plan on December 22, 2023, stating that FLS Connect followed its established procedures and past practices in approving the extension of credit, that it previously extended credit to and received prompt payment in full from the Committee, that the extension of credit was in conformity with the usual and normal practice in its trade or industry, that its efforts to collect the debt were similar to other debt collection efforts against its nonpolitical debtors, and that it accepts the Committee's settlement offer of \$7,083.37. Attachment at 6; 11 C.F.R. § 116.7(e)(1)(iv), (2).

With respect to the second and third factors, the debt totaling \$36,432.25 was incurred between August 1, 2008 and December 31, 2009. This debt remains unpaid. Under the plan, the Committee would pay \$7,083.37 in settlement of the debt.³ The proposed settlement would thus

The Committee represents that there will be residual funds totaling \$2,500 after it pays FLS Connect that it will use to pay legal and compliance-related winding down costs. *See* 11 C.F.R. § 116.7(e)(5) (requiring the debt settlement plan to include a statement regarding how residual funds will be used). As a terminating committee, the

result in FLS Connect forgiving approximately 80% of the debt. 11 C.F.R. § 116.7(f)(2)-(3). The \$36,432.25 debt represents approximately 17% of the cost of services provided by FLS Connect to the Committee, based on the Committee's reported payments of \$204,126.70 to FLS Connect in between 2006 and 2011.⁴

Analysis of the fourth factor shows that the total amount of the Committee's debt of \$36,432.25 exceeds its available cash on hand, which was \$9,586.42 as of December 31, 2023, and that the Committee has no remaining assets to liquidate.

The Committee's ability to pay its debt to FLS Connect is limited by the funds available to it or funds that the Committee may be able to raise. The plan discloses that the Committee attempted to raise funds to repay the debt but was unable to do so due to an "eroded" contributor base. Attachment at 4. The Committee has not reported raising any contributions since January 2015. Because the Committee is not active and has not received any contributions in nine years, we conclude that it may have limited ability to raise funds to pay the more than decade old debt through further fundraising efforts. The Committee has no other funds. Under such circumstances, it is unlikely the Committee would be able make additional payments.

For the fifth factor, the DSP discloses the Committee's 2023 year-to-date receipts total as \$6.86, and its year-to-date disbursements total as \$88.00.6

The sixth and final factor involves comparing the total percentage of any loans that were or will be repaid to the candidate with the total percentage that was or will be repaid to other creditors. 11 C.F.R. § 116.7(f)(6). Because the Committee is an unauthorized committee, there are no candidate loans in the debt settlement plan.

Committee may make expenditures for payments for the costs associated with the termination of political activity. 11 C.F.R. § 116.1(a).

The Committee reported 52 disbursements to FLS Connect between August 5, 2006 and January 3, 2011 totaling \$204,127 for "consulting-PAC fundraising fees," "consulting-PAC mgmt salaries, rent," "consulting-PAC fundraising," "PAC fundraising fees," "PAC fundraising dinner in MPLS," "reimb. meals for PAC meeting," and "PAC mgmt. fee: inc. sal & rent." *See* FEC Disbursements: Filtered Results https://www.fec.gov/data/disbursements/?data_type=processed&committee_id=C00386573&recipient_name=fls+connect&recipient_name=fls+connect+llc (last visited Feb. 14, 2024) (reflecting Committee's reported payments to FLS Connect). Thus, the Committee has paid approximately 83% of its total financial obligation to FLS Connect. If the Commission approves the plan, FLS Connect will ultimately forgive approximately 13% of the Committee's total financial obligation.

See Attachment at 2; 11 C.F.R. § 116.7(f)(5). The Committee's 2023 Year End Report discloses a year-to-date receipts total of \$23.42, and year-to-date disbursements total of \$176.00. See 2023 Year End Report at 2.

B. The Debt Settlement Plan Does Not Result in An Excessive Contribution to the Committee

We conclude that the foregoing factors weigh in favor of approving the debt settlement plan. 11 C.F.R. § 116.7(f). The information the Committee provided demonstrates that the debt owed to FLS Connect will be settled under the terms of the debt settlement plan and that the creditor agrees to the terms of the settlement. Because the requirements for the debt settlement plan have been met, we conclude that the debt settlement with FLS Connect would not result in an excessive contribution from that creditor to the Committee. *Id.*; *see* Debts Owed by Candidates and Political Committees, 55 Fed. Reg. at 26378. Accordingly, we recommend that the Commission approve the debt settlement plan.

II. <u>RECOMMENDATIONS</u>

- 1. Approve the debt settlement plan filed by Northstar Leadership PAC;
- 2. Approve the appropriate letter; and
- 3. Close the file.
