8 Dear Mr. Dávila-Pernas:

9 We are responding to your request on behalf of Democratic Party of Puerto Rico (the  
10 “Requestor”) regarding its status as the state committee of a political party under the Federal  
11 Election Campaign Act, 52 U.S.C. §§ 30101-45 (the “Act”), and Commission regulations. The  
12 Commission concludes that the Requestor qualifies as a state committee of a political party.

13 ***Background***

14 The facts presented in this advisory opinion are based on your letter received on February  
15 3, 2025, your supplemental submission received on February 6, 2025, public disclosure reports  
16 filed with the Commission, and other publicly available information.

17 The Democratic Party is a national political party. The Democratic National Committee  
18 (“DNC”) is responsible for the day-to-day functions of the Democratic Party. The DNC  
19 confirmed by letter dated January 27, 2025, that the Requestor is the “sole and official State  
20 Democratic Party of the Commonwealth of Puerto Rico.”<sup>1</sup> The DNC further stated that  
21 Requestor is the only party in Puerto Rico authorized to “elect DNC members and to organize  
22 the process for selecting delegates to the Democratic National Convention, the party authority  
23 responsible for nominating the Democratic Party’s candidates for President and Vice President of  
24 the United States.”<sup>2</sup>

1           The Requestor is a Democratic Party organization operating within Puerto Rico, an  
2           unincorporated territory of the United States.<sup>3</sup> The charter of the Democratic Party states that  
3           “Puerto Rico shall be treated as a state” for purposes of the charter and recognizes state party  
4           rules relating to the election of delegates to the Democratic National Convention.<sup>4</sup> Accordingly,  
5           the Requestor established the Puerto Rico Delegate Selection Plan to elect delegates to the  
6           Democratic National Convention through a “primary election to establish presidential preference  
7           and election of delegates.”<sup>5</sup> The Requestor also adopted rules regarding the Puerto Rico  
8           Democratic Presidential Primary Process and such rules were approved by both the DNC and the  
9           Puerto Rico Elections Commission.<sup>6</sup>

10          The Requestor obtained ballot access for Joe Biden on the 2024 primary election ballot in  
11          Puerto Rico.<sup>7</sup> Joe Biden appeared as a candidate of Requestor on the primary election ballot and  
12          election results from the Puerto Rico State Elections Commission displayed the Requestor’s seal  
13          next to Joe Biden picture and name.<sup>8</sup> Joe Biden’s campaign committee reported receiving  
14          contributions or making expenditures in excess of \$5,000 during the 2024 presidential election  
15          cycle.<sup>9</sup>

Pursuant to its bylaws, the Requestor engages in various political party activities in Puerto Rico.<sup>10</sup> These activities include promoting Democratic Party principles, endorsing candidates for public office, sending delegates to the Democratic Party's national convention, overseeing presidential primaries in Puerto Rico, and organizing itself as the state committee of the Democratic Party.<sup>11</sup> The Requestor's bylaws also provide the requirements for membership, establishment and composition of a Central Committee and Executive Committee.<sup>12</sup> The Executive Committee among other things is responsible for the general affairs of the Requestor, its bylaws, delegate selection plan, fundraising events, appointments, creation of advisory committees, and coordination of political strategy.<sup>13</sup> The Requestor further engages in community outreach through its website, newspaper advertising, and other media.<sup>14</sup>

### ***Question Presented***

*Does the Requestor qualify as a state committee of a political party within the meaning of the Act and Commission regulations?*

### ***Legal Analysis***

Yes, the Requestor qualifies as the state committee of a political party within the meaning of the Act and Commission regulations.

1           The Requestor is a Democratic Party organization operating within Puerto Rico, an  
2           unincorporated territory of the United States.<sup>15</sup> The Act defines “state” to include a territory or  
3           possession of the United States.<sup>16</sup>

4           Whether a state party organization qualifies as a state committee of a national political  
5           party turns on three elements: (1) the national organization affiliated with the state party  
6           organization must itself be a “political party;”<sup>17</sup> (2) the state party organization must be part of  
7           the official structure of the national party; and (3) the state party organization must be  
8           responsible for the day-to-day operation of the national party at the state level.<sup>18</sup> The  
9           Commission addresses each of these elements in turn.

10           (1)     *Qualification of the Democratic Party as Political Party*

11           The Democratic Party has placed numerous candidates for federal offices on election  
12           ballots in every state. Accordingly, the Democratic Party is a “political party” for purposes of  
13           the Act and Commission regulations.<sup>19</sup>

(2) *Status of the Requestor as Part of the Official Structure of Party*

To determine whether a state party organization is part of the official structure of a national party, the Commission evaluates documentation from the national party.<sup>20</sup> The letter from the DNC confirms that the Requestor is part of the official structure of the Democratic Party.<sup>21</sup>

(3) *Responsibility of the Requestor for Day-to-Day Operation of the Party at the State Level*

To determine whether a state party organization is responsible for the day-to-day operations of a national party at the state level, the Commission considers: (a) whether the state organization has assisted in obtaining ballot access for a federal candidate, and (b) whether the bylaws or other governing documents of the state party organization indicate activity commensurate with the day-to-day functions and operations of a political party at the state level.<sup>22</sup>

(a) *Candidate on the Ballot*

The Requestor obtained ballot access for Joe Biden on the 2024 primary election ballot in Puerto Rico.<sup>23</sup> Joe Biden's campaign committee received contributions or made expenditures in

1 excess of \$5,000 according to public disclosure reports filed with the Commission, therefore  
2 satisfying the Act’s definition of a “candidate.”<sup>24</sup>

3 (b) *Day-To-Day Functions and Operations*

4 In addition to gaining ballot access for a candidate for federal office, the Requestor must  
5 show, in its bylaws, constitution, or other governing documents, that it is responsible for activity  
6 commensurate with the day-to-day functions and operations of a national political party at the  
7 state level.

8 Here, the bylaws indicate that the Requestor engages in various political party activities  
9 in Puerto Rico.<sup>25</sup> These activities include promoting Democratic Party principles, endorsing  
10 candidates for public office, sending delegates to the Democratic Party’s national convention,  
11 overseeing presidential primaries in Puerto Rico, and organizing as the state committee of the  
12 Democratic Party.<sup>26</sup> The Requestor’s bylaws also provide the requirements for membership,  
13 establishment and composition of a Central Committee and Executive Committee including the  
14 election of members to such committees.<sup>27</sup> The Executive Committee among other things is  
15 responsible for the general affairs of the Requestor, its bylaws, delegate selection plan,  
16 fundraising events, appointments, creation of advisory committees and coordination of political  
17 strategy.<sup>28</sup>

1           The Requestor's bylaws indicate activity commensurate with the day-to-day functions  
2   and operations of a political party at the state level and are similar to other state party rules that  
3   the Commission has found sufficient to qualify an organization for state-committee status.<sup>29</sup> The  
4   Requestor therefore satisfies the requirement of being responsible for the day-to-day operation of  
5   the Democratic Party at the state level pursuant to 52 U.S.C. § 30101(15) and 11 C.F.R.  
6   § 100.14(a).

7           The Commission concludes that the Requestor qualifies as the state committee of a  
8   political party under the Act and Commission regulations because: (1) the Democratic Party  
9   qualifies as a "political party"; (2) the Requestor is part of the official structure of the  
10   Democratic Party; and (3) the Requestor is responsible for the day-to-day operation of the  
11   Democratic Party at the state level.

12           This response constitutes an advisory opinion concerning the application of the Act and  
13   Commission regulations to the specific transaction or activity set forth in your request.<sup>30</sup> The  
14   Commission emphasizes that, if there is a change in any of the facts or assumptions presented,  
15   and such facts or assumptions are material to a conclusion presented in this advisory opinion,

1 then the Requestor may not rely on that conclusion as support for its proposed activity. Any  
2 person involved in any specific transaction or activity which is indistinguishable in all its  
3 material aspects from the transaction or activity with respect to which this advisory opinion is  
4 rendered may rely on this advisory opinion.<sup>31</sup> Please note that the analysis or conclusions in this  
5 advisory opinion may be affected by subsequent developments in the law including, but not  
6 limited to, statutes, regulations, advisory opinions, and case law. Any advisory opinions cited  
7 herein are available on the Commission's website.
