SUBJECT: Status of Enforcement – Fiscal Year 2026, First Quarter (10/1/2025 to 12/31/2025)

To assist the Commission and the Office of General Counsel in assessing the current productivity of the Commission’s enforcement program, we submit the Status of Enforcement for the first quarter (10/1/2025 to 12/31/2025). The tables that follow provide information to assist agency management in its review of the enforcement program.

At the close of the quarter, the total enforcement caseload was 195 matters — 156 active and 39 inactive. During the first quarter, the Enforcement Division circulated First General Counsel’s Reports (“FGCRs”) in 14 matters in an average of 203 days, meeting the internal circulation goal 50% of the time. The Enforcement Division’s Office of Complaints Examination & Legal Administration (“CELA”) circulated EPS reports for four matters in an average of 35 days from assignment. Two matters were pending in the investigation stage at the close of the quarter. Finally, attorney staffing in the Enforcement Division at the close of the quarter stood at 17 staff attorneys, five team leaders (one in CELA), and two deputies. Enforcement staff was furloughed during the quarter from October 1, 2025, to November 13, 2025.
