We are withdrawing the document circulated to the Commission on June 23, 2008 in order to reflect updates disclosed in recent filings received by the Commission. Attached is the list of political committees and their treasurers who failed to file the 2008 April Quarterly Report in accordance with 2 U.S.C. 434(a). The April Quarterly Report was due on April 15, 2008.

The committees listed in the attached RTB Circulation Report either failed to file the report, filed the report more than five (5) days after the due date, or filed the report more than thirty (30) days after the due date (considered a non-filed report). In accordance with the schedule of civil money penalties for reports at 11 CFR 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

Recommendation

1. Find reason to believe that the political committees and their treasurers listed on the RTB Circulation Report violated 2 U.S.C. 434(a) and make a preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.
2. Send the appropriate letters.

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires that your committee file an April Quarterly Report of Receipts and Disbursements in a calendar year during which there is a regularly scheduled election. This report, covering the period through March 31st, 2008, shall be filed no later than April 15th, 2008. 2 U.S.C. 434(a). Records at the Federal Election Commission ("FEC") indicate that this report was filed on 5/6/2008, 21 days late.

The Act was further amended in 1999 to permit the FEC to impose civil money penalties for violations of the reporting requirements of 2 U.S.C. 434(a). 2 U.S.C. 437g(a)(4). On 9/19/2008, the FEC found that there is reason to believe ("RTB") that Sun Political Action Committee (SUNPAC) and you, as treasurer, violated 2 U.S.C. 434(a) by failing to file timely this report on or before April 15th, 2008. To Pay the Calculated Civil Money Penalty

To challenge the RTB finding and/or calculated civil money penalty, you must submit a written response, including the AF# found on page one, to the FEC's Office of Administrative Review, 999 E Street, NW, Washington, DC 20463. Your response must be received by

10/29/2008. Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty. The FEC will only consider challenges that are based on a factual error in the RTB finding; miscalculation of the calculated civil money penalty by the FEC; or your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. In order for a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to, a failure of Commission computers or Commission-provided software despite you seeking technical assistance from Commission personnel and resources; a widespread disruption of information transmissions over the Internet that is not caused by the Commission's or your computer systems or Internet service provider; and severe weather or other disaster-related incident. **Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to, negligence; delays caused by vendors or contractors; treasurer and staff illness, inexperience or unavailability; committee computer, software, or internet service provider failures; failure to know filing dates; and failure to use filing software properly.** Your response must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 C.F.R. 111.35.

Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of your right to present such argument in a petition to the district court under 2 U.S.C. 437g. 11 C.F.R. 111.38.

If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

If You Do Not Pay the Calculated Civil Money Penalty or Submit a Challenge

If you do not pay the calculated civil money penalty or submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that Sun Political Action Committee (SUNPAC) and you, as treasurer, violated 2 U.S.C. 434(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. 3701 et seq. The FEC may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 C.F.R. 111.45.

This matter was generated based on information ascertained by the FEC in the normal course of carrying out its supervisory responsibilities. 2 U.S.C. 437g(a)(2). It will remain confidential in accordance with 2 U.S.C. 437g(a)(4)(B) and 437g(a)(12)(A) until it is placed on

This reporting requirement is in addition to the requirement to file 24-hour reports of independent expenditures each time disbursements for independent expenditures in connection with that election aggregate or exceed \$1,000 during the last 20 days—up to 24 hours—before an election. PACs and Party Committees must report independent expenditures that do not trigger the 48- or 24-hour reporting thresholds on their regularly-scheduled disclosure reports. See 11 CFR 104.4.

CHANGE IN FILING FREQUENCY

On September 19, 2008, the Commission found reason to believe ("RTB") that the respondents violated 2 U.S.C. § 434(a) for failing to timely file the 2008 April Quarterly Report and made a preliminary determination that the civil money penalty was \$1,875 based on the schedule of penalties at 11 C.F.R. § 111.43. They were notified by the Reports Analysis Division ("RAD") on September 22, 2008 of the Commission's RTB finding and civil money penalty.

Respondents' Response

On October 22, 2008, the Commission received the written response ("challenge") from the Treasurer requesting that the Commission abate the late filing penalty because they had substantial problems with the FEC software. Further, as soon as the technical problems were resolved, the report was immediately and successfully uploaded. The Treasurer also asserts that the Committee has never filed a report late, with the exception of the 2008 April Quarterly Report, and he understands the importance of meeting all filing deadlines.

Analysis

The 2008 April Quarterly Report was filed on May 6, 2008, 21 days late.

The Federal Election Campaign Act ("Act") states that the treasurer of committee not authorized by a candidate shall file, in an election year, a report for the period ending March 30 no later than April 15. 2 U.S.C. § 434(a)(4)(A)(i) and 11 C.F.R. § 104.5(c)(1)(i). Political committees required to file reports with the Commission must file in an electronic format if they received or expect to receive contributions or made or expect to make expenditures in a calendar year aggregating in excess of \$50,000. 2 U.S.C. § 434(a)(11) and 11 C.F.R. § 104.18(a). Reports filed electronically must be received and validated at or before 11:59 pm Eastern Standard/Daylight Time on April 15 to be timely filed. 11 C.F.R. §§ 100.19(c) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

The Treasurer asserts that he had substantial problems with FECFile, the FEC's filing software, and that he was in constant communication with his RAD analyst. He also claims that he was in contact with the Electronic Filing Office ("EFO") to resolve the problems he experienced with the software.

The telephone records provided by RAD, as well as the supplemental response from RAD about the telephone conversations, indicate that he did not call their RAD Analyst about

difficulties filing this report, as he did for the prior report. The telephone records provided by the EFO indicate that the Treasurer did not call for assistance until April 30, 15 days after the due date of the report. At that time, the EFO staff left a voicemail message for him and asked him to call back if he still required assistance. However, the Treasurer did not return the call until May 6, six days after his initial call, and sought help with a validation error. After he emailed the data set to the EFO on May 6, the EFO staff instructed the Treasurer on how to close the report, which enabled him to upload it, 21 days after the due date of April 15.

Their challenge fails to address any of the three valid excuses at 11 C.F.R. § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. The Administrative Fine regulations specifically state that delays caused by the failure to use filing software properly do not constitute reasonably unforeseen circumstances. 11 C.F.R. § 111.35(d).

Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 2 U.S.C. § 434(a) and assess a civil money penalty of \$1,875.

OAR Recommendations

- (1) Adopt the Reviewing Officer recommendation for AF# 1818 involving the Sun Political Action Committee (SUNPAC) and Stewart L. Appelrouth, as Treasurer, in making the final determination;
- (2) Make a final determination in AF# 1818 that the Sun Political Action Committee (SUNPAC) and Stewart L. Appelrouth, as Treasurer, violated 2 U.S.C. § 434(a) and assess a civil money penalty of \$1,875; and
- (3) Send the appropriate letter.




On September 19, 2008, the Federal Election Commission ("Commission") found reason to believe ("RTB") that the Sun Political Action Committee (SUNPAC) and you, as Treasurer ("respondents"), violated 2 U.S.C. § 434(a) for failing to timely file the 2008 April Quarterly Report. The Commission also made a preliminary determination that the civil money penalty was \$1,875 based on the schedule of penalties at 11 C.F.R. § 111.43.

After reviewing the written response and any supplemental information submitted by you and Commission staff, the Reviewing Officer has recommended that the Commission make a final determination in this matter. A copy of the Reviewing Officer's recommendation is attached.

On September 19, 2008, the Commission found reason to believe ("RTB") that the respondents violated 2 U.S.C. § 434(a) for failing to timely file the 2008 April Quarterly Report. As a result, the Commission also made a preliminary determination that the civil money penalty was \$1,875 based on the schedule of penalties at 11 C.F.R. § 111.43.

On October 22, 2008, the Commission received their written response ("challenge"). After reviewing the challenge, the Reviewing Officer's recommendation dated December 5, 2008 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference. The Reviewing Officer recommended that the Commission make a final determination that they violated 2 U.S.C. § 434(a) and assess a \$1,875 civil money penalty because they submitted no evidence that a factual error was made in the RTB finding, that the penalty was miscalculated at RTB or that they used best efforts to file on time. 11 C.F.R. § 111.35(b).

Within 10 days of transmittal of the recommendation, they may file a written response with the Commission Secretary which may not raise any arguments not raised in

their challenge or not directly responsive to the Reviewing Officer's recommendation. 11 C.F.R. § 111.36(f). A response was received from the Treasurer on January 5, 2009.

In his response, the Treasurer says that he "adamantly disagree[s]" with the Reviewing Officer recommendation ("ROR") and addresses the issue raised in it and the challenge: he had substantial problems with the FECFile software, he was in contact with his Reports Analysis Division ("RAD") Analyst and the Electronic Filing Office ("EFO") staff about these problems, and filed the report as soon as the problems were resolved. He also provides new facts: he prepared and was ready to file the report before the due date but could not upload it because of errors he could not fix; he immediately called the Analyst and left messages; she called back several days later but he was sick and out of the office; he called her back, she did not answer but subsequently called back and tried to help him; her solution did not work so he called the EFO as she suggested and left a message; and the EFO staff called back but they could not help and referred him back to the Analyst who finally helped him solve the problem so he could upload the report.

On February 12, 2009, OAR asked RAD if it was possible that the Analyst spoke with the Treasurer about his efforts to file the report but may not have documented the contacts because of the heavy call volume during the filing period. In her March 2 response, the Unauthorized Branch Chief explains that it is possible, during filing periods when call volume is particularly heavy, that a conversation may occur about filing requirements or difficulties and not be documented. She says it is possible that the Analyst spoke with him yet RAD has no documented record for the 2008 April Quarterly Report and the Analyst assigned to this Committee was not in the office on May 6, 2008, the day on which the Treasurer states that he was able to successfully upload the report with her help.

Because the respondents say that they tried but could not upload the report before and after it was due, OAR asked the Information Technology Division ("ITD") Manager on May 7, 2009 if the EFO records show any network connections between the Commission's electronic filing system and the Committee which would indicate that they tried to upload the report or that the report failed validation and a rejection notice was emailed to them.

According to the ITD Manager's May 12 response, the EFO logs any successful network connection between a filer's computer hardware and the Commission's electronic filing system. This log retains either the source IP address which is usually the filer's computer or the IP address of the firewall or proxy server where the connection originated. A filer may successfully connect to the electronic filing system, so that connection and IP address will be logged, but the filer does not complete the upload process after establishing the connection. He provides two examples of this: the filer discontinues the upload process or the filer experiences a local or internet interruption, or disconnection. On May 6, there is a log of the IP address used by the Treasurer to upload the report. There is no other connection by that IP address for the period between April 1 and May 6.

The Treasurer says he spoke to the Analyst before and after the report was due but he does not provide the dates of these contacts. RAD has no records of contacts with him about the report but it is possible the Analyst spoke to him and did not document their conversations. The Treasurer's contacts with the EFO appear to have occurred after the due date; again, he does not provide any dates. The EFO's April 30 log supports the Treasurer's assertion that he called and left a message, and they called him back. The EFO log differs, however, in that the EFO staff left a message for him, telling him to call back if he still needed help, whereas the Treasurer states the EFO staff could not help him and referred him back to the Analyst. The Treasurer does not refer to any other contact with the EFO staff but the EFO logs show that they, not the Analyst, spoke with him on May 6. The EFO staff told him to email the Committee's FECFile data set to her (which he did), explained how to close the report, and waited on the phone until he successfully uploaded it.

The Treasurer asserts that he sought technical assistance from Commission staff with the FECFile software because he could not upload the report. Yet, the EFO logs and ITD Manager's responses indicate that this is not a situation involving the failure of the FECFile software. In fact, the logs show that the validation error he spoke to the EFO staff about on May 6 was one of several steps in the upload process. The ITD Manager explains that subsequent tests on the data set also found no validation errors or other problems that would have prevented the Treasurer from uploading the report. A review of the IP address logs for the period before and after April 15 indicate that the only successful connection to the electronic filing system occurred on May 6.

The administrative fines regulations provide for a best efforts defense under which the Commission may decide that no violation occurred because the respondents used their best efforts to file on time. 11 C.F.R. § 111.35(b)(3) and (c). The best efforts defense is a two-part test. The first part consists of the respondents demonstrating that they were prevented from filing on time by reasonably unforeseen circumstances that were beyond their control.

One example of a circumstance that will be considered reasonably unforeseen and beyond their control is a failure of Commission-provided software despite the respondents seeking technical assistance from Commission personnel and resources. 11 C.F.R. § 111.35(c)(1). Just as the administrative fine regulations provide examples of circumstances that will be considered reasonably unforeseen and beyond the respondents' control, the regulations also provide examples of circumstances that will not be considered reasonably unforeseen and beyond their control. One of these examples is the failure to use filing software properly. 11 C.F.R. § 111.35(d)(6).

The Reviewing Officer believes that that is what occurred in this case: the Treasurer sought help because he did not complete all the required steps in the upload process. As part of the signing and dating of the report in the FECFile software, the filer must also close the report (the FECFile User's Manual for Party Committees and PACs on the Commission's website includes this as part of the instructions for uploading reports). Had the Treasurer done so, he should have been able to successfully upload the

report and complete the validation process as subsequent tests on the report's data set show that there were no other problems which would have prevented its upload.

The Reviewing Officer, therefore, recommends that the Commission make a final determination that the respondents violated 2 U.S.C. § 434(a) and assess a civil money penalty of \$1,875.

OAR Recommendations

- (1) Adopt the Reviewing Officer recommendation for AF# 1818 involving the Sun Political Action Committee (SUNPAC) and Stewart L. Appelrouth, as Treasurer, in making the final determination;
- (2) Make a final determination in AF# 1818 that the Sun Political Action Committee (SUNPAC) and Stewart L. Appelrouth, as Treasurer, violated 2 U.S.C. § 434(a) and assess a civil money penalty of \$1,875; and
- (3) Send the appropriate letter.

File Submission

When all transactions have been entered for a report, and the deadline for reporting is imminent, the final details must be collected in order to file electronically. There are several different ways a user may file, and with detailed information following.

Filing Requirements

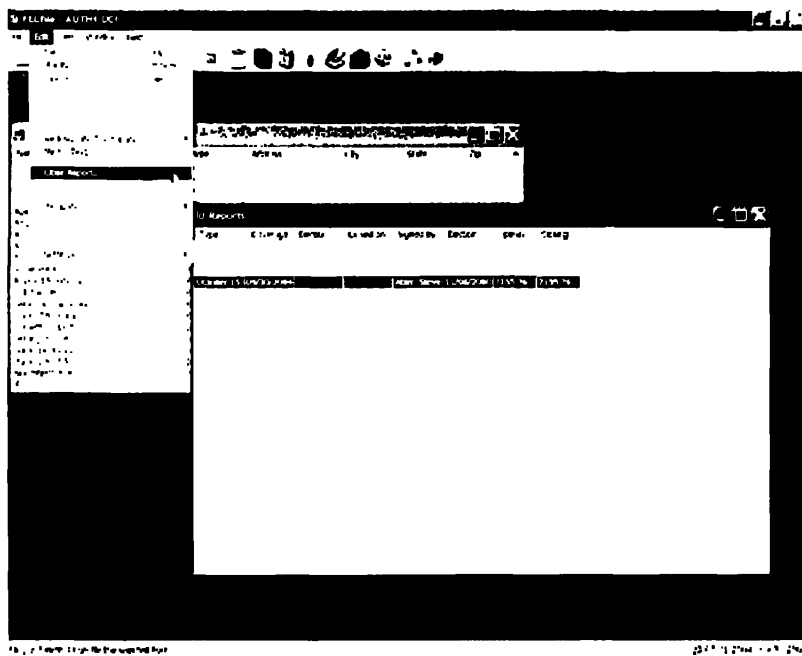
- ✓ **The user must have an FEC electronic filing password. This is REQUIRED. They must contact the FEC electronic filing office if they do not have a password, or if it has been forgotten.**

The user must have a modem and phone line connection for dial up, or a network connection to the Internet. (When no other option is available, filing on diskette or CD is an option). The report must pass validation.

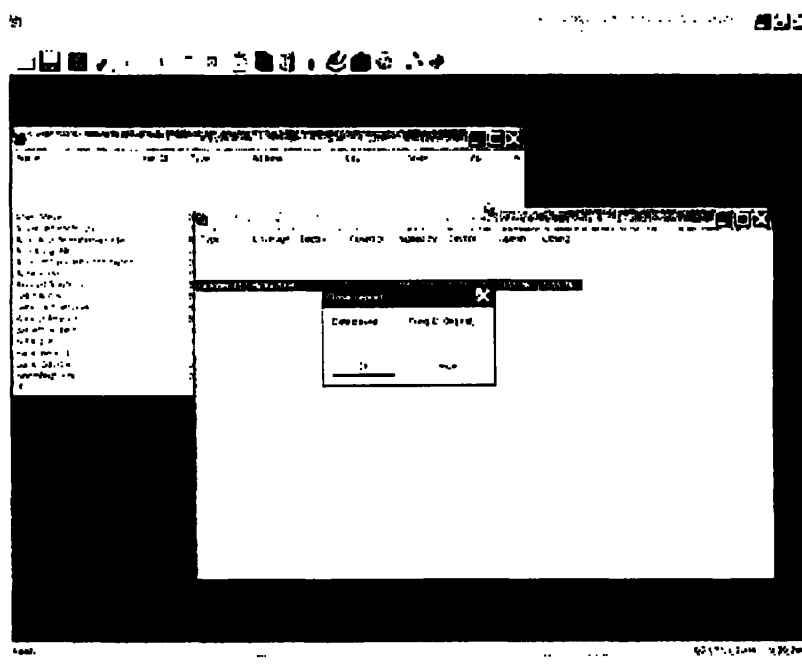
Signing and Dating the Report

If the report is not properly signed and dated, the validator will note that the information is missing and generate Level 12 (serious level) errors, and uploading will not be possible. If the report is not ready to actually upload, but want to validate it, the user may want to leave the report date blank.

- ✓ To sign the report, double click on the report type in the Reports Window. This will open the report information window. The Treasurer must be selected in the 'Signed by' field. Date the report, select **Close Report** from the edit menu or right click on the report to close in the **Reports** window. This can only be done with the Reports View active.

On September 19, 2008, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Sun Political Action Committee (SUNPAC) and you, as Treasurer, violated 2 U.S.C. § 434(a) for failing to timely file the 2008 April Quarterly Report. By letter dated September 22, 2008, the Commission sent you notification of the RTB finding that included a civil money penalty calculated at RTB of \$1,875 in accordance with the schedule of penalties at 11 C.F.R. § 111.43. On October 22, 2008, the Office of Administrative Review received the written response from you, challenging the RTB civil money penalty.

The Reviewing Officer reviewed the Commission's RTB finding with its supporting documentation and the written response. Based on this review, the Reviewing Officer recommended that the Commission make a final determination that Sun Political Action Committee (SUNPAC) and you, as Treasurer, violated 2 U.S.C. § 434(a) and assess a civil money penalty in the amount of \$1,875 in accordance with 11 C.F.R. § 111.43. The basis for the Reviewing Officer's recommendation was included in the Final Determination Report, a copy of which was sent to you on December 8, 2008.

On June 3, 2009, the Commission adopted the Reviewing Officer's recommendation and made a final determination that Sun Political Action Committee (SUNPAC) and you, as Treasurer, violated 2 U.S.C. § 434(a) and assessed a civil money penalty of \$1,875. It is based on the same factors used to calculate the civil money penalty at RTB. A copy of the final determination recommendation is attached.

To Pay the Civil Money Penalty

If you should decide to pay the civil money penalty, send the enclosed form and payment to the address on page 3 within 30 days of receipt of this letter.

If You Do Not Pay the Civil Money Penalty

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection

Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701 et seq. If you do not pay this debt within 30 days (or file a written petition to a federal district court - see below), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Within 5 days of the transfer to Treasury, Treasury will contact the debtor and request payment. Treasury currently charges a fee of 28% of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency ("PCA"). If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

If You Choose to Appeal the Final Determination and/or Civil Money Penalty

If you choose to appeal the final determination, you should submit a written petition, within 30 days of receipt of this letter, to the district court of the United States for the district in which the committee or treasurer reside, or transact business, requesting that the final determination be modified or set aside. See 2 U.S.C. § 437g(a)(4)(C)(iii). Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of the respondents' right to present such argument in a petition to the district court under 2 U.S.C. § 437g. 11 C.F.R. § 111.38.

The confidentiality provisions at 2 U.S.C. § 437g(a)(12) no longer apply and this matter is now public. The file will be made a part of the public record pursuant to 11 C.F.R. § 111.42(b). Although the file must be placed on the public record within 30 days from the date of the Commission's notification, this could occur at any time following certification of the Commission's vote.
