Attached is a list of political committees and their treasurers who failed to file the 2008 July Quarterly Report in accordance with 2 U.S.C. 434(a). The July Quarterly Report was due on July 15, 2008.

The committees listed in the attached RTB Circulation Report either failed to file the report, filed the report more than five (5) days after the due date, or filed the report more than thirty (30) days after the due date (considered a non-filed report). In accordance with the schedule of civil money penalties for reports at 11 CFR 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

**Recommendation**

1. Find reason to believe that the political committees and their treasurers listed on the RTB Circulation Report violated 2 U.S.C. 434(a) and make a preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.
2. Send the appropriate letters.

Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to, a failure of Commission computers or Commission-provided software despite you seeking technical assistance from Commission personnel and resources; a widespread disruption of information transmissions over the Internet that is not caused by the Commission's or your computer systems or Internet service provider; and severe weather or other disaster-related incident. **Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to, negligence; delays caused by vendors or contractors; treasurer and staff illness, inexperience or unavailability; committee computer, software, or internet service provider failures; failure to know filing dates; and failure to use filing software properly.** Your response must include the factual basis supporting the reason(s) and supporting documentation. Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of your right to present such argument in a petition to the district court under 2 U.S.C. 437g. 11 C.F.R. 111.38.

If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

Attached are two lists of political committees and their treasurers against which the Commission has found reason to believe (RTB) and assessed proposed civil money penalties calculated at RTB for failure to file or failure to timely file the 2008 July Quarterly Report. The first list represents the committees that have paid the civil money penalty and the second list represents those committees that have not paid the civil money penalty. The committees that have not paid have been given at least forty (40) days from the date of the Commission's RTB finding to remit payment.

In accordance with 11 CFR 111.34 and 11 CFR 111.40, the Commission shall send a final determination notice to those respondents that have either paid or not paid the civil money penalty.

For your information, twelve (12) committees disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. Of these, four (4) committees will be assessed a civil money penalty at Final Determination (FD) that has been reduced since the RTB finding, and eight (8) committees will be assessed a civil money penalty of \$0 at FD. An overview of each of these cases has been provided below.

Boh Hill for Congress (AF 1838) filed a report to cover the 2008 July Quarterly coverage dates after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$107,467), thus the fine would be lowered from \$4,500 to \$0.

Buckey for Senate (AF 1839) filed a report to cover the 2008 July Quarterly coverage dates after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$2,649 (previously estimated to be \$67,743), thus the fine would be lowered from \$2,700 to \$250.

Chase for Senate (AF 1841) filed the 2008 July Quarterly Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$33,324), thus the fine would be lowered from \$900 to \$0.

Committee to Re-Elect Bobby Jindal Inc. (AF 1844) disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$27,090), thus the fine would be lowered from \$900 to \$0.

Derrick Shepherd Campaign Committee (AF 1850) filed the 2008 July Quarterly Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$87,128), thus the fine would be lowered from \$4,375 to \$0.

Finegold Committee (AF 1853) filed the 2008 July Quarterly Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$303,583), thus the fine would be lowered from \$8,000 to \$0.

John Rounsaville for Congress (AF 1858) disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$3,032 (previously estimated to be \$182,439), thus the fine would be lowered from \$5,500 to \$250.

Kopplin for Congress (AF 1861) filed the 2008 July Quarterly Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$16,383 (previously estimated to be \$318,557), thus the fine would be lowered from \$8,000 to \$500.

Naehbar for Congress (AF 1863) filed a report to cover the 2008 July Quarterly coverage dates after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$143,916), thus the fine would be lowered from \$4,500 to \$0.

Ricardo Munoz for Congress (AF1865) disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$172,578), thus the fine would be lowered from \$5,500 to \$0.

Robinson for Congress (AF 1866) filed the 2008 July Quarterly Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$12,000 (previously estimated to be \$41,965), thus the fine would be lowered from \$900 to \$500.

Sean O'Kane for US Congress Committee (AF 1869) disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$115,810), thus the fine would be lowered from \$4,500 to \$0.

- (1) Make final determination that the political committees and their treasurers on the attached reports violated 2 U.S.C. 434(a) and assess the final civil money penalties so indicated.

On 9/19/2008, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Cindy for Congress and you, as treasurer, violated 2 U.S.C. 434(a) for filing late or failing to file the 2008 July Quarterly Report. By letter dated 9/22/2008, the Commission sent you notification of the RTB finding that included a civil money penalty calculated at the RTB stage of **\$5,500** in accordance with the schedule of penalties at 11 C.F.R. 111.43.

On 10/28/2008, the FEC received payment of your civil money penalty calculated at the RTB stage. The FEC made a final determination on 11/20/2008 that you, as treasurer, and Cindy for Congress violated 2 U.S.C. 434(a), assessed a civil money penalty in the amount of **\$5,500** in accordance with 11 C.F.R. 111.43, and voted to close the file.

The confidentiality provisions at 2 U.S.C. 437g(a)(12) no longer apply and this matter is now public. The file will be made a part of the public record pursuant to 11 C.F.R. 111.42(b).
