SUBJECT: Reason To Believe Recommendation – 2014 12 Day Pre-General Report
(Unauthorized Committees – Monthly Filers) for the Administrative Fine
Program

Attached is a list of political committees and their treasurers who failed to file or timely file the 2014 12 Day Pre-General Report in accordance with 52 U.S.C. § 30104(a) (formerly 2 U.S.C. 434(a)). The 12 Day Pre-General Report was due on October 23, 2014 and the General Election was held on November 4, 2014. The list is comprised of unauthorized committees that file monthly.

The committees listed on the attached RTB Circulation Report either filed the election sensitive report after the due date, failed to file the report or failed to file the report prior to four (4) days before the General Election (considered a non-filed report). In accordance with the schedule of civil money penalties at 11 CFR 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

Recommendation

1. Find reason to believe that the political committees and their treasurers listed on the RTB Circulation Report violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. 434(a)) and make a

preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.

2. Send the appropriate letters.

Dear Mr. Collins:

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires that your committee file a 12 Day Pre-General Report of Receipts and Disbursements in a calendar year during which there is a regularly scheduled election. This report, covering the period October 1, 2014 through October 15, 2014, shall be filed no later than October 23, 2014. 52 U.S.C. § 30104(a) (formerly 2 U.S.C. 434(a)). Because records at the Federal Election Commission ("FEC") indicate that you did not file this report prior to four (4) days before the General Election held on November 4, 2014, the report is considered not filed for the purpose of calculating the civil money penalty.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 52 U.S.C. § 30104(a) (formerly 2 U.S.C. 434(a)). 52 U.S.C. § 30109(a)(4) (formerly 2 U.S.C. 437g(a)(4)). On December 17, 2014, the FEC found that there is reason to believe ("RTB") that CSL Behring Employees Political Action Committee and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. 434(a)) by failing to file timely this report on or before October 23, 2014. Based on the FEC's schedules of civil money penalties at 11 CFR § 111.43, the amount of your civil money penalty calculated at the RTB stage is \$550. Please see the attached copy of the Commission's administrative fine regulations at 11 CFR §§ 111.30-111.55. Attachment 1. The Commission's website contains further information about how the administrative fine program works and how the fines are calculated. See <http://www.fec.gov/af/af.shtml>. 11 CFR § 111.34. Your payment of \$550 is due within forty (40) days of the finding, or by January 26, 2015, and is based on these factors:

Election Sensitivity of Report: Election Sensitive

Level of Activity: \$4,332

Number of Days Late: Not Filed (reports not filed prior to four (4) days before the General Election held on November 4, 2014 are considered not filed for the purpose of calculating the penalty)

Number of Previous Civil Money Penalties Assessed: 0

At this juncture, the following courses of action are available to you:

1. If You Choose to Challenge the RTB Finding and/or Civil Money Penalty

If you should decide to challenge the RTB finding and/or calculated civil money penalty, you must submit a written response, including the AF# found at the top of page 1 under your committee's identification number, to the FEC's Office of Administrative Review, 999 E Street, NW, Washington, DC 20463. Your response must be received within forty (40) days of the Commission's RTB finding, or January 26, 2015. 11 CFR § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty, and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 CFR § 111.36(c).

The FEC will only consider challenges that are based on at least one of three grounds: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 CFR § 111.35(b). In order for a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. *Id.* Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) a failure of Commission computers or Commission-provided software despite your seeking technical assistance from Commission personnel and resources; (2) a widespread disruption of information transmissions over the Internet that is not caused by a failure of the Commission's or your computer systems or Internet service provider; and (3) severe weather or other disaster-related incident. 11 CFR § 111.35(c). Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) negligence; (2) delays caused by vendors or contractors; (3) treasurer and staff illness, inexperience or unavailability; (4) committee computer, software, or Internet service provider failures; (5) failure to know filing dates; and (6) failure to use filing software properly. 11 CFR § 111.35(d).

The "failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver" of your right to present such argument in a petition to the U.S. district court under 52 U.S.C. § 30109 (formerly 2 U.S.C. § 437g). 11 CFR § 111.38.

If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge

If you do not pay the calculated civil money penalty and do not submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that CSL Behring Employees Political Action Committee and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701 *et seq.* The FEC may take any and all appropriate

I am in receipt of your letter stating that as Treasurer of the CSL Behring Employees Political Action Committee, the 12 Day Pre-General Report of Receipts that was to be filed by October 23, 2014 was not filed. I would like to challenge this finding and ask that the civil penalty of \$550 be repealed.

In support of my appeal, I would like to submit the following:

12 Day Pre-General Report of Receipts

On the website www.fec.gov the 12-day Pre-general Report of Receipts filed by the CSL Behring Employees Political Action Committee is posted. Please find attached a copy of that filing that was printed right off of the www.fec.gov website.

The upper right corner of the front page of this filing states that the report was received by the FEC on November 3 at 11:42 AM, which is clearly past the deadline date of filing. However, I would like to reference the very last page of the filing listed on the www.fec.gov webpage which indicates how the filing was received. **This document clearly states the document was received via first class mail from the United States Postal Service and was postmarked October 17, 2014, a full six days before the deadline to file.**

In reviewing the www.fec.gov website, I have become aware of the following posting:

Other Means of Filing - Reports filed by any other means—including first class mail and courier—must be received by the Commission (or the Secretary of the Senate for Senate committees or for committees only supporting Senate candidates) before the close of business on the last business day before the filing deadline.

I would hope the submitted filing will illustrate there was never any intent not to file the 12 Day Pre-General Report of Receipts. The effort was made to file on time and in fact the filing was postmarked by the US Postal Service with time to spare. For that reason, I would ask that the fee be repealed.

Moving forward, the CSL Behring Employees Political Action Committee will be switching to an electronic filing of our reports for 2015 in order to avoid this situation from recurring. In consultation with our FEC staff adviser, we were encouraged to finish the 2014 year with hard copy reports, as that is how we began the year. Our Post-General report was submitted via First class mail from the US Postal Service prior to receiving your letter. Our 2014 Year-End filing will be submitted via certified mail and we will begin our 2015 filing submissions electronically.

May I conclude by stressing there was never any intent not to file and in fact our desire was to file on time, in advance of the deadline. Because of this, I would ask the civil penalty be rescinded.

Thank you for your consideration and I await your decision.

AF# 2886 – CSL Behring Employees Political Action Committee and Patrick Collins, in his official capacity as Treasurer (C00422501)

Summary of Recommendation

Make a final determination that the respondents violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assess a \$550 civil money penalty.

Reason-to-Believe Background

The 2014 Pre-General Report was due on October 23, 2014. The respondents filed the report on November 3, 2014, the day before the 2014 General Election. The report is election sensitive and was not filed prior to four days before the 2014 General Election; therefore, the report is considered not filed. 11 C.F.R. §§ 111.43(d)(1) and (e)(2).

On December 17, 2014, the Commission found reason to believe ("RTB") that the respondents violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) for failing to timely file the 2014 Pre-General Report and made a preliminary determination that the civil money penalty was \$550 based on the schedule of penalties at 11 C.F.R. § 111.43. A letter was mailed to the respondents' address of record from the Reports Analysis Division ("RAD") on December 18, 2014 to notify them of the Commission's RTB finding and civil money penalty.

Legal Requirements

The Federal Election Campaign Act ("Act") states that the treasurer of a political committee not authorized by a candidate shall file a pre-election report no later than the 12th day before any election in which the committee makes contributions or expenditures in connection with such election. 52 U.S.C. § 30104(a)(4)(A)(ii) (formerly 2 U.S.C. § 434(a)(4)(A)(ii)) and 11 C.F.R. § 104.5(c)(1)(ii). The Pre-General Report is an election sensitive report pursuant to 11 C.F.R. § 111.43(d)(1). Reports sent by first class mail must be received by the close of business on the filing date to be timely filed. 11 C.F.R. §§ 100.19(b) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

Respondents' Challenge

On January 6, 2015, the Commission received the response ("challenge") from the Committee's Treasurer requesting that the penalty be repealed because the Committee never had any intent to not file on time. The Treasurer acknowledges that the 2014 Pre-General Report was received after the due date, but notes "...the document was received via first class mail from the United States Postal Service and was postmarked October 17, 2014, a full six days before the

deadline to file." The Treasurer states that "[t]he effort was made to file on time and in fact the filing was postmarked by the U.S. Postal Service with time to spare."

The Treasurer further explains that that he is now aware that reports filed by first class mail "must be received by the Commission...before the close of business on the last business day before the filing deadline," as posted on the Commission's website. In order to avoid this situation from recurring, the Committee will begin to submit reports electronically in 2015.

Copies of the Committee's 2014 Pre-General Report, as disclosed on the Commission's website, and the RTB Letter were included with the challenge.

Analysis

The scanned copy of the mailing envelope attached to the respondents' 2014 Pre-General Report confirms that the respondents mailed the report via first class mail on October 17, 2014, yet it was not delivered to the Commission until November 3, 2014, 17 days later. The envelope shows no evidence of any reason for the delay in delivery. In addition, since no optional insurance or tracking services were purchased for the mailing, there is no further information available to explain the delay in delivery.

The respondents' challenge states the Treasurer is now aware that reports filed by first class mail "must be received by the Commission...before the close of business on *the last business day before* the filing deadline" (emphasis added). However, the only time reports mailed via first class mail must be received on the last business day before the filing deadline is when a filing deadline falls on a non-business day, i.e., a weekend or holiday. When a filing deadline falls on a business day, reports filed via first class mail must be received by the close of business *on* the filing deadline to be considered timely filed. 11 C.F.R. §§ 100.19(b) and 104.5(c).

The 2014 12 Day Pre-General Report was due on Thursday, October 23, 2014. Since the respondents elected to mail the report via first class mail, it was required to be delivered at the Commission by close of business on that date to be considered timely filed. If the respondents had elected to mail the report via registered mail, certified mail, priority or express mail having a delivery confirmation, or overnight delivery service, the report would have been considered filed on the postmark date as long as it was postmark dated no later than 11:59 p.m. Eastern Standard/Daylight Time on the fifteenth day before the date of the election, or October 20, 2014. 52 U.S.C. § 30104(a)(5) (formerly 2 U.S.C. § 434(a)(5)), 11 C.F.R. §§ 100.19(b) and 104.5(e).

While the Treasurer may not have been aware that reports filed via first class mail are only considered filed once received, the regulations are clear in how the Commission determines filing receipt dates. In addition, page 45 of the Commission's *Campaign Guide for Corporations and Labor Organizations* explains:

"Unless sent by registered or certified mail, priority or express mail having a delivery confirmation or an overnight delivery service with an online tracking system, a report is considered to be filed on time if it reaches the appropriate

federal and state filing offices by close of business on the filing date. [11 C.F.R. § 104.5(e).] Thus, reports filed by first class mail or by hand delivery must be received by the FEC by the close of business on the filing date.

A filing date is not extended even if it falls on a weekend or holiday, when filing offices are closed. In such cases, the report should reach the filing offices by the close of business on the last working day before the filing date."

The Reviewing Officer recognizes the respondents' intent to file the 2014 Pre-General Report timely. However, their challenge fails to address any of the three valid grounds at 11 C.F.R § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assess a \$550 civil money penalty.

OAR Recommendations

- 1) Adopt the Reviewing Officer recommendation for AF# 2886 involving CSL Behring Employees Political Action Committee and Patrick Collins, in his official capacity as Treasurer in making the final determination;
- 2) Make a final determination in AF# 2886 that CSL Behring Employees Political Action Committee and Patrick Collins, in his official capacity as Treasurer, violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assess a \$550 civil money penalty; and
- 3) Send the appropriate letter.

Filing FEC Reports

CHAPTER 6

Filing FEC Reports

As explained in Chapter 1, a separate segregated fund (SSF) must register within 10 days of its establishment, regardless of how much money it raises or spends.

Once the committee has registered, the SSF must begin to file reports of receipts and disbursements according to the schedules described in this chapter. The first report filed by an SSF must disclose any financial activity that took place prior to registration. 104.3(a) and (b).

1. Treasurer's Duties

General

The treasurer of an SSF has the following responsibilities regarding filing FEC reports:

- Signing and filing complete, accurate reports and statements on time. 102.2, 104.14(a) and (d).
- Making "best efforts" to obtain and report required information. See page 43 for more information. 102.9(d); 104.7.
- Keeping the required records of receipts and disbursements. 102.9 and 104.14(d).
- Continuing to file required reports until the committee has filed a termination report, as explained in Chapter 8. 102.3(a).

In the treasurer's absence, only an assistant treasurer designated on the SSF's Statement of Organization may sign reports and assume the treasurer's duties. 102.7(a). See Chapter 1 for information on appointing an assistant treasurer.

Electronic Filing

The treasurer must obtain a password from the FEC and use it when filing any electronic report or statement. See also 104.18(g) and page 50 "Verification Requirements" for alternatives.

2. Filing Deadlines

Report on Time

Committee treasurers must file reports on time. The Commission cannot grant extensions to reporting deadlines. Filing reports late or not at all may result in enforcement action, including administrative fines. See below.

Filing Date

Unless sent by registered or certified mail, priority or express mail having a delivery confirmation or an overnight delivery service with an online tracking system, a report is considered to be filed on time if it reaches the appropriate federal and state filing offices by close of business on the filing date. 104.5(e). Thus, reports filed by first class mail or by hand delivery must be received by the FEC by the close of business on the filing date.

A filing date is not extended even if it falls on a weekend or holiday, when filing offices are closed. In such cases, the report should reach the filing offices by the close of business on the last working day before the filing date.

Registered, Certified, Priority or Express Mailing Date

If a report is sent by registered or certified mail, or by priority or express mail having a delivery confirmation, it is considered filed on time if postmarked by the filing date. Exception: In the case of a pre-election report, the report must be postmarked at least three days before the filing date. 100.19(b) and 104.5(e).


Overnight Delivery

Reports sent by overnight delivery service are considered timely if they are:

- Received by the delivery service on or before the filing date;
- Scheduled for delivery on the next business day; and



I am in receipt of the letter from the Reviewing Officer at the Office of Administrative Review along with the recommendations to uphold the original findings of the CSL Behring Employees Political Action Committee's 12 Day Pre-General Report of Receipts being considered "not filed" by the October 23, 2014 deadline. Additionally, the Reviewing Officer recommends upholding the civil penalty of \$550.

Might I ask the Federal Election Commission to reconsider the recommendations of the Reviewing Officer or alternatively wave the civil penalty?

I understand the recommendations of the reviewing officer (see attached) and acknowledge that the 12 Day Pre-General Report of Receipts was not received by the Federal Election Commission (FEC) by the October 23, 2014 deadline. The FEC timestamp indicates the filing was received on November 3, 2014 according to the posted filing on www.fec.gov.

I now recognize that reports filed by first class mail must be received by the Commission before the close of business on the last business day before the filing deadline. Further, I realize that my ignorance of this requirement is not a defense. However, I would like to reference the very last page of our filing which indicates how the filing was received. This document clearly states the document was received via first class mail from the United States Postal Service and was postmarked October 17, 2014, a full six days before the deadline to file.

I would hope the submitted filing will illustrate there was never any intent not to file the 12 Day Pre-General Report of Receipts, nor was it a last minute submission. On December 17, 2014, the Commission found reason to believe (“RTB”) that the respondents violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) for failing to timely file the 2014 Pre-General Report and made a preliminary determination that the civil money penalty was \$550 based on the schedule of penalties at 11 C.F.R. § 111.43.

On January 6, 2015, the Commission received their written response (“challenge”). After reviewing the challenge, the Reviewing Officer Recommendation (“ROR”) dated January 28, 2015 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference. The Reviewing Officer recognized the respondents’ intent to file the 2014 Pre-General Report timely but determined that the respondents’ challenge failed to address any of the three valid grounds at 11 C.F.R. § 111.35(b). Therefore, the Reviewing Officer recommended that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assess a \$550 civil money penalty.

Within 10 days of transmittal of the recommendation, they may file a written response with the Commission Secretary which may not raise any arguments not raised in their challenge or not directly responsive to the ROR. 11 C.F.R. § 111.36(f). On January 30, 2015, the Commission received a written response from the Treasurer.

In the response, the Treasurer asks the Commission to reconsider the Reviewing Officer's recommendation. He reiterates the points made in the original challenge and acknowledges his ignorance of the first class mail requirement is not a defense. He further states:

"...[T]here was never any intent not to file and in fact our desire was to file on time, in advance of the deadline. Filing via first class mail was simply a measure to save the expense of certified mail and the filing as provided to the post office with days to spare. Additionally, we have provided all of our previous submissions to date via first class mail without ever having this delay in our filings being received by the Commission. Because there was never any intent not to file, nor was there an oversight not to file, I would ask the civil penalty be waived."

As stated in the ROR, the Reviewing Officer recognizes the respondents' intent to file the 2014 Pre-General Report timely. However, their original challenge and response to the ROR both fail to address any of the three valid grounds at 11 C.F.R § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assess a \$550 civil money penalty.

OAR Recommendations

- 1) Adopt the Reviewing Officer recommendation for AF# 2886 involving CSL Behring Employees Political Action Committee and Patrick Collins, in his official capacity as Treasurer in making the final determination;
- 2) Make a final determination in AF# 2886 that CSL Behring Employees Political Action Committee and Patrick Collins, in his official capacity as Treasurer, violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assess a \$550 civil money penalty; and
- 3) Send the appropriate letter.





On December 17, 2014, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that CSL Behring Employees Political Action Committee and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) for failing to file the 2014 Pre-General Report. By letter dated December 18, 2014, the Commission sent notification of the RTB finding that included a civil money penalty calculated at RTB of \$550 in accordance with the schedule of penalties at 11 C.F.R. § 111.43. On January 6, 2015, the Office of Administrative Review received your written response challenging the RTB finding.

The Reviewing Officer reviewed the Commission's RTB finding with its supporting documentation and your written response. Based on this review, the Reviewing Officer recommended that the Commission make a final determination that CSL Behring Employees Political Action Committee and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assess a civil money penalty in the amount of \$550 in accordance with 11 C.F.R. § 111.43. A copy of the Reviewing Officer Recommendation was sent to you on January 29, 2015.

On January 30, 2015, the Commission received your response to the ROR. On March 16, 2015, the Commission adopted the Reviewing Officer's recommendation and made a final determination that CSL Behring Employees Political Action Committee and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) (formerly 2 U.S.C. § 434(a)) and assessed a civil money penalty in the amount of \$550. A copy of the Final Determination Recommendation is attached.

At this juncture, the following courses of action are available to you:

The Reviewing Officer's Recommendation is available at the Commission's website.

1. If You Choose to Appeal the Final Determination and/or Civil Money Penalty

If you choose to appeal the final determination, you should submit a written petition, within 30 days of receipt of this letter, to the U.S. District Court for the district in which the committee or you reside, or transact business, requesting that the final determination be modified or set aside. See 52 U.S.C. § 30109(a)(4)(C)(iii) (formerly 2 U.S.C. § 437g(a)(4)(C)(iii)). Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of the respondents' right to present such argument in a petition to the district court under 52 U.S.C. § 30109 (formerly 2 U.S.C. § 437g). 11 CFR § 111.38.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Appeal

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701 *et seq.* If you do not pay this debt within 30 days (or file a written petition to a federal district court - see below), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Within 5 days of the transfer to Treasury, Treasury will contact you to request payment. Treasury currently charges a fee of 28% of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency ("PCA"). If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

Actions which may be taken to enforce recovery of a delinquent debt by Treasury may also include: (1) offset of any payments, which the debtor is due, including tax refunds and salary; (2) referral of the debt to agency counsel for litigation; (3) reporting of the debt to a credit bureau; (4) administrative wage garnishment; and (5) reporting of the debt, if discharged, to the IRS as potential taxable income. In addition, under the provisions of DCIA and other statutes applicable to the FEC, the debtor may be subject to the assessment of other statutory interest, penalties, and administrative costs.

In accordance with the DCIA, at your request, the agency will offer you the opportunity to inspect and copy records relating to the debt, the opportunity for a review of the debt, and the opportunity to enter into a written repayment agreement.

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the civil money penalty, send the enclosed remittance form, along with your payment, to the address on page 4 within 30 days of receipt of this letter.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS

4. Partial Payments

If you make a payment in an amount less than the civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assessed upon making a final determination.

5. Settlement Offers

Any offer to settle or compromise a debt owed to the Commission, including a payment in an amount less than the civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assessed upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

The confidentiality provisions at 52 U.S.C. § 30109(a)(12) (formerly 2 U.S.C. § 437g(a)(12)) no longer apply and this matter is now public. Pursuant to 11 C.F.R. §§ 111.42(b) and 111.20(c), the file will be placed on the public record within 30 days from the date of this notification.
