SUBJECT: Reason To Believe Recommendation - 2020 30 Day Post-General Report

(Unauthorized Filers) for the Administrative Fine Program

Attached is a list of political committees and their treasurers who failed to file or timely file the 2020 30 Day Post-General Report in accordance with 52 U.S.C. § 30104(a). The list is comprised of unauthorized committees that failed to file or timely file the 2020 30 Day Post-General Report.

The committees appearing on the 30 Day Post-General Report list either failed to file the report, filed the report after the due date but within thirty (30) days of the due date (considered a late filed report), or filed the report more than thirty (30) days after the due date (considered a non-filed report). In accordance with 11 C.F.R. § 111.43, these committees should be assessed the civil money penalties indicated in the attachment.

In order to determine the level of activity for unauthorized quarterly filers that failed to file or failed to timely file the 30 Day Post-General Report, the Reports Analysis Division (RAD) used the following procedures and criteria:

- Every 30 Day Post-General Report (30 Day Report) submitted by an unauthorized quarterly filer that covered the period from October 1, 2020 through November 23, 2020 (54 days), was reviewed for activity which would have required the filing of a 12 Day Pre-General Report (12 Day Report). If our research indicated that the filing of a 12 Day Report was required, we utilized a two-step method to arrive at the estimated level of activity on which to base the fine amount. First, we took the sum of all itemized receipts and disbursements that should have been disclosed on a 12G. Second, if the committee had any unitemized activity, a per diem level of activity was used by multiplying the total amount of activity on the report by 25.93% (14 days (12G Filing Period)/54 days (30G Filing Period)).
- The committees identified through this process as failing to file or failing to timely file the 12 Day Report were included in the Reason to Believe Recommendation circulated to the Commission on March 4, 2021. If the same committee also failed to file the 30 Day Report in a timely manner, we based the 30 Day Report fine on the amount of the remaining level of activity. We arrived at this amount by subtracting the estimated level of activity for the 12 Day Report from the total amount of activity on the 30 Day Report. In these cases, the committees will also be assessed a fine for the 30 Day Report based on the estimated levels of activity described above and are included on the attached list.
- Every Year-End Report (YE) submitted by an unauthorized quarterly filer that covered the period from October 1, 2020 through December 31, 2020 (92 days) was reviewed for activity which would have required the filing of a 30G. If our research indicated that a 30G was required, we utilized a three-step method to arrive at the activity on which to base the 30G fine amount. First, we took the sum of all itemized receipts and disbursements that should have been disclosed on a 30G. Second, if the committee had any unitemized activity, a per diem level of this activity was calculated by multiplying the total amount of unitemized activity on the report by 58.70% (54 days (30G Filing Period)/92 days (YE Filing Period)). Third, we took the sum of the amounts calculated in steps one and two to arrive at the level of activity assigned to the 30G. If the same committee was required to file the 12 Day Report, but failed to file this report, we utilized a three-step method to arrive at the activity on which to base the 30G fine amount. First, we took the sum of all itemized receipts and disbursements that should have been disclosed on a 30G. Second, if the committee had any unitemized activity, a per diem level of this activity was calculated by multiplying the total amount of unitemized activity on the report by 43.48% (40 days (30G Filing Period)/92 days (YE Filing Period)). Third, we took the sum of the amounts calculated in steps one and two to arrive at the level of activity assigned to the 30G.

Recommendation

- 1. Find reason to believe that the political committees and their treasurers, in their official capacity, listed on the RTB Circulation Report violated 52 U.S.C. § 30104(a) and make a preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.
- 2. Send the appropriate letters.

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires that your committee file a 30 Day Post-General Report of Receipts and Disbursements in a calendar year in which a regularly scheduled general election is held. This report, covering the period October 15, 2020 through November 23, 2020 shall be filed no later than December 3, 2020. 52 U.S.C. § 30104(a). Because records at the Federal Election Commission ("FEC") indicate that you did not file this report within thirty (30) days of the due date, the report is considered not filed for the purpose of calculating the civil money penalty. You should file the report if you have not already done so.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 52 U.S.C. § 30104(a). 52 U.S.C. § 30109(a)(4). On March 19, 2021, the FEC found that there is reason to believe ("RTB") that Tarrant County Republican Victory Fund and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) by failing to file timely this report on or before December 3, 2020. At this juncture, the following courses of action are available to you:

1. If You Choose to Challenge the RTB Finding and/or Civil Money Penalty

If you should decide to challenge the RTB finding and/or calculated civil money penalty, you must submit a written response to the FEC's Office of Administrative Review. Your response must include the AF# (found at the top of page 1 under your committee's identification number) and be received within forty (40) days of the Commission's RTB finding, or April 28, 2021. 11 CFR § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 CFR § 111.36(c).

Please note, on June 18, 2020, the Federal Election Commission began the initial phase (Phase I) of its return to normal operations. At this stage, the agency's offices will remain closed to visitors and most of its employees will continue to telework in an effort to limit the spread of coronavirus (COVID-19). The Commission is processing some documents submitted by mail, though processing will not occur daily until the agency resumes normal mail operations. Nevertheless, a challenge to an RTB finding and/or calculated civil money penalty must be received on time. Thus, all written responses and supporting documentation should be converted to PDF (Portable Document Format) and must be emailed to administrative fines@fec.gov. The Commission encourages the use of electronic signatures on electronically submitted documents, but scanned copies of ink signatures will be accepted. Electronically submitted challenges will be deemed received on the date it is electronically received by staff.

The FEC will only consider challenges that are based on at least one of three grounds: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 CFR § 111.35(b). For a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. Id. Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) a failure of Commission computers or Commission-provided software despite your seeking technical assistance from Commission personnel and resources; (2) a widespread disruption of information transmissions over the Internet that is not caused by a failure of the Commission's or your computer systems or Internet service provider; and (3) severe weather or other disaster-related incident. 11 CFR § 111.35(c). Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) negligence; (2) delays caused by vendors or

contractors; (3) treasurer and staff illness, inexperience or unavailability; (4) committee computer, software, or Internet service provider failures; (5) failure to know filing dates; and (6) failure to use filing software properly. 11 CFR § 111.35(d).

The "failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver" of your right to present such argument in a petition to the U.S. District Court under 52 U.S.C. § 30109. 11 CFR § 111.38.

If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge

If you do not pay the calculated civil money penalty and do not submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that Tarrant County Republican Victory Fund and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701 et seq. The FEC may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 CFR § 111.51(a)(2).

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the calculated civil money penalty, follow the payment instructions on page 4 of this letter. Upon receipt of your payment, the FEC will send you a final determination letter.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS

4. Partial Payments

If you make a payment in an amount less than the calculated civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assesses upon making a final determination.

5. Settlement Offers

Any offer to settle or compromise a debt owed to the Commission, including a payment in an amount less than the calculated civil money penalty assessed or any

restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assesses upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

This matter was generated based on information ascertained by the FEC in the normal course of carrying out its supervisory responsibilities. 52 U.S.C. § 30109(a)(2). Unless you notify the FEC in writing that you wish the matter to be made public, it will remain confidential in accordance with 52 U.S.C. § 30109(a)(4)(B) and 30109(a)(12)(A) until it is placed on the public record at the conclusion of this matter in accordance with 11 CFR § 111.42.

We are a small county party organization with volunteers. I am the volunteer treasurer who can only work on a desktop in the party offices. There is no laptop. I come into the office once or twice a month to do the filings. During Covid, when the offices were legally forced closed, I was unable to file reports monthly. This lead to some fines earlier in the year that compounded this fine.

I've had nobody to train me on the rules and I've done my best to read and follow them. Since becoming the new treasurer, I've submitted a Form 99 to explain our "best practices" and filed a Cash on Hand amendment to make the numbers more accurate. Every month, when I file, I list all charges and donations regardless of size to make sure our filings are as accurate as possible. If a correction or amendment is ever need, I immediately contact the FEC and work with my representative to make any needed changes.

Again, we are a small county party and I only a volunteer. A fine of this magnitude would be devastating, especially when part of its calculation is due to the effects of Covid-19 and legally not being able to file in the office (it would've been against the law). I would also like to notify the administrative body that since this fine, we have filed monthly reports on time every month of 2021.

REVIEWING OFFICER RECOMMENDATION OFFICE OF ADMINISTRATIVE REVIEW ("OAR")

AF# 4094 – Tarrant County Republican Victory Fund and Shannon Dubberly, in his official capacity as Treasurer (C00406645)

Summary of Recommendation

Make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$8,082 civil money penalty.

Reason-to-Believe Background

The 2020 Post-General Report was due on December 3, 2020. The respondents filed activity for the coverage period on January 20, 2021, 48 days late.¹ The report is not election sensitive and was not filed within 30 days of the due date; therefore, the report is considered not filed. 11 C.F.R. §§ 111.43(d)(1) and (e)(1).

On March 19, 2021, the Commission found reason to believe ("RTB") that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2020 Post-General Report and made a preliminary determination that the civil money penalty was \$8,082 based on the schedule of penalties at 11 C.F.R. § 111.43. A letter was mailed to the respondents' email address of record from the Reports Analysis Division ("RAD") on April 9, 2021 to notify them of the Commission's RTB finding and civil money penalty.

Legal Requirements

The Federal Election Campaign Act ("Act") states that the treasurer of a committee not authorized by a candidate shall file a post-general report covering through the 20th day after the election no later than 30 days after the election. 52 U.S.C. § 30104(a) and 11 C.F.R. § 104.5(c)(1)(iii). Reports electronically filed must be received and validated at or before 11:59 pm Eastern Standard/Daylight Time on the filing deadline to be timely filed.

 $^{^1}$ The 2020 Post-General Report coverage period was 10/15/20-11/23/20. On 1/20/21, the Committee filed the 2020 November Monthly Report to include a portion of the required activity (10/15/20-10/31/20). On 1/21/21, the Committee filed the 2020 December Monthly Report to include the remaining portion of the required activity (11/1/20-11/23/20). On 2/23/21, the Committee clarified the public record by filing the 2020 Post-General Report (10/15/20-11/23/20). The report disclosed \$27,181.20 in total receipts and \$44,070.54 in total disbursements. Therefore, the level of activity of the 2020 Post-General Report is \$71,251.74.

11 C.F.R. §§ 100.19(c) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

Summary of Respondents' Challenge

On May 24, 2021, the Commission received the written response ("challenge") from the Treasurer, explaining in part:

We are a small county party organization with volunteers. I am the volunteer treasurer who can only work on a desktop in the party offices. There is no laptop. I come into the office once or twice a month to do the filings. During Covid, when the offices were legally forced closed, I was unable to file reports monthly. This lead [sic] to some fines earlier in the year that compounded this fine.

The Treasurer also explains he does his best to follow reporting requirements and has timely filed all 2021 monthly reports. In addition, he notes that the large penalty would be devastating to the small county party.

Analysis

The Treasurer does not provide a defense for the Committee's failure to timely file the 2020 Post-General Report but requests consideration in the calculation of the civil money penalty.² He contends the penalty in this matter was compounded by previous administrative fine matters, which were the result of impacts from COVID-19.

The Treasurer is referring to the civil money penalties assessed in AF# 3779, AF# 3783, AF# 3799, and AF# 3844 for the Committee's failure to timely file the 2019 Year-End Report and 2020 February, March, and May Monthly Reports, respectively. The Treasurer previously challenged the RTB findings in AF# 3783, AF# 3799, and AF# 3844.³ He acknowledged these reports were not timely filed due to a misunderstanding of the monthly reporting requirements and not due to impacts of COVID-19. Failure to know reporting dates and inexperience of the treasurer are specifically included at 11 C.F.R. § 111.35(d) as examples of a circumstance that will not be considered reasonably unforeseen and beyond the respondents' control. Therefore, the Reviewing Officer recommended that the Commission make a final determination in AF# 3783, AF# 3799, and AF# 3844 that the respondents violated 52 U.S.C. § 30104(a) and assess civil money penalties of \$684, \$236, and \$684, respectively. On February 17, 2021, the Commission adopted the Reviewing Officer's recommendations.⁴

² While the respondents did not indicate they misunderstood or were unaware of the 2020 Post-General Report filing requirement, the Reviewing Officer confirms that the Commission appropriately notified and reminded the Committee of its requirement to file the report prior to and after the December 3, 2020 reporting deadline. *See* Attachments 2, 3, and 4.

³ The Committee did not challenge the RTB finding in AF# 3779.

⁴ See Reviewing Officer Recommendation, Final Determination Recommendation, and Certification in AF# 3783, AF# 3799, and AF# 3844 – Tarrant County Republican Victory Fund and Shannon Dubberly, in his official capacity as Treasurer (C00406645)

The Reviewing Officer confirms that previous violations are included in the calculation of a civil money penalty, and the calculation of the civil money penalty at RTB is correct. A previous violation is defined as a prior civil money penalty assessed during the current and prior two-year election cycle. 11 C.F.R. § 111.43(d)(4). At the time of the RTB finding in this matter, the Committee had four (4) previous violations (AF# 3779, AF# 3783, AF# 3799, and AF# 3844). The civil money penalty calculation for a report which is not election-sensitive is contained at 11 C.F.R. § 111.43(a). It states that the penalty for a non-filed report with between \$50,000 and \$74,999.99 in activity will be \$4,041 x [$1 + (.25 \times \text{Number of previous violations})$]. Considering the Committee's four (4) previous violations, the civil money penalty is \$8,082.

The challenge fails to adequately address any of the three valid grounds at 11 C.F.R § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. 11 C.F.R. § 111.35(b). Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a civil money penalty of \$8,082.

OAR Recommendations

- 1. Adopt the Reviewing Officer recommendation for AF# 4094 involving Tarrant County Republican Victory Fund and Shannon Dubberly, in his official capacity as Treasurer, in making the final determination;
- 2. Make a final determination in AF# 4094 that Tarrant County Republican Victory Fund and Shannon Dubberly, in his official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$8,082 civil money penalty; and
- 3. Send the appropriate letter.

On March 19, 2021, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Tarrant County Republican Victory Fund and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) for failing to file the 2020 Post-General Report. The Commission also made a preliminary determination that the civil money penalty was \$8,082 based on the schedule of penalties at 11 C.F.R. § 111.43.

After reviewing your written response and any supplemental information submitted by you and Commission staff, the Reviewing Officer has recommended that the Commission make a final determination and assess a civil money penalty. A copy of the Reviewing Officer's recommendation is attached.

You may file with the Commission Secretary a written response to the recommendation within 10 days of the date of this letter. Please note, the agency's offices remain closed to visitors and most of its employees will continue to telework in an effort to limit the spread of coronavirus (COVID-19). The Commission is processing some documents submitted by mail, though processing will not occur on a daily basis until the agency resumes normal mail operations. Below, I will try to clarify why they were made and hope to help you understand what happened and how in some cases there were extenuating circumstances. I also hope to show how the fine will be debilitating, as well as counterproductive. In no particular order:

- **COVID Restrictions** The offices were closed by the government for months during the pandemic and it was against the law for me to go into the office. There was literally no way for me to file as our organization only has an old desktop (no laptop) that is located in our office.
- Knowledge Though not an excuse, I originally misunderstood the FEC's guidance and thought
 monthly filings should be submitted quarterly. That's why you see the first two sets of filings
 were in groups of three in a quarterly pattern. In regard to the post-general filings, I
 misunderstood the guidance and thought since we were an organization, not a campaign with a
 candidate, we only had to continue filing monthly. Once the FEC notified me this was incorrect, I
 worked with them to refile.
- Already Paid Thousands We are a small county party and have already paid thousands for the previous mistakes that were caused either by COVID or misunderstandings. Having to pay this additional fine would be crushing. We have learned from our mistakes and to pay a fine that includes mistakes we've already paid for is doubly punitive.
- **Laptop** We are saving money to buy a laptop for the treasurer to prevent the circumstances from occurring again. If the fine holds, then we will not be able to afford the laptop and will continue to be at risk to future pandemic (or other natural disaster) closures.
- No Mistakes Since Since the post-general/end-of-year filing issues, we have submitted all
 monthly filings on time and in full compliance. We have learned from our mistakes and
 established internal processes and mechanisms to prevent future treasurers from repeating
 them.

In summation, we ask for the Committee's understanding and confidence. These circumstances and mistakes will not happen again. We have taken action to improve our internal knowledge management and communication capabilities. Furthermore, if not fined again, we plan to spend the saved money on tools (laptop) to improve our capability as filers. We understand you deal with issues like this regularly, but for us this is a massive fine that will cripple our organization. We ask that you make the determination not to assess the fine so that we can spend the funds on tools to meet our FEC obligations and voter outreach goals.

On March 19, 2021, the Commission found reason to believe ("RTB") that Tarrant County Republican Victory Fund and Shannon Dubberly, in their official capacity as Treasurer violated 52 U.S.C. § 30104(a) for failing to timely file the 2020 Post-General Report and made a preliminary determination that the civil money penalty was \$8,082 based on the schedule of penalties at 11 C.F.R. § 111.43. On May 24, 2021, the Commission received their written response ("challenge"). After reviewing the challenge, the Reviewing Officer Recommendation ("ROR") dated July 22, 2021 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference. The Reviewing Officer determined that the challenge failed to adequately address any of the three valid grounds at 11 C.F.R § 111.35(b). The Reviewing Officer also confirmed that previous violations are included in the calculation of a civil money penalty, and the calculation of the civil money penalty at RTB is correct. Therefore, the Reviewing Officer recommended that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$8,082 civil money penalty.

Within 10 days of transmittal of the recommendation, the respondents may file a written response with the Commission Secretary which may not raise any arguments not raised in their challenge or not directly responsive to the ROR. 11 C.F.R. § 111.36(f). On October 12, 2021, the Treasurer submitted a response to the ROR. See Attachment 1. The response reiterates the

points made in the original challenge and addressed in the ROR.¹ The response also further emphasizes how the additional penalty would financially impact the Committee. The respondents state, in part:

In summation, we ask for the [Commission's] understanding and confidence. These circumstances and mistakes will not happen again. We have taken action to improve our internal knowledge management and communication capabilities. Furthermore, if not fined again, we plan to spend the saved money on tools (laptop) to improve our capability as filers. We understand you deal with issues like this regularly, but for us this is a massive fine that will cripple our organization. We ask that you make the determination not to assess the fine so that we can spend the funds on tools to meet our FEC obligations and voter outreach goals. (emphasis included)

The Reviewing Officer's analysis and recommendations are unchanged. The challenge and response to the ROR fail to adequately address any of the three valid grounds at 11 C.F.R § 111.35(b). In addition, the calculation of the civil money penalty at RTB is correct. Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$8,082 civil money penalty.

OAR Recommendations

- 1. Adopt the Reviewing Officer recommendation for AF# 4094 involving Tarrant County Republican Victory Fund and Shannon Dubberly, in their official capacity as Treasurer, in making the final determination;
- 2. Make a final determination in AF# 4094 that Tarrant County Republican Victory Fund and Shannon Dubberly, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$8,082 civil money penalty; and
- 3. Send the appropriate letter.

¹ The Treasurer's response to the ROR refers to impacts of COVID-19. The Reviewing Officer notes that this reference was made with respect to prior administrative fines and the calculation of previous violations in this matter, as explained in the original challenge and analyzed in the ROR.

Dear Mr. Dubberly:

On March 19, 2021, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Tarrant County Republican Victory Fund and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) for failing to file the 2020 Post-General Report . By letter dated April 9, 2021, the Commission sent notification of the RTB finding that included a civil money penalty calculated at RTB of \$8,082 in accordance with the schedule of penalties at 11 C.F.R. § 111.43. On May 24, 2021, the Office of Administrative Review received your written response challenging the RTB finding.

The Reviewing Officer reviewed the Commission's RTB finding with its supporting documentation and your written response. Based on this review, the Reviewing Officer recommended that the Commission make a final determination that Tarrant County Republican Victory Fund and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and assess a civil money penalty in the amount of \$8,082 in accordance with 11 C.F.R. § 111.43. The Reviewing Officer Recommendation was sent to you on July 23, 2021. On October 12, 2021, the Commission received your written response.

On November 3, 2021, the Commission adopted the Reviewing Officer's recommendation and made a final determination that Tarrant County Republican Victory Fund and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assessed a civil money penalty in the amount of \$8,082. A copy of the Final Determination Recommendation is attached.

At this juncture, the following courses of action are available to you:

1. If You Choose to Appeal the Final Determination and/or Civil Money Penalty

If you choose to appeal the final determination, you should submit a written petition, within 30 days of receipt of this letter, to the U.S. District Court for the district in which the committee or you reside, or transact business, requesting that the final determination be modified or set aside.

See 52 U.S.C. § 30109(a)(4)(C)(iii). Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of the respondents' right to present such argument in a petition to the district court under 52 U.S.C. § 30109. 11 CFR § 111.38.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Appeal

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701 et seq. If you do not pay this debt within 30 days (or file a written petition to a federal district court - see below), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Within 5 days of the transfer to Treasury, Treasury will contact you to request payment. Treasury currently charges a fee of 30% of the civil money penalty amount for its collection services. If the age of the debt is greater than or equal to two years old, Treasury will charge a fee of 32% of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency ("PCA"). If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

Actions which may be taken to enforce recovery of a delinquent debt by Treasury may also include: (1) offset of any payments, which the debtor is due, including tax refunds and salary; (2) referral of the debt to agency counsel for litigation; (3) reporting of the debt to a credit bureau; (4) administrative wage garnishment; and (5) reporting of the debt, if discharged, to the IRS as potential taxable income. In addition, under the provisions of DCIA and other statutes applicable to the FEC, the debtor may be subject to the assessment of other statutory interest, penalties, and administrative costs.

In accordance with the DCIA, at your request, the agency will offer you the opportunity to inspect and copy records relating to the debt, the opportunity for a review of the debt, and the opportunity to enter into a written repayment agreement.

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the civil money penalty, follow the payment instructions on page 4 of this letter. You should make payment within thirty (30) days of receipt of this letter.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS

4. Partial Payments

If you make a payment in an amount less than the civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assessed upon making a final determination.

5. Settlement Offers

Any offer to settle or compromise a debt owed to the Commission, including a payment in an amount less than the civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assessed upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

The confidentiality provisions at 52 U.S.C. § 30109(a)(12) no longer apply and this matter is now public. Pursuant to 11 C.F.R. §§ 111.42(b) and 111.20(c), the file will be placed on the public record within 30 days from the date of this notification.
