SUBJECT: Reason To Believe Recommendation – 2021 October Quarterly Report (Non-Election Sensitive) for the Administrative Fine Program

Attached is a list of political committees and their treasurers who failed to file the 2021 October Quarterly Report (Non-Election Sensitive) in accordance with 52 U.S.C. § 30104(a). The October Quarterly Report was due on October 15, 2021.

The committees listed on the attached RTB Circulation Report either failed to file the report, filed the report no more than thirty (30) days after the due date (considered a late filed report), or filed the report more than thirty (30) days after the due date (considered a non-filed report). In accordance with the schedule of civil money penalties for reports at 11 C.F.R. 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

Recommendation

1. Find reason to believe that the political committees and their treasurers, in their official capacity, listed on the RTB Circulation Report violated 52 U.S.C. § 30104(a) and make a

preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.

2. Send the appropriate letters.

Dear Ms. Rodriguez,

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires that your committee file an October Quarterly Report of Receipts and Disbursements every calendar year. This report, covering the period July 1, 2021 through September 30, 2021, shall be filed no later than October 15, 2021. 52 U.S.C. § 30104(a). Because records at the Federal Election Commission ("FEC") indicate that this report was not filed within thirty (30) days of the due date, the report is considered not filed for the purpose of calculating the civil money penalty. You should file this report if you have not already done so.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 52 U.S.C. § 30104(a). 52 U.S.C. § 30109(a)(4). On November 24, 2021, the FEC found that there is reason to believe ("RTB") that William Sanchez for US Senate and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) by failing to file timely this report on or before October 15, 2021. Based on the FEC's schedules of civil money penalties at 11 CFR § 111.43, the amount of your civil money penalty calculated at the RTB stage is \$4,041. Please see the attached copy of the Commission's administrative fine regulations at 11 CFR §§ 111.30-111.55. Attachment 1. The Commission's website contains further information about how the administrative fine program works and how the fines are calculated. See <https://www.fec.gov/af/pay.shtml> 11 CFR § 111.34. Your payment of \$4,041 is due within forty (40) days of the finding, or by January 3, 2022, and is based on these factors:

1. If You Choose to Challenge the RTB Finding and/or Civil Money Penalty

If you should decide to challenge the RTB finding and/or calculated civil money penalty, you must submit a written response to the FEC's Office of Administrative Review. Your response must include the AF# (found at the top of page 1 under your committee's identification number) and be received within forty (40) days of the Commission's RTB finding, or January 3, 2022. 11 CFR § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 CFR § 111.36(c).

Please note, the Federal Election Commission's office remains closed to visitors and most of its employees are continuing to telework in an effort to limit the spread of coronavirus (COVID-19). The Commission is processing some documents submitted by mail, though processing will not occur daily until the agency resumes normal mail operations. Nevertheless, a challenge to an RTB finding and/or calculated civil money penalty must be received on time. Thus, all written responses and supporting documentation should be converted to PDF (Portable Document Format) and must be emailed to administrativefines@fec.gov. The Commission encourages the use of electronic signatures on electronically submitted documents, but scanned copies of ink signatures will be accepted. Electronically submitted challenges will be deemed received on the date it is electronically received by staff.

The FEC will only consider challenges that are based on at least one of three grounds: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 CFR § 111.35(b). For a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. *Id.* Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) a failure of Commission computers or Commission-provided software despite your seeking technical assistance from Commission personnel and resources; (2) a widespread disruption of information transmissions over the Internet that is not caused by a failure of the Commission's or your computer systems or Internet service provider; and (3) severe weather or other disaster-related incident. 11 CFR § 111.35(c). Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) negligence; (2) delays caused by vendors or contractors; (3) treasurer and staff illness, inexperience or unavailability; (4) committee computer, software, or Internet service provider failures; (5) failure to know filing dates; and (6) failure to use filing software properly. 11 CFR § 111.35(d).

The "failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver" of your right to present such argument in a petition to the U.S. District Court under 52 U.S.C. § 30109. 11 CFR § 111.38.

If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge

If you do not pay the calculated civil money penalty and do not submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that William Sanchez for US Senate and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701 et seq. The FEC may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 CFR § 111.51(a)(2).

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the calculated civil money penalty, follow the payment instructions on page 4 of this letter. Upon receipt of your payment, the FEC will send you a final determination letter.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS

4. Partial Payments

If you make a payment in an amount less than the calculated civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assesses upon making a final determination.

5. Settlement Offers

Any offer to settle or compromise a debt owed to the Commission, including making a payment in an amount less than the calculated civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute



acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assesses upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

This matter was generated based on information ascertained by the FEC in the normal course of carrying out its supervisory responsibilities. 52 U.S.C. § 30109(a)(2). Unless you notify the FEC in writing that you wish the matter to be made public, it will remain confidential in accordance with 52 U.S.C. § 30109(a)(4)(B) and 30109(a)(12)(A) until it is placed on the public record at the conclusion of this matter in accordance with 11 CFR § 111.42.





**REVIEWING OFFICER RECOMMENDATION
OFFICE OF ADMINISTRATIVE REVIEW (“OAR”)**

AF# 4261 – William Sanchez for US Senate and Marcia Rodriguez, in their official capacity as Treasurer (C00765750)

Summary of Recommendation

Make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$4,041 civil money penalty.

Reason-to-Believe Background

The 2021 October Quarterly Report was due on October 15, 2021. The respondents have not yet electronically filed the report. The report is not election sensitive and was not filed within 30 days of the due date; therefore, the report is considered not filed. 11 C.F.R. §§ 111.43(d)(1) and (e)(1).

On November 24, 2021, the Commission found reason to believe (“RTB”) that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2021 October Quarterly Report and made a preliminary determination that the civil money penalty was \$4,041 based on the schedule of penalties at 11 C.F.R. § 111.43. A letter was sent to the respondents’ email address of record from the Reports Analysis Division (“RAD”) on November 29, 2021 to notify them of the Commission’s RTB finding and civil money penalty.

Legal Requirements

The Federal Election Campaign Act (“Act”) states that the treasurer of a principal campaign committee shall file a report for the quarter ending September 30 no later than October 15. 52 U.S.C. § 30104(a) and 11 C.F.R. § 104.5(a)(1)(i). Political committees required to file reports with the Commission must file in an electronic format if they have received contributions or made expenditures or expect to receive contributions or make expenditures in a calendar year aggregating in excess of \$50,000. 52 U.S.C. § 30104(a)(11) and 11 C.F.R. § 104.18(a). Reports electronically filed must be received and validated at or before 11:59 p.m. Eastern Standard/Daylight Time on the filing date to be timely filed. 11 C.F.R. §§ 100.19(c) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

Summary of Respondents' Challenge

On December 3, 2021, the Commission received the written response (“challenge”) from the Candidate. He explains that on October 15, 2021, he mailed the 2021 October Quarterly Report to the FEC via USPS. The Candidate includes relevant USPS tracking information and a copy of the 2021 October Quarterly Report.

Analysis

The Reviewing Officer recognizes the Committee timely submitted a paper version of the 2021 October Quarterly Report.¹ However, the report is considered not filed because the Committee is required to file reports electronically. Political committees required to file reports with the Commission must file in an electronic format if they have received contributions or made expenditures totaling over \$50,000 in a calendar year. 52 U.S.C. § 30104(a)(11) and 11 C.F.R. § 104.18(a). The Committee exceeded the mandatory electronic filing threshold with its 2021 July Quarterly Report. Therefore, all subsequent reports for that calendar year and the two following calendar years are required to be filed in an electronic format. 11 C.F.R. § 104.18(a).²

The Reviewing Officer notes that prior to the Committee’s paper submission of the 2021 October Quarterly Report, the Committee electronically filed its 2021 April and July Quarterly Reports. As stated in the challenge, the Candidate then submitted a paper version of the 2021 October Quarterly Report. The Commission considered the document received on October 15, 2021. 11 C.F.R. § 104.5(e).

On October 16, 2021, the day following the 2021 October Quarterly Report filing deadline, the Commission’s Electronic Filing Office (“EFO”) sent a late notification email to william@wsanchezlaw.com, team@sanchezforsenate.com, campaign@sanchezforsenate.com, and claire@sanchezforsenate.com because the report had not yet been electronically filed. RAD subsequently generated a notification to alert the respondents that the paper version of the 2021 October Quarterly Report was not considered filed, and it must be filed in an electronic format. Commission records indicate the notification was sent via email to campaign@sanchezforsenate.com and claire@sanchezforsenate.com on October 31, 2021. On November 3, 2021, RAD sent the non-filer notification to the same email addresses.

On December 2, 2021, RAD contacted the Committee to confirm receipt of the RTB letter sent November 29, 2021. The Candidate indicated he had submitted the 2021 October Quarterly Report on paper due to difficulty filing electronically, and he would soon electronically file the report.³ To date, the Committee has not yet electronically filed the 2021 October Quarterly Report.⁴

The challenge fails to adequately address any of the three valid grounds at 11 C.F.R. § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. 11 C.F.R. § 111.35(b). Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$4,041 civil money penalty.

OAR Recommendations

1. Adopt the Reviewing Officer recommendation for AF# 4261 involving William Sanchez for US Senate and Marcia Rodriguez, in their official capacity as Treasurer, in making the final determination;
2. Make a final determination in AF# 4261 involving William Sanchez for US Senate and Marcia Rodriguez, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$4,041 civil money penalty; and
3. Send the appropriate letter.







The Commission also made a preliminary determination that the civil money penalty was \$4,041 based on the schedule of penalties at 11 C.F.R. § 111.43.

After reviewing your written response and any supplemental information submitted by you and Commission staff, the Reviewing Officer has recommended that the Commission make a final determination and assess a civil money penalty. A copy of the Reviewing Officer’s recommendation is attached.

Subject: Final Determination Recommendation in AF# 4261 – William Sanchez for US Senate and Marcia Rodriguez, in their official capacity as Treasurer (C00765750)

On November 24, 2021, the Commission found reason to believe (“RTB”) that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2021 October Quarterly Report and made a preliminary determination that the civil money penalty was \$4,041 based on the schedule of penalties at 11 C.F.R. § 111.43. On December 3, 2021, the Commission received their written response (“challenge”). After reviewing the challenge, the Reviewing Officer Recommendation (“ROR”) dated February 1, 2022 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference. The Reviewing Officer recognized the Committee timely submitted a paper version of the 2021 October Quarterly Report. However, the report was considered not filed because the Committee is required to file reports electronically. The Reviewing Officer determined the challenge failed to adequately address any of the three valid grounds at 11 C.F.R. § 111.35(b) and recommended that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$4,041 civil money penalty. *See ROR.*

Within 10 days of transmittal of the recommendation, the respondents may file a written response with the Commission Secretary which may not raise any arguments not raised in their challenge or not directly responsive to the ROR. 11 C.F.R. § 111.36(f). On February 14, 2022, the Commission received a written response from the Candidate. The Candidate explains two events which impacted the campaign’s normal operations leading up to the 2021 October Quarterly Report filing deadline. Specifically, the Candidate states that in June 2021, he tragically lost two family members, and the Committee’s campaign manager resigned.

He notes that the campaign’s new temporary staff was able to file the 2021 October

Quarterly Report on paper and has now electronically filed the report.¹ The Candidate concludes by requesting the Commission waive the penalty due to the “excusable neglect” standard. *See* Attachment 1.

The Reviewing Officer’s analysis of the Committee’s requirement to electronically file the 2021 October Quarterly Report is unchanged. *See* ROR. While sympathetic to the Committee’s circumstances leading up to the 2021 October Quarterly reporting period and filing deadline, the Reviewing Officer notes that unavailability and inexperience of a committee’s treasurer or staff, and negligence, are included at 11 C.F.R. § 111.35(d) as examples of circumstances that will not be considered reasonably unforeseen and beyond the respondents’ control. The challenge and response to the ROR both fail to adequately address any of the three valid grounds at 11 C.F.R. § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. 11 C.F.R. § 111.35(b). Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a).

At the time of the RTB finding, the Commission used the level of activity (\$54,678) disclosed on the paper submission of the 2021 October Quarterly Report to calculate the penalty because the report had not yet been electronically filed. 11 C.F.R. § 111.43(d)(3)(i). At the time of the ROR, the Committee had still not yet electronically filed the report. On February 10, 2022, the Committee electronically filed the 2021 October Quarterly Report disclosing a lower level of activity of \$40,967.04. The report was filed 118 days late and is considered not filed. 11 C.F.R. § 111.43(e)(1). Using the schedule of penalties at 11 C.F.R. § 111.43(a), a penalty of \$1,267 should be assessed (reduced from the RTB civil money penalty of \$4,041).

The Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$1,267 civil money penalty (reduced from the RTB civil money penalty of \$4,041).

OAR Recommendations

1. Adopt the Reviewing Officer recommendation for AF# 4261 involving William Sanchez for US Senate and Marcia Rodriguez, in their official capacity as Treasurer, in making the final determination;
2. Make a final determination in AF# 4261 that William Sanchez for US Senate and Marcia Rodriguez, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$1,267 civil money penalty (reduced from the RTB civil money penalty of \$4,041); and
3. Send the appropriate letter.

This is in response to an FEC letter dated February 3, 2022 directed to our campaign regarding the 3rd quarter filing.

In response to the reviewing officer's recommendations we submit the following, which we hope to be considered under the doctrine of "excusable regret."

1. The campaign suffered a very unfortunate loss which negatively affected the our capacity to effectively function in the 3rd and 4th quarter. On June 23, 2022 a terrible tragedy occurred in Miami Beach, in which a building collapsed with over 100 fatalities.
<https://www.newyorker.com/news/as-told-to/a-miami-familys-agonizing-wait> My aunt and uncle were unfortunately 2 of the victims. As a result of this tragedy, the campaign was significantly affected during the end of

2. the 2nd quarter and beginning of the third quarter. As is expected, it took the campaign a significant amount of time to once again function properly, which affected our 3rd quarter filing.
3. Furthermore, in mid June, the campaign's campaign manager withdrew. Enclosed is a copy of a redacted email from our campaign manager which confirms this. We redacted her name
4. These unexpected events obviously affected our young campaign at the end of the 2nd quarter and throughout the 3rd quarter. We were nevertheless able to file a paper report with our new temporary staff, and have uploaded online, the 3rd quarters filing as of last week.
5. The federal definition for "excusable neglect" in the 11th Circuit, where the campaign is located, is as follows:

The determination of what constitutes excusable neglect is generally an equitable one, taking into account the totality of the circumstances surrounding the party's omission." *Sloss Indus. Corp. v. Eurisol*, 488 F.3d 922, 934 (11th Cir. 2007). Relevant considerations include the *Pioneer* factors: "the danger of prejudice to the [opposing party], the length of the delay and its potential impact on judicial proceedings, the reason for the delay, including whether it was within the

reasonable control of the movant, and whether the movant acted in good faith.” *Pioneer Inv. Servs. Co. v. Brunswick Assocs. Ltd.*, 507 U.S. 380, 394 (1993). “

At this point in the process, the FEC is not considered to be the (opposing party), but if it were, it is difficult to see how it would be prejudiced by the excusable late filing. The length of delay was minimal and the campaign in fact filed in paper form on a timely basis. The reasons for the delay are clearly understandable and were not within the control of the candidate. The campaign has always shown that it has acted in good faith.

Given this analysis of the “excusable neglect” standard, the campaign believes it has met all of the relevant factors set forth by the *Pioneer* court and thus respectfully requests that the campaign’s reasonable request to excuse the late filing be granted.



On November 24, 2021, the Federal Election Commission (“the Commission”) found reason to believe (“RTB”) that William Sanchez for US Senate and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) for failing to file the 2021 October Quarterly Report. By letter dated November 29, 2021, the Commission sent notification of the RTB finding that included a civil money penalty calculated at \$4,041 in accordance with the schedule of penalties at 11 C.F.R. § 111.43. On December 3, 2021, the Office of Administrative Review received your written response challenging the RTB finding.

The Reviewing Officer reviewed the Commission’s RTB finding with its supporting documentation and your written response. Based on this review, the Reviewing Officer recommended that the Commission make a final determination that William Sanchez for US Senate and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a civil money penalty in the amount of \$4,041 in accordance with 11 C.F.R. § 111.43. The Reviewing Officer Recommendation was sent to you on February 3, 2022. On February 10, 2022, the Commission received the electronically filed 2021 October Quarterly Report. On February 14, 2022, the Commission received your written response.

On May 3, 2022, the Commission adopted the Reviewing Officer’s final recommendation and made a final determination that William Sanchez for US Senate and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and based on the level of activity disclosed on the electronically filed 2021 October Quarterly Report (\$40,967.04), assessed a civil money penalty in the amount of \$1,267 (reduced from the RTB civil money penalty of \$4,041). It is based on the same factors used to calculate the civil money penalty at RTB, except that the actual level of activity of the electronically filed report was used. A copy of the Final Determination Recommendation is attached.

At this juncture, the following courses of action are available to you:

1. If You Choose to Appeal the Final Determination and/or Civil Money Penalty

If you choose to appeal the final determination, you should submit a written petition, within 30 days of receipt of this letter, to the U.S. District Court for the district in which the committee or you reside, or transact business, requesting that the final determination be modified or set aside. See 52 U.S.C. § 30109(a)(4)(C)(iii). Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of the respondents' right to present such argument in a petition to the district court under 52 U.S.C. § 30109. 11 CFR § 111.38.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Appeal

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701, *et seq.* If you do not pay this debt within 30 days (or file a written petition to a federal district court - see below), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Within 5 days of the transfer to Treasury, Treasury will contact you to request payment. Treasury currently charges a fee of 30% of the civil money penalty amount for its collection services. If the age of the debt is greater than or equal to two years old, Treasury will charge a fee of 32% of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency ("PCA"). If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

Actions which may be taken to enforce recovery of a delinquent debt by Treasury may also include: (1) offset of any payments that the debtor is due, including tax refunds and salary; (2) referral of the debt to agency counsel for litigation; (3) reporting of the debt to a credit bureau; (4) administrative wage garnishment; and (5) reporting of the debt, if discharged, to the IRS as potential taxable income. In addition, under the provisions of DCIA and other statutes applicable to the FEC, the debtor may be subject to the assessment of other statutory interest, penalties, and administrative costs.

In accordance with the DCIA, at your request, the agency will offer you the opportunity to inspect and copy records relating to the debt, the opportunity for a review of the debt, and the opportunity to enter into a written repayment agreement.

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the civil money penalty, follow the payment instructions on page 4 of this letter. You should make payment within thirty (30) days of receipt of this letter.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS**4. Partial Payments**

If you make a payment in an amount less than the civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assessed upon making a final determination.

5. Settlement Offers

Any offer to settle or compromise a debt owed to the Commission, including a payment in an amount less than the civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assessed upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

The confidentiality provisions at 52 U.S.C. § 30109(a)(12) no longer apply and this matter is now public. Pursuant to 11 C.F.R. §§ 111.42(b) and 111.20(c), the file will be placed on the public record within 30 days from the date of this notification.
