SUBJECT: Reason to Believe Recommendation -
Failure to File 48-Hour Notices under the Administrative Fine Program

Attached is the name of a principal campaign committee that has failed to file 48-hour notices with the Commission for contributions of \$1,000.00 or more received from (1) the close of books for the Puerto Rico 12-Day Pre-Primary Report up to 48 hours before the August 9, 2020 Primary Election, and (2) from the close of books for the 12-Day Pre-General Report up to 48 hours before the November 3, 2020 General Election in accordance with 52 U.S.C. § 30104(a) and 11 CFR. § 104.5(f). The committee, TODOS CON JENNIFER INC. DBA JENNIFER FOR CONGRESS, represents a candidate who won the General Election. The committee is being referred for failing to file 48-hour notices for contributions totaling \$109,200.00.

A 48-hour notice is required to report all contributions of \$1,000.00 or more, to any authorized committee of a candidate, including contributions from the candidate, loans from the candidate and other non-bank sources and endorsements or guarantees of loans from banks, as per 11 CFR § 104.5(f).

We have attached an information sheet which includes the contributor name, date of receipt and amount of the contributions for which a 48-hour notice was not filed.

In accordance with the schedule of civil money penalties outlined within 11 CFR § 111.44, this committee should be assessed the civil money penalty so indicated.

Recommendation

1. Find reason to believe that TODOS CON JENNIFER INC. DBA JENNIFER FOR CONGRESS and Oriol Campos Hernandez, in their official capacity as treasurer, violated 52 U.S.C. § 30104(a) and make a preliminary determination that a civil money penalty of \$11,720 be assessed.
2. Send the appropriate letter.

Dear Mr. Hernandez,

The Federal Election Campaign Act of 1971, as amended, 52 U.S.C. § 30101, et seq. ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing the Federal Election Commission ("FEC") and the Secretary of State, as appropriate, of any contribution of \$1,000 or more, received by any authorized committee of the candidate after the 20th day, but more than 48 hours before, any election. 52 U.S.C. § 30104(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of receipt, the amount of the contribution, and the identification of the contributor. Id. These notification requirements are in addition to all other reporting requirements. 52 U.S.C. § 30104(a). Our records indicate that Todos Con Jenniffer Inc. Dba Jenniffer for Congress did not submit 48-Hour Notices for contributions of \$1,000 or more, received between July 21, 2020 and August 6, 2020, and between October 15, 2020 and October 31, 2020, totaling \$109,200, as required by 52 U.S.C. § 30104(a)(6)(A). Attachment 1.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 52 U.S.C. § 30104(a). 52 U.S.C. § 30109(a)(4). On March 23, 2022, the FEC found that there is Reason to Believe ("RTB") that Todos Con Jenniffer Inc. Dba Jenniffer for Congress and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) by failing to file the 48-Hour Notices. Based on the FEC's schedule of civil money penalties at 11 C.F.R. § 111.44, the amount of your civil money penalty calculated at the RTB stage is \$11,720. Please see the attached copy of the Commission's administrative fine regulations at 11 C.F.R. §§ 111.30-111.55. Attachment 2. The Commission's website contains further information about how the administrative fine program works and how the fines are calculated. <http://www.fec.gov/af/af.shtml>. 11 CFR § 111.34. The amount of the civil money penalty is \$160 for each non-filed notice plus 10 percent of the dollar amount of the contributions not timely reported. The civil money penalty increases by 25 percent for each prior violation. Send your payment of \$11,720 within forty (40) days of the finding, or by May 2, 2022.

At this juncture, the following courses of action are available to you:

1. If You Choose to Challenge the RTB Finding and/or Civil Money Penalty

If you should decide to challenge the RTB finding and/or calculated civil money penalty, you must submit a written response to the FEC's Office of Administrative Review. Your response must include the AF# (found at the top of page 1 under your committee's identification number) and be received within forty (40) days of the Commission's RTB finding, or May 2, 2022. 11 C.F.R. § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 C.F.R. § 111.36(c).

Please note, all challenges to an RTB finding and/or calculated civil money penalty should be converted to PDF (Portable Document Format) and emailed to administrativefines@fec.gov. The Commission encourages the use of electronic signatures on electronically submitted documents, but scanned copies of ink signatures will be accepted. Electronically submitted challenges will be deemed received on the date it is electronically received by staff.

The FEC will only consider challenges that are based on at least one of three grounds: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 C.F.R. § 111.35(b). For a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. *Id.* Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) a failure of Commission computers or Commission-provided software despite your seeking technical assistance from Commission personnel and resources; (2) a widespread disruption of information transmissions over the Internet that is not caused by a failure of the Commission's or your computer systems or Internet service provider; and (3) severe weather or other disaster-related incident. 11 C.F.R. § 111.35(c). Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) negligence; (2) delays caused by vendors or contractors; (3) treasurer and staff illness, inexperience or unavailability; (4) committee computer, software, or Internet service provider failures; (5) failure to know filing dates; and (6) failure to use filing software properly. 11 C.F.R. § 111.35(d).

The "failure to raise an argument in a timely fashion during the administrative process

shall be deemed a waiver" of your right to present such argument in a petition to the U.S. District Court under 52 U.S.C. § 30109. 11 C.F.R. § 111.38.

If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge

If you do not pay the calculated civil money penalty and do not submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that Todos Con Jenniffer Inc. Dba Jenniffer For Congress and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701, *et seq.* The FEC may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 C.F.R. § 111.51(a)(2).

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the calculated civil money penalty, follow the payment instructions on page 4 of this letter. Upon receipt of your payment, the FEC will send you a final determination letter.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS

4. Partial Payments

If you make a payment in an amount less than the calculated civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assesses upon making a final determination.

5. Settlement Offers

Any offer to settle or compromise a debt owed to the Commission, including a payment in an amount less than the calculated civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be

deposited and treated as a partial payment towards the civil money penalty that the Commission assesses upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

This matter was generated based on information ascertained by the FEC in the normal course of carrying out its supervisory responsibilities. 52 U.S.C. § 30109(a)(2). Unless you notify the FEC in writing that you wish the matter to be made public, it will remain confidential in accordance with 52 U.S.C. § 30109(a)(4)(B) and 30109(a)(12)(A) until it is placed on the public record at the conclusion of this matter in accordance with 11 C.F.R. § 111.42.

Dear Mr. Allen:

We acknowledge receipt of your notice dated March 28, 2022, informing us that the FEDERAL ELECTIONS COMMISSION found reason to believe that TODOS CON JENNIFER failed to file the 48-Hour Notices for contributions of \$1,000 or more, received between July 21, 2020 and August 6, 2020, and between October 15, 2020 and October 31, 2020.

We acknowledge that, due to an inadvertent oversight, the 48-Hour Notices for some contributions of \$1,000 or more, received between October 15, 2020 and October 31, 2020 which are listed in Attachment 1 of the Notice were not filed within the prescribed period, although they were included in subsequent disclosures. According to our calculations, the fines assessed for these contributions totals \$4,470.00. We will make the corresponding payment for this amount.


In regards with the Civil Penalty imposed on the Committee due to failure to submit Primary 48-Hour Notices for contributions of \$1,000 or more, received between July 21, 2020 and August 6, 2020 because, we intend to challenge those, based on a factual error in the RTB finding. We believe that, since there was no federal primary celebrated in Puerto Rico, we did not need to be filed, therefore it should not be imposed any penalty on us.

As a territory, Puerto Rico only has one federal elected official: the Resident Commissioner. Although two local parties held primaries for local elected positions during the 2020 election cycle, ***none of the five parties in Puerto Rico held primaries for the position of the Resident Commissioner and none of the candidates for Resident Commissioner in the general election were subject to a primary process.*** Because Puerto Rico did not hold a primary for any federal

position in the 2020 election cycle, we understood that we were not subject to the requirement to submit any 48-Hour Notice reports during those dates.

In light of the aforementioned, we respectfully request that the Commission reconsider any fines for failing to file the 48-Hour Notices for contributions of \$1,000 or more, received between July 21, 2020 and August 6, 2020.

**REVIEWING OFFICER RECOMMENDATION
OFFICE OF ADMINISTRATIVE REVIEW (“OAR”)**

AF# 4285 – Todos Con Jenniffer Inc. DBA Jenniffer for Congress and Oriol Campos Hernandez, in their official capacity as Treasurer (C00588392)

Summary of Recommendation

Make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$11,720 civil money penalty.

Reason-to-Believe Background

In connection with the 2020 Puerto Rico Primary Election held on August 9, 2020, the respondents were required to file 48-Hour Notices for contributions of \$1,000 or more received between July 21, 2020 and August 6, 2020. In connection with the 2020 General Election held on November 3, 2020, the respondents were required to file 48-Hour Notices for contributions of \$1,000 or more received between October 15, 2020 and October 31, 2020. On March 23, 2022, the Commission found reason to believe (“RTB”) that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file 48-Hour Notices for 60 contributions totaling \$109,200 and made a preliminary determination that the civil money penalty was \$11,720 based on the schedule of penalties at 11 C.F.R. § 111.44. A letter was sent to the respondents’ e-mail address of record from the Reports Analysis Division (“RAD”) on March 28, 2022 to notify them of the Commission’s RTB finding and civil money penalty.

Legal Requirements

The Federal Election Campaign Act (“Act”) requires that the principal campaign committee of a candidate must notify the Commission, in writing, of any contribution of \$1,000 or more received after the 20th day but more than 48 hours before an election. The principal campaign committee must notify the Commission within 48 hours of receipt of the contribution. The 48-hour notification shall be in addition to all other reporting requirements under the Act. 52 U.S.C. § 30104(a)(6)(A) and 11 C.F.R. § 104.5(f). Reports electronically filed must be received and validated at or before 11:59 pm Eastern Standard/Daylight Time on the filing deadline to be timely filed. 11 C.F.R. §§ 100.19(c) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

Summary of Respondents' Challenge

On May 2, 2022, the Commission received the written response (“challenge”) from the Treasurer stating there was an error in the RTB finding. The Treasurer acknowledges that the Committee failed to timely file 48-Hour Notices for the cited contributions received from October 15, 2020 through October 31, 2020. The Treasurer states that the Committee plans to make payment for this portion of the penalty, which they have calculated to be \$4,470. The Treasurer states the Committee was not required to file 48-Hour Notices for the remaining contributions included in the RTB finding, which were received from July 21, 2020 through August 6, 2020.

The Treasurer explains that the Committee was not required to file 48-Hour Notices in connection with the 2020 Primary Election “...since there was no federal primary celebrated in Puerto Rico.” The Treasurer states, in part:

As a territory, Puerto Rico only has one federal elected official: the Resident Commissioner. Although two local parties held primaries for local elected positions during the 2020 election cycle, *none of the five parties in Puerto Rico held primaries for the position of the Resident Commissioner and none of the candidates for Resident Commissioner in the general election were subject to a primary process.* Because Puerto Rico did not hold a primary for *any* federal position in the 2020 election cycle, we understood that we were not subject to the requirement to submit any 48-Hour Notice reports during those dates. (emphasis included)

The Treasurer requests that the Commission reconsider assessing a penalty for the 2020 Primary 48-Hour Notices.

Analysis

The Committee is the principal campaign committee of Congresswoman Jenniffer González-Colón, whom currently serves as Puerto Rico’s Resident Commissioner to the U.S. House of Representatives.¹ 11 § CFR 100.4. The respondents state the Committee was not required to file 48-Hour Notices in connection with the 2020 Primary Election because no such election was held for the office of Resident Commissioner, nor was the Candidate subject to the primary process.

The Reviewing Officer recognizes that the Candidate may have been unopposed for nomination within their party for the 2020 Primary Election and may not have appeared on the 2020 Primary Election ballot. However, such candidates are still considered to be participating in the primary election and thus, election-specific reporting requirements apply. 11 §§ CFR 100.2, 100.3, 100.4, and 104.5(f). Commission records also indicate the Committee otherwise considered the Candidate to be participating in the 2020 Puerto Rico Primary Election. The Reviewing Officer notes that ahead of the 2020 Puerto Rico Primary Election, the Committee timely filed the 2020 Pre-Primary Report on July 28, 2020.² Further, the Committee has been accepting contributions designated for the 2020 Primary Election since 2017.

Commission records also indicate the Committee should have been aware of its requirement to file 48-Hour Notices in connection with the 2020 Puerto Rico Primary Election. The Committee previously demonstrated its understanding of the filing requirement in connection with the 2016 Puerto Rico Primary Election by timely filing 48-Hour Notices for contributions received during that period. In addition, on July 8, 2020, the Commission's Information Division sent an email to the Committee regarding its 2020 Puerto Rico Primary Election reporting requirements. The email included a link to the 2020 Puerto Rico Primary Election Prior Notice on the Commission's website, which detailed the 48-Hour Notice requirement for contributions of \$1,000 or more received from July 21, 2020 through August 6, 2020.³

The Reviewing Officer concludes that the Commission's RTB finding was not based on a factual error, and the Committee was required to file 48-Hour Notices for all 60 contributions in question. Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$11,720 civil money penalty.

OAR Recommendations

1. Adopt the Reviewing Officer recommendation for AF# 4285 involving Todos Con Jenniffer Inc. DBA Jenniffer for Congress and Oriol Campos Hernandez, in their official capacity as Treasurer, in making the final determination;
2. Make a final determination in AF# 4285 that Todos Con Jenniffer Inc. DBA Jenniffer for Congress and Oriol Campos Hernandez, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$11,720 civil money penalty; and
3. Send the appropriate letter.

On March 23, 2022, the Commission found reason to believe (“RTB”) that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file 48-Hour Notices for 60 contributions totaling \$109,200 and made a preliminary determination that the civil money penalty was \$11,720 based on the schedule of penalties at 11 C.F.R. § 111.44. On May 2, 2022, the Commission received their written response (“challenge”). The respondents acknowledged their failure to timely file 48-Hour Notices in connection with the 2020 Puerto Rico General Election, and on May 3, 2022, the Commission received their partial payment of \$4,470. The respondents challenged the remaining portion of the RTB finding covering their failure to file 48-Hour Notices in connection with the 2020 Puerto Rico Primary Election. After reviewing the challenge, the Reviewing Officer Recommendation (“ROR”) dated June 30, 2022 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference.

The Reviewing Officer recognized that the Candidate may have been unopposed for nomination within their party for the 2020 Primary Election and may not have appeared on the 2020 Primary Election ballot. However, such candidates are still considered to be participating in the primary election and thus, election-specific reporting requirements apply. 11 §§ CFR 100.2, 100.3, 100.4, and 104.5(f). The Reviewing Officer concluded that the Commission’s RTB finding was not based on a factual error, and the Committee was required to file 48-Hour Notices for all 60 contributions in question. Therefore, the Reviewing Officer

recommended that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$11,720 civil money penalty.

Within 10 days of transmittal of the recommendation, the respondents may file a written response with the Commission Secretary which may not raise any arguments not raised in their challenge or not directly responsive to the ROR. 11 C.F.R. § 111.36(f). The respondents have since indicated they accept the Reviewing Officer Recommendation and intend to pay the recommended civil money penalty of \$11,720.

OAR Recommendations

1. Adopt the Reviewing Officer recommendation for AF# 4285 involving Todos Con Jenniffer Inc. DBA Jenniffer for Congress and Oriol Campos Hernandez, in their official capacity as Treasurer, in making the final determination;
2. Make a final determination in AF# 4285 that Todos Con Jenniffer Inc. DBA Jenniffer for Congress and Oriol Campos Hernandez, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$11,720 civil money penalty; and
3. Send the appropriate letter.

On March 23, 2022, the Federal Election Commission (“the Commission”) found reason to believe (“RTB”) that Todos Con Jenniffer Inc. DBA Jenniffer for Congress and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) for failing to timely file 48-Hour Notices for 60 contributions totaling \$109,200. By letter dated March 28, 2022, the Commission sent notification of the RTB finding that included a civil money penalty calculated at \$11,720 in accordance with the schedule of penalties at 11 C.F.R. § 111.44. On May 2, 2022, the Office of Administrative Review received your written response challenging the RTB finding. On May 3, 2022, the Commission received your partial payment of \$4,470.

The Reviewing Officer reviewed the Commission’s RTB finding with its supporting documentation and your written response. Based on this review, the Reviewing Officer recommended that the Commission make a final determination that Todos Con Jenniffer Inc. DBA Jenniffer for Congress and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and assess a civil money penalty in the amount of \$11,720 in accordance with 11 C.F.R. § 111.44. The Reviewing Officer Recommendation was sent to you on June 30, 2022.

On September 21, 2022, the Commission adopted the Reviewing Officer’s recommendation and made a final determination that Todos Con Jenniffer Inc. DBA Jenniffer for Congress and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and assessed a civil money penalty in the amount of \$11,720. A copy of the Final Determination Recommendation is attached.

At this juncture, the following courses of action are available to you:

1. If You Choose to Appeal the Final Determination and/or Civil Money Penalty

If you choose to appeal the final determination, you should submit a written petition, within 30 days of receipt of this letter, to the U.S. District Court for the district in which the committee or you reside, or transact business, requesting that the final determination be modified or set aside. See 52 U.S.C. § 30109(a)(4)(C)(iii). Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of the respondents' right to present such argument in a petition to the district court under 52 U.S.C. § 30109. 11 CFR § 111.38.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Appeal

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701, *et seq.* If you do not pay this debt within 30 days (or file a written petition to a federal district court - see below), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Within 5 days of the transfer to Treasury, Treasury will contact you to request payment. Treasury currently charges a fee of 30% of the civil money penalty amount for its collection services. If the age of the debt is greater than or equal to two years old, Treasury will charge a fee of 32% of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency ("PCA"). If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

Actions which may be taken to enforce recovery of a delinquent debt by Treasury may also include: (1) offset of any payments that the debtor is due, including tax refunds and salary; (2) referral of the debt to agency counsel for litigation; (3) reporting of the debt to a credit bureau; (4) administrative wage garnishment; and (5) reporting of the debt, if discharged, to the IRS as potential taxable income. In addition, under the provisions of DCIA and other statutes applicable to the FEC, the debtor may be subject to the assessment of other statutory interest, penalties, and administrative costs.

In accordance with the DCIA, at your request, the agency will offer you the opportunity to inspect and copy records relating to the debt, the opportunity for a review of the debt, and the opportunity to enter into a written repayment agreement.

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the civil money penalty, follow the payment instructions on page 4 of this letter. You should make payment within thirty (30) days of receipt of this letter.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS

4. Partial Payments

If you make a payment in an amount less than the civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assessed upon making a final determination.

5. Settlement Offers

Any offer to settle or compromise a debt owed to the Commission, including a payment in an amount less than the civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assessed upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

The confidentiality provisions at 52 U.S.C. § 30109(a)(12) no longer apply and this matter is now public. Pursuant to 11 C.F.R. §§ 111.42(b) and 111.20(c), the file will be placed on the public record within 30 days from the date of this notification.
