SUBJECT: Reason To Believe Recommendation – 2022 April Quarterly Report for the

Administrative Fine Program

Attached is a list of political committees and their treasurers who failed to file the 2022 April Quarterly Report in accordance with 52 U.S.C. § 30104(a). The April Quarterly was due on April 15, 2022.

The committees listed in the attached RTB Circulation Report either failed to file the report, filed the report no more than thirty (30) days after the due date (considered a late filed report), or filed the report more than thirty (30) days after the due date (considered a non-filed report). In accordance with the schedule of civil money penalties for reports at 11 C.F.R. 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

Recommendation

1. Find reason to believe that the political committees and their treasurers, in their official capacity, listed on the RTB Circulation Report violated 52 U.S.C. § 30104(a) and make a

preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.

2. Send the appropriate letters.

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires that your committee file an April Quarterly Report of Receipts and Disbursements every calendar year. This report, covering the period January 1, 2022 through March 31, 2022, shall be filed no later than April 15, 2022. 52 U.S.C. § 30104(a). Records at the Federal Election Commission ("FEC") indicate that this report was filed on April 21, 2022, 6 days late.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 52 U.S.C. § 30104(a). 52 U.S.C. § 30109g(a)(4). On June 13, 2022, the FEC found that there is reason to believe ("RTB") that Kimberly Lowe for Congress and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) by failing to file timely this report on or before April 15, 2022. Your response must include the AF# (found at the top of page 1 under your committee's identification number) and be received within forty (40) days of the Commission's RTB finding, or July 23, 2022. 11 C.F.R. § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 C.F.R. § 111.36(c).

Please note, all challenges to an RTB finding and/or calculated civil money penalty should he converted to **PDF** (Portable Document Format) and emailed Commission use administrativefines@fec.gov. The encourages the of signatures on electronically submitted documents, but scanned copies of ink signatures will be accepted. Electronically submitted challenges will be deemed received on the date they are electronically received by staff.

The FEC will only consider challenges that are based on at least one of three grounds: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 C.F.R. § 111.35(b). For a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. Id. 2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge

If you do not pay the calculated civil money penalty and do not submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that Kimberly Lowe for Congress and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701, et seq. The FEC may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 C.F.R. § 111.51(a)(2).

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the calculated civil money penalty, follow the payment instructions on page 4 of this letter. Upon receipt of your payment, the FEC will send you a final determination letter.

On June 21st, 2022 Kimberly Lowe for Congress received AF#4306 stating that a Civil Penalty was due and is hereby appealed such that the penalty is based on an inaccurate amount listed on form AF#4306 and as such is being challenged:

- 1. The level of activity listed for Q1 on AF#4306 is \$75,096 when Kimberly Lowe for Congress over a year has a total of \$65,562.77, and Q1 had operating expenses of only \$36,772.53/total receipts of of \$37,972.53, total disbursements of \$37,124.14 as shown in the online report, thus there is an error. See Exhibit 1.
- 2. The committee has \$94.70 on hand.
- 3. The fee of \$1,595 is exorbitant because:
 - a. The committee only has \$94.70 on hand
 - b. The committee owes \$3,000 in loans
 - c. \$47,674.16 is owed to the committee
 - d. The amount of money added into the campaign account during Q1 in donations was only **\$2837.50** while the fine is \$1,595
- 4. The report being late is due to the fault of the hired accountant and Kimberly Lowe called your office requesting an extension which is not allowed. It is not the fault of Kimberly Lowe that the report was late.
- 5. Kimberly Lowe has been already been penalized for a late report: a. All of Q1 had to be amended and itemized with addresses for every receipt.
 - a. The committee had under **under \$3,000** in donations for Q1 and **\$7,210.39** in individual contributions over a twelve month period. Again the report was late (and I thought it was 3 days late not 6) because the accountant did not file in a timely manner.
- 6. Further there appears to be accountant negligence and Kimberly Lowe would like the opportunity to hire a competent accountant.


CONCLUSION:

The fine amount is incorrect as Kimberly Lowe for Congress did not have that amount of disbursements listed (\$75,096) over a year period as shown in your online records. See the attached Q1 itemized to show exact amounts and addresses as was required to be amended. Over \$1,500 is excessive and inaccurate particularly considering less than \$3,000 was raised in Q1. The fine is over 50% of the amount raised. Please consider removing the fine, correcting the days late and the inaccurate amount raised on AF #4306, and giving Ms. Lowe the opportunity to hire a proper accountant. Thank you for your time and consideration.

REVIEWING OFFICER RECOMMENDATION OFFICE OF ADMINISTRATIVE REVIEW ("OAR")

AF# 4306 – Kimberly Lowe for Congress and Kim Lowe, in their official capacity as Treasurer (C00773838)

Summary of Recommendation

Make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$1,595 civil money penalty.

Reason-to-Believe Background

The 2022 April Quarterly Report was due on April 15, 2022. The respondents filed the report on April 21, 2022, 6 days late. The report is not election sensitive and was filed within 30 days of the due date; therefore, the report is considered late. 11 C.F.R. §§ 111.43(d)(1) and (e)(1).

On June 13, 2022, the Commission found reason to believe ("RTB") that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2022 April Quarterly Report and made a preliminary determination that the civil money penalty was \$1,595 based on the schedule of penalties at 11 C.F.R. § 111.43. A letter was sent to the respondents' email address of record from RAD on June 15, 2022 to notify them of the Commission's RTB finding and civil money penalty.

Legal Requirements

The Federal Election Campaign Act ("Act") states that the treasurer of a principal campaign committee shall file a quarterly report for the period ending March 30 no later than April 15. 52 U.S.C. § 30104(a)(2) and 11 C.F.R. § 104.5(a). Reports electronically filed must be received and validated at or before 11:59 pm Eastern Standard/Daylight Time on the filing deadline to be timely filed. 11 C.F.R. §§ 100.19(c) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

Summary of Respondents' Challenge

On July 22, 2022, the Commission received the written response ("challenge") from the Candidate who also serves as Treasurer. The Candidate states that she is not responsible for the late filing. The Committee had hired an accountant who appears to be negligent. The Candidate notes that she called the FEC to request a filing extension, but the extension was not granted.

The Candidate also notes the incorrect calculation of the civil money penalty. She believes the report was 3 days late rather than 6 days late. Further, the Candidate explains that the RTB finding is based on an incorrect level of activity of \$75,096. She notes that the 2022 April Quarterly Report disclosed only \$2,837.50 in contributions received, \$37,972.53 in total receipts, \$36,772.53 in operating expenditures, and \$37,124.14 in total disbursements.

Further, the Candidate explains the Committee's current financial standing, noting that it only has \$94.70 in cash on hand, with \$3,000 in debts to be paid and \$47,674.16 owed to the Committee. The Candidate highlights the \$1,595 penalty is exorbitant considering the minimal activity of the Committee. She also notes she has already been penalized by being required to amend a report to disclose the addresses of contributors. She requests the Commission remove or recalculate the penalty and give her an opportunity to hire a new accountant.

Analysis

The Candidate, who also serves as the Committee's Treasurer, explains the 2022 April Quarterly Report was not timely filed due to accountant negligence. The Candidate contends she is not responsible for the late filing of the report. However, a committee's treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d). Moreover, delays caused by committee vendors or contractors and negligence are specifically included at 11 C.F.R. § 111.35(d) as examples of circumstances that will not be considered reasonably unforeseen and beyond the respondents' control.

The Candidate also contends the civil money penalty was incorrectly calculated at RTB. The 2022 April Quarterly Report was due on April 15, 2022. 52 U.S.C. § 30104(a)(2)(A)(iii) and 11 C.F.R. § 104.5(a)(1)(i). The Committee filed the report on April 21, 2022. Therefore, the Reviewing Officer confirms the report was filed 6 days late. Further, the Reviewing Officer notes that the level of activity is defined as "the total amount of receipts and disbursements for the period covered by the late report." 11 C.F.R § 111.43(d)(3)(i). The Committee's 2022 April Quarterly Report disclosed \$37,972.53 in total receipts and \$37,124.14 in total disbursements for the reporting period. Therefore, the Reviewing Officer confirms the level of activity is \$75,096. Using the schedule of penalties at 11 C.F.R § 111.43(a) for the level of activity bracket of \$75,000 - \$99,999.99, the civil money penalty is [\$635 + (\$160 x 6 days late)] x [1 + (.25 x 0 previous violations)] or \$1,595. The Reviewing Officer confirms the penalty was correctly calculated at RTB.

The challenge fails to adequately address any of the three valid grounds at 11 C.F.R § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. 11 C.F.R. § 111.35(b). Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$1,595 civil money penalty.

OAR Recommendations

- 1. Adopt the Reviewing Officer recommendation for AF# 4306 involving Kimberly Lowe for Congress and Kim Lowe, in their official capacity as Treasurer, in making the final determination;
- 2. Make a final determination in AF# 4306 that Kimberly Lowe for Congress and Kim Lowe, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$1,595 civil money penalty; and
- 3. Send the appropriate letter.

On June 13, 2022, the Commission found reason to believe ("RTB") that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2022 April Quarterly Report and made a preliminary determination that the civil money penalty was \$1,595 based on the schedule of penalties at 11 C.F.R. § 111.43. On July 22, 2022, the Commission received their written response ("challenge"). After reviewing the challenge, the Reviewing Officer Recommendation ("ROR") dated September 20, 2022 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference.

The Reviewing Officer noted that delays caused by committee vendors or contractors and negligence are specifically included at 11 C.F.R. § 111.35(d) as examples of circumstances that will not be considered reasonably unforeseen and beyond the respondents' control. The Reviewing Officer also confirmed the penalty was correctly calculated at RTB. The challenge failed to adequately address any of the three valid grounds at 11 C.F.R § 111.35(b). Therefore, the Reviewing Officer recommended that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$1,595 civil money penalty.

Within 10 days of transmittal of the recommendation, the respondents may file a written response with the Commission Secretary which may not raise any arguments not raised in their challenge or not directly responsive to the ROR. 11 C.F.R. § 111.36(f). To date, a response has not been received.

OAR Recommendations

- 1. Adopt the Reviewing Officer recommendation for AF# 4306 involving Kimberly Lowe for Congress and Kim Lowe, in their official capacity as Treasurer, in making the final determination;
- 2. Make a final determination in AF# 4306 that Kimberly Lowe for Congress and Kim Lowe, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$1,595 civil money penalty; and
- 3. Send the appropriate letter.

Dear Kim Lowe:

On June 13, 2022, the Federal Election Commission (the "Commission" or "FEC") found reason to believe ("RTB") that Kimberly Lowe for Congress and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) for failing to file the 2022 April Quarterly Report. By letter dated June 15, 2022, the Commission sent notification of the RTB finding that included a civil money penalty calculated at \$1,595 in accordance with the schedule of penalties at 11 C.F.R. § 111.43. On July 22, 2022, the Office of Administrative Review received your written response challenging the RTB finding.

The Reviewing Officer reviewed the Commission's RTB finding with its supporting documentation and your written response. Based on this review, the Reviewing Officer recommended that the Commission make a final determination that Kimberly Lowe for Congress and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and assess a civil money penalty in the amount of \$1,595 in accordance with 11 C.F.R. § 111.43. The Reviewing Officer Recommendation was sent to you on September 20, 2022.

On February 22, 2023, the Commission adopted the Reviewing Officer's recommendation and made a final determination that Kimberly Lowe for Congress and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and assessed a civil money penalty in the amount of \$1,595. A copy of the Final Determination Recommendation is attached.

At this juncture, the following courses of action are available to you:

1. If You Choose to Appeal the Final Determination and/or Civil Money Penalty

If you choose to appeal the final determination, you must submit a written petition requesting that the final determination be modified or set aside. This request must be made within

thirty (30) days of receipt of this letter and sent to the U.S. District Court for the district in which the committee or you reside or transact business. *See* 52 U.S.C. § 30109(a)(4)(C)(iii). If you did not timely raise a factual argument in a challenge to the Commission's RTB finding, your right to present such an argument in an appeal to the U.S. District Court under 52 U.S.C. § 30109 shall be deemed waived. 11 C.F.R. § 111.38.

2. If You Choose to Not Pay the Civil Money Penalty and to Not Appeal

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701, et seq. If you do not pay this debt within thirty (30) days and do not appeal the Commission's final determination to the U.S. District Court (see above), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Treasury will contact you to request payment within five (5) days of the receiving the debt. Treasury currently charges a fee of 30% of the civil money penalty amount for its collection services. If the age of the debt is greater than or equal to two years old, Treasury will charge a fee of 32% of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency. If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

Actions which may be taken by Treasury to enforce recovery of a delinquent debt may also include: (1) offset of any payments, which the debtor is due, including tax refunds and salary; (2) referral of the debt to agency counsel for litigation; (3) reporting of the debt to a credit bureau; (4) administrative wage garnishment; and (5) reporting of the debt, if discharged, to the IRS as potential taxable income. In addition, under the provisions of DCIA and other statutes applicable to the FEC, the debtor may be subject to the assessment of other statutory interest, penalties, and administrative costs.

In accordance with the DCIA, at your request, the agency will offer you the opportunity to inspect and copy records relating to the debt, the opportunity for a review of the debt, and the opportunity to enter into a written repayment agreement.

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the civil money penalty, please follow the payment instructions below. You should make payment within thirty (30) days of receipt of this letter.

You may remit payment by Automated Clearinghouse ("ACH") withdrawal from your bank account, or by debit or credit card through Pay.gov, the federal government's secure portal for online collections. Visit www.fec.gov/af/pay.shtml to be directed to Pay.gov's Administrative Fine Program Payment form. Please use the details above to complete the required fields.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS

Partial Payments

If you make a payment in an amount less than the civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assessed upon making a final determination.

Settlement Offers

Any offer to settle or compromise a debt owed to the Commission will be rejected. This includes a payment in an amount less than the civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assessed upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

The confidentiality provisions at 52 U.S.C. § 30109(a)(12) no longer apply and this matter is now public. Pursuant to 11 C.F.R. §§ 111.42(b) and 111.20(c), the file will be placed on the public record within thirty (30) days from the date of this notification.
