SUBJECT: Reason To Believe Recommendation – 2022 October Quarterly Report (Non-

Election Sensitive) for the Administrative Fine Program

Attached is a list of political committees and their treasurers who failed to file the 2022 October Quarterly Report (Non-Election Sensitive) in accordance with 52 U.S.C. § 30104(a). The October Quarterly Report was due on October 15, 2022.

The committees listed on the attached RTB Circulation Report either failed to file the report or filed the report — no more than thirty (30) days after the due date (considered a late filed report). In accordance with the schedule of civil money penalties for reports at 11 C.F.R. 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

Recommendation

1. Find reason to believe that the political committees and their treasurers, in their official capacity, listed on the RTB Circulation Report violated 52 U.S.C. § 30104(a) and make a

preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.

2. Send the appropriate letters.

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires that your committee file an October Quarterly Report of Receipts and Disbursements every calendar year. This report, covering the period July 1, 2022 through September 30, 2022, shall be filed no later than October 15, 2022. 52 U.S.C. § 30104(a). Because records at the Federal Election Commission ("FEC") indicate that this report was not filed within thirty (30) days of the due date, the report is considered not filed for the purpose of calculating the civil money penalty. You should file this report if you have not already done so.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 52 U.S.C. § 30104(a). 52 U.S.C. § 30109(a)(4). On December 8, 2022, the FEC found that there is reason to believe ("RTB") that Sturm4Congress and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) by failing to file timely this report on or before October 15, 2022. 1. If You Choose to Challenge the RTB Finding and/or Civil Money Penalty

If you should decide to challenge the RTB finding and/or calculated civil money penalty, you must submit a written response to the FEC's Office of Administrative Review. Your response must include the AF# (found at the top of page 1 under your committee's identification number) and be received within forty (40) days of the Commission's RTB finding, or January 17, 2023. 11 C.F.R. § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 C.F.R. § 111.36(c).

Please note, all challenges to an RTB finding and/or calculated civil money penalty should be converted **PDF** (Portable Document Format) and emailed to Commission use administrativefines@fec.gov. The encourages the signatures on electronically submitted documents, but scanned copies of ink signatures will be accepted. Electronically submitted challenges will be deemed received on the date they are electronically received by staff.

The FEC will only consider challenges that are based on at least one of three grounds: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 C.F.R. § 111.35(b). For a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. Id. Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) a failure of Commission computers or Commission-provided software despite your seeking technical assistance from Commission personnel and resources; (2) a widespread disruption of information transmissions over the Internet that is not caused by a failure of the Commission's or your computer systems or Internet service provider; and (3) severe weather or other disaster-related incident. 11 C.F.R. § 111.35(c). If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address, and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge

If you do not pay the calculated civil money penalty and do not submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that Sturm4Congress and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701, et seq. The FEC may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 C.F.R. § 111.51(a)(2).

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the calculated civil money penalty, follow the payment instructions on page 4 of this letter. Upon receipt of your payment, the FEC will send you a final determination letter.

NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS

4. Partial Payments

If you make a payment in an amount less than the calculated civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assesses upon making a final determination.

5. Settlement Offers

Any offer to settle or compromise a debt owed to the Commission, including making a payment in an amount less than the calculated civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assesses upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

REVIEWING OFFICER RECOMMENDATION OFFICE OF ADMINISTRATIVE REVIEW ("OAR")

AF# 4445 - Sturm4Congress and William Sturm, in their official capacity as Treasurer (C00778589)

Summary of Recommendation

Make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$1,346 civil money penalty.

Reason-to-Believe Background

The 2022 October Quarterly Report was due on October 15, 2022. The respondents have not yet filed the report. The report is not election sensitive and was not filed within 30 days of the due date; therefore, the report is considered not filed. 11 C.F.R. §§ 111.43(d)(1) and (e)(1).

On December 8, 2022, the Commission found reason to believe ("RTB") that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2022 October Quarterly Report and made a preliminary determination that the civil money penalty was \$1,346 based on the schedule of penalties at 11 C.F.R. § 111.43. A letter was sent to the respondents' email address of record from the Reports Analysis Division ("RAD") on December 9, 2022 to notify them of the Commission's RTB finding and civil money penalty.

Legal Requirements

The Federal Election Campaign Act ("Act") states that the treasurer of a principal campaign committee shall file a report for the quarter ending September 30 no later than October 15. 52 U.S.C. § 30104(a) and 11 C.F.R. § 104.5(a)(1)(i). Reports electronically filed must be received and validated at or before 11:59 pm Eastern Standard/Daylight Time on the filing deadline to be timely filed. 11 C.F.R. §§ 100.19(c) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

Summary of Respondents' Challenge

On January 12, 2023, the Commission received the written response ("challenge") from the Candidate. He states the Committee became inactive after the March 2022 Primary Election, and no money has been raised since that time. The Candidate mentions paying a penalty in a separate matter and submitting final paperwork to the FEC.

Analysis

The Reviewing Officer recognizes that the Committee may have become inactive after the 2022 Primary Election. However, a committee's filing obligation ends only when a committee files a termination report, and the Commission notifies them in writing that their termination report has been accepted. 11 C.F.R § 102.3.¹ On March 14, 2022, the Committee filed a termination report.² On March 22, 2022, RAD notified the Committee that its termination report was not accepted due to outstanding reporting issues.³ On March 30, 2022, the Committee filed an amended termination report which partially corrected the cited reporting issues.⁴ To date, the Committee has not resolved all outstanding reporting issues, and the Committee's request for termination has not been approved. Therefore, the respondents were required to file the 2022 October Quarterly Report.⁵

At the time of the RTB finding, the Commission used an estimated level of activity (\$26,845) to calculate the penalty because the 2022 October Quarterly Report had not yet been filed. 11 C.F.R § 111.43(d)(2)(i). To date, the Committee has not yet filed the report. In order to calculate the civil money penalty using the actual level of activity disclosed on the 2022 October Quarterly Report, the Committee shall file the report prior to the Reviewing Officer's Final Determination Recommendation to the Commission and no later than April 7, 2023. The recommended civil money penalty in the Final Determination Recommendation will be calculated using the actual level of activity of the 2022 October Quarterly Report. 11 C.F.R § 111.43(d)(3)(i).

At the time of this Reviewing Officer Recommendation, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$1,346 civil money penalty.

OAR Recommendations

- 1. Adopt the Reviewing Officer recommendation for AF# 4445 involving Sturm4Congress and William Sturm, in their official capacity as Treasurer, in making the final determination;
- 2. Make a final determination in AF# 4445 that Sturm4Congress and William Sturm, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$1,346 civil money penalty; and
- 3. Send the appropriate letter.

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following 2 item(s):

1. While it is permissible for a person to make a contribution for the general election prior to the primary election, the recipient committee must employ an acceptable accounting method to distinguish between primary and general election contributions. (11 CFR § 102.9(e)) This general election amount must be maintained in the committee's account.

Since the candidate will not participate in the general election, any contribution received for the general election must be returned to the donors or redesignated to the primary if your committee has net debts outstanding for the primary election. To redesignate a contribution the committee must either (1) obtain written documentation from the contributor(s) authorizing redesignation of the contribution for another election provided that the new designation does not exceed the limitations on contributions made with respect to that election, or (2) redesignate the contribution by presumption to the primary election, for undesignated contributions made after the primary but before the general election, provided that the new designation does not exceed the limitations on contributions made with respect to that election. In this case, the treasurer must notify the contributor of the redesignation in writing. The notification must give the contributor an opportunity to request a refund. A contribution can only be redesignated to a previous election to the extent that the contribution does not exceed net debts outstanding for that election. (11 CFR § 110.1(b)(3)(i) and (5)(ii)(C)

The attached general election contributions do not appear to have been remedied. Any subsequent report(s) filed with the Commission must disclose the refund or redesignation of any general election contribution. Refunds or redesignations must be done within 60 days after the 2022 Primary Election.

2. Your committee has requested that the Commission permit your committee to terminate pursuant to 52 U.S.C. §30103(d) (formerly 2 U.S.C. §433(d)) and 11 CFR §102.3. In order to terminate your committee, you must file amendments to correct any problems on your 2021 July Quarterly Report, 2021 October Quartelry Report, this Termination Report and/or on any previous reports that still contain uncorrected errors or omissions. If you are not certain about what corrections need to be made, please contact the undersigned analyst. Once the FEC receives and approves the corrections to your report(s), it will notify you. Until that time, you must continue to file all required reports.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. On December 8, 2022, the Commission found reason to believe ("RTB") that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2022 October Quarterly Report and made a preliminary determination that the civil money penalty was \$1,346 based on the schedule of penalties at 11 CFR § 111.43. On January 12, 2023, the Commission received their written response ("challenge"). After reviewing the challenge, the Reviewing Officer Recommendation ("ROR") dated March 10, 2023 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference.

The Reviewing Officer recognized the Committee may have become inactive after the 2022 Primary Election but noted that a committee's filing obligation ends only when a committee files a termination report, and the Commission notifies them in writing that their termination report has been accepted. 11 CFR § 102.3. While the Committee had filed a termination report, RAD notified the Committee that its termination report was not accepted due to outstanding reporting issues. At the time the 2022 October Quarterly Report was due, the Committee had not yet resolved all outstanding reporting issues, and the Committee's request for termination had not been approved. Therefore, the respondents were required to file the 2022 October Quarterly Report. Further, the Reviewing Officer noted that the 2022 October Quarterly Report had not yet been filed and explained that in order to recalculate the civil money penalty using the actual level of activity disclosed on the 2022 October Quarterly Report, the Committee shall file the report prior to the Reviewing Officer's Final Determination Recommendation to the Commission and no later than April 7, 2023. See ROR.

Within 10 days of transmittal of the recommendation, the respondents may file a written response with the Commission Secretary which may not raise any arguments not raised in their challenge or not directly responsive to the ROR. 11 CFR § 111.36(f). To date, the respondents have not filed the 2022 October Quarterly Report, nor directly responded to the ROR or OAR's numerous attempts to make contact. However, in response to a separate administrative fine matter, the Committee filed a Miscellaneous Electronic Submission (FEC Form 99)¹ indicating the Committee had no activity after its latest filed report ending March 14, 2022.²

At the time of the RTB finding, the Commission used an estimated level of activity (\$26,845) to calculate the penalty because the report had not yet been filed. 11 CFR § 111.43(d)(2)(i). Based on the FEC Form 99, the actual level of activity for the 2022 October Quarterly reporting period is \$0. 11 CFR § 111.43(d)(3)(i). Using the schedule of penalties at 11 CFR § 111.43(a), no civil money penalty should be assessed for a level of activity of \$0. Therefore, the Reviewing Officer recommends that the Commission assess no civil money penalty (reduced from the RTB civil money penalty of \$1,346).

OAR Recommendations

- 1. Adopt the Reviewing Officer recommendation for AF# 4445 involving Sturm4Congress and William Sturm, in their official capacity as Treasurer, in making the final determination;
- 2. Make a final determination in AF# 4445 that Sturm4Congress and William Sturm, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess no civil money penalty (reduced from the RTB civil money penalty of \$1,346); and
- 3. Send the appropriate letter.

On December 8, 2022, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Sturm4Congress and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) for failing to file the 2022 October Quarterly Report. By letter dated December 9, 2022, the Commission sent notification of the RTB finding that included a civil money penalty calculated at \$1,346 in accordance with the schedule of penalties at 11 CFR § 111.43. On January 12, 2023, the Office of Administrative Review received your written response challenging the RTB finding.

The Reviewing Officer reviewed the Commission's RTB finding with its supporting documentation and your written response. The Reviewing Officer recommended that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$1,346 civil money penalty. The Reviewing Officer also noted that in order to calculate the civil money penalty using the actual level of activity disclosed on the 2022 October Quarterly Report, the Committee shall file the report prior to the Reviewing Officer's Final Determination Recommendation to the Commission. The Reviewing Officer Recommendation was sent to you on March 13, 2023.

On January 17, 2024, the Commission adopted the Reviewing Officer's recommendation and made a final determination that Sturm4Congress and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and based on the level of activity disclosed on the Miscellaneous Electronic Submission filed April 26, 2023, assessed no civil money penalty (reduced from the RTB civil money penalty of \$1,346). It is based on the same factors used to calculate the civil money penalty at RTB except that the actual level of activity, rather than the estimated level of activity, was used. A copy of the Final Determination Recommendation is attached.

The confidentiality provisions at 52 U.S.C. § 30109(a)(12) no longer apply and this matter is now public. Pursuant to 11 CFR §§ 111.42(b) and 111.20(c), the file will be placed on the public record within 30 days from the date of this notification.
