

Attached is a list of political committees and their treasurers who failed to file the 2023 Year-End Report in accordance with 52 U.S.C. § 30104(a). The Year-End Report was due on January 31, 2024.

The committees listed in the attached RTB Circulation Report either failed to file the report, filed the report [REDACTED] no more than thirty (30) days after the due date (considered a late filed report), or filed the report more than thirty (30) days after the due date (considered a non-filed report). In accordance with the schedule of civil money penalties for reports at 11 C.F.R. 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

Dear Trina Estelle,

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires that your committee file a 2023 Year-End Report of Receipts and Disbursements every calendar year. This report, covering the period July 1, 2023 through December 31, 2023, shall be filed no later than January 31, 2024. 52 U.S.C. § 30104(a). Records at the Federal Election Commission (the "Commission" or "FEC") indicate that this report was filed on February 19, 2024, 19 days late.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 52 U.S.C. § 30104(a). 52 U.S.C. § 30109g(a)(4). On March 22, 2024, the Commission found that there is reason to believe ("RTB") that Social Progress in Union with Economic Growth and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) by failing to file timely this report on or before January 31, 2024. Based on the FEC's schedules of civil money penalties at 11 CFR § 111.43, the amount of your civil money penalty calculated at the RTB stage is \$5,258. Please see the attached copy of the Commission's administrative fine regulations at 11 CFR §§ 111.30-111.55. Attachment 1. The FEC's website contains further information about how the administrative fine program works and how the fines are calculated. See <https://www.fec.gov/af/af.shtml>. 11 CFR § 111.34. Your payment of \$5,258 is due within forty (40) days of the finding, or by May 1, 2024, and is based on these factors:

**1. If You Choose to Challenge the RTB Finding and/or Civil Money Penalty**

If you decide to challenge the RTB finding and/or calculated civil money penalty, you must email a written response to the FEC's Office of Administrative Review at [administrativefines@fec.gov](mailto:administrativefines@fec.gov). Your response must include the AF# (found at the top of page 1 under your committee's identification number) and be received within forty (40) days of the Commission's RTB finding, or May 1, 2024. 11 CFR § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty, and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 CFR § 111.36(c).

The FEC will only consider challenges that are based on at least one of three factors: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 CFR § 111.35(b). For a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. *Id.* Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) a failure of Commission computers or Commission-provided software despite your seeking technical assistance from Commission personnel and resources; (2) a widespread disruption of information transmissions over the Internet that is not caused by a failure of the Commission's or your computer systems or Internet service provider; and (3) severe weather or other disaster-related incident. 11 CFR § 111.35(c). Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) negligence; (2) delays caused by vendors or contractors; (3) treasurer and staff illness, inexperience, or unavailability; (4) committee computer, software, or Internet service provider failures; (5) failure to know filing dates; and (6) failure to use filing software properly. 11 CFR § 111.35(d).

If you fail to timely raise a factual argument in your challenge to the RTB finding, your right to present such an argument in an appeal to the U.S. District Court under 52 U.S.C. § 30109 shall be deemed waived. 11 CFR § 111.38.

It should also be noted that all challenges to an RTB finding and/or calculated civil money penalty should be converted to Portable Document Format ("PDF") and emailed to [administrativefines@fec.gov](mailto:administrativefines@fec.gov). The Commission encourages the use of electronic signatures on electronically submitted documents, but scanned copies of ink signatures will be accepted. Electronically submitted challenges will be deemed received on the date they are electronically received by staff.

In addition, if you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address, and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

**2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge**

If you do not pay the calculated civil money penalty and do not submit a written response challenging the RTB finding and/or calculated civil money penalty, the FEC will conclude that the factual allegations underlying the RTB finding and/or calculated civil money penalty are true and make a final determination that Social Progress in Union with Economic Growth and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701, et seq. The Commission may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 CFR § 111.51(a)(2).

**3. If You Choose to Pay the Civil Money Penalty**

If you decide to pay the calculated civil money penalty, please follow the payment instructions below. Upon receipt of your payment, the FEC will send you a final determination letter.

You may remit payment by Automated Clearinghouse ("ACH") withdrawal from your bank account, or by debit or credit card through Pay.gov, the federal government's secure portal for online collections. Visit <https://www.fec.gov/af/pay.shtml> to be directed to Pay.gov's Administrative Fine Program Payment form. Please use the details at the top of this letter to complete the required fields.

Any offer to settle or compromise a debt owed to the Commission will be rejected. This includes making a payment in an amount less than the calculated civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assesses upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

This matter was generated based on information ascertained by the FEC in the normal course of carrying out its supervisory responsibilities. 52 U.S.C. § 30109(a)(2). Unless you notify the FEC in writing that you wish the matter to be made public, it will remain confidential in accordance with 52 U.S.C. §§ 30109(a)(4)(B) and 30109(a)(12)(A) until it is placed on the public record at the conclusion of this matter in accordance with 11 CFR § 111.42.



I am in receipt of your letter issuing a fine dated March 22, 2024. I am challenging the civil money penalty for the reason that I am inexperienced. The factual basis to support my reason are the following declarations:



1. This is the first time I was filing on my own as I had my accountant previously walk me through the process with the first filing. Please note that I have not been a treasurer before on any other independent expenditure committee.
2. On January 17, 2024, I prepared and validated the report timely as evidenced by report FEC Form 3X that I had saved for my records and is accompanying this letter. However, based on my inexperience, I erroneously considered this report to be filed because there was no icon button to file, only to validate. Not recalling that I had to go to the “File” master menu and select “Upload a Report” to file.
3. On February 19, 2023, when I saw the email with the letter dated February 15, 2024 notifying me that I had not filed, I immediately filed the report by going to the “File” master menu and selecting “Upload a Report” to file.

I am now experienced in this process and am committed to not allowing a late filing to happen again based on inexperience and therefore also understand that using this as a reason in the future will not be an adequate reason for a late filing. I declare that all these statements are true to the best of my knowledge.

OFFICE OF ADMINISTRATIVE REVIEW (“OAR”)**

AF# 4691 – Social Progress in Union with Economic Growth and Trina Estelle, in their official capacity as Treasurer (C00833665)

**Summary of Recommendation**

Make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$5,258 civil money penalty.

**Reason-to-Believe Background**

The 2023 Year-End Report was due on January 31, 2024. The respondents filed the report on February 19, 2024, 19 days late. The report is not election sensitive and was filed within 30 days of the due date; therefore, the report is considered late. 11 C.F.R. §§ 111.43(d)(1) and (e)(1).

On March 22, 2024, the Commission found reason to believe (“RTB”) that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2023 Year-End Report and made a preliminary determination that the civil money penalty was \$5,258 based on the schedule of penalties at 11 C.F.R. § 111.43. A letter was sent to the respondents’ email address of record from the Reports Analysis Division (“RAD”) on March 22, 2024 to notify them of the Commission’s RTB finding and civil money penalty.

**Legal Requirements**

The Federal Election Campaign Act (“Act”) states that the treasurer of a political committee not authorized by a candidate which is filing on a quarterly basis shall file, in a non-election year, a report for the period ending December 31 no later than January 31 of the following calendar year. U.S.C. § 30104(a) and 11 C.F.R. § 104.5(c)(2)(i). Reports electronically filed must be received and validated at or before 11:59 pm Eastern Standard/Daylight Time on the filing deadline to be timely filed. 11 C.F.R. §§ 100.19(c) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

## Summary of Respondents' Challenge

On March 25, 2024, the Commission received the written response (“challenge”) from the Treasurer noting this is her first time serving as a Treasurer, and she was inexperienced at the time she attempted to file the 2023 Year-End Report. The Treasurer further explains that on January 17, 2024, ahead of the January 31 deadline, she prepared and validated the report but failed to properly upload it to the FEC. On February 19, 2024, she became aware of the Commission’s February 15, 2024 email which alerted her to the missing report. She then immediately uploaded the 2023 Year-End Report. The Treasurer states she is now experienced in the upload process and commits to timely filing future reports.

## Analysis

The Treasurer acknowledges that the Committee’s 2023 Year-End Report was not timely filed due to inexperience and failing to properly upload the report. The copy of the report provided with the challenge suggests the Committee closed the report in FECFile<sup>1</sup> on January 17, 2024, prior to the January 31, 2024 filing deadline. However, as noted in the challenge, the Committee failed to take the required next steps to upload the report to the FEC.<sup>2</sup>

The Treasurer states that she became aware of the missing 2023 Year-End Report on February 19, 2024. However, Commission records indicate the Committee was alerted to its failure to file the report prior to this date. On February 1, 2024, the day following the filing deadline, RAD sent a Late Notification email to hairat302@yahoo.com, the Committee’s email address of record, because the Committee had not yet filed the report. On February 15, 2024, RAD sent the Non-filer Notice to the same email address because the Committee had still not yet filed the report.<sup>3</sup>

While the Reviewing Officer recognizes the Committee may have intended to timely file the 2023 Year-End Report, inexperience and failure to use filing software properly are specifically included at 11 C.F.R. § 111.35(d) as examples of circumstances that will not be considered reasonably unforeseen and beyond the respondents’ control. The Reviewing Officer also notes that a committee’s treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d). The challenge fails to address any of the three valid grounds at 11 C.F.R. § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. 11 C.F.R. § 111.35(b). Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a civil money penalty of \$5,258.

Subject: Final Determination Recommendation in AF# 4691 – Social Progress in Union with Economic Growth and Trina Estelle, in their official capacity as Treasurer (C00833665)

On March 22, 2024, the Commission found reason to believe (“RTB”) that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2023 Year-End Report and made a preliminary determination that the civil money penalty was \$5,258 based on the schedule of penalties at 11 C.F.R. § 111.43. On March 25, 2024, the Commission received their written response (“challenge”). After reviewing the challenge, the Reviewing Officer Recommendation (“ROR”) dated May 22, 2024 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference.

The Reviewing Officer recognized the Committee may have intended to properly upload and timely file the 2023 Year-End Report but noted that inexperience and failure to use filing software properly are specifically included at 11 C.F.R. § 111.35(d) as examples of circumstances that will not be considered reasonably unforeseen and beyond the respondents’ control. The challenge failed to address any of the three valid grounds at 11 C.F.R. § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. 11 C.F.R. § 111.35(b). Therefore, the Reviewing Officer recommended that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a civil money penalty of \$5,258. *See ROR.*


Within 10 days of transmittal of the recommendation, the respondents may file a written response with the Commission Secretary which may not raise any arguments not raised in their challenge or not directly responsive to the ROR. 11 C.F.R. § 111.36(f). On July 30, 2024, the Treasurer submitted a response. *See Attachment 1.*

The Treasurer requests that the penalty be abated because it was her first late filing. The Reviewing Officer notes that a committee or treasurer's history of compliance is not grounds for challenging the reason to believe finding or proposed civil money penalty. 11 C.F.R. § 111.35(b). In addition, the Treasurer states she did not receive RAD's February 1, 2024 Late Notification email referenced in the ROR and suggests that it "...may have been blocked by [her] email provider or routed to spam." Further, the Treasurer indicates she would have filed the missing report sooner if she had received this email. The Reviewing Officer again reviewed Commission records and confirms that the February 1, 2024 Late Notification email was appropriately sent from [rad@fec.gov](mailto:rad@fec.gov) to [hairat302@yahoo.com](mailto:hairat302@yahoo.com), the Committee's email address of record.

The Reviewing Officer considered the Treasurer's response to the ROR, and the recommendations are unchanged. The Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$5,258 civil money penalty.

## **OAR Recommendations**

1. Adopt the Reviewing Officer recommendation for AF# 4691 involving Social Progress in Union with Economic Growth and Trina Estelle, in their official capacity as Treasurer, in making the final determination;
2. Make a final determination in AF# 4691 that Social Progress in Union with Economic Growth and Trina Estelle, in their official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$5,258 civil money penalty; and
3. Send the appropriate letter.

Dear Treasurer:

On March 22, 2024, the Federal Election Commission (“the Commission”) found reason to believe (“RTB”) that Social Progress in Union with Economic Growth and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) for failing to file the 2023 Year-End Report. By letter dated March 22, 2024, the Commission sent notification of the RTB finding that included a civil money penalty calculated at \$5,258 in accordance with the schedule of penalties at 11 CFR § 111.43. On March 25, 2024, the Office of Administrative Review received your written response challenging the RTB finding.

The Reviewing Officer reviewed the Commission’s RTB finding with its supporting documentation and your written response. Based on this review, the Reviewing Officer recommended that the Commission make a final determination that Social Progress in Union with Economic Growth and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and assess a civil money penalty in the amount of \$5,258 in accordance with 11 CFR § 111.43. The Reviewing Officer Recommendation was sent to you on May 23, 2024.

On July 30, 2024, the Commission received your response to the ROR. On August 14, 2024, the Commission adopted the Reviewing Officer’s recommendation and made a final determination that Social Progress in Union with Economic Growth and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and assessed a civil money penalty in the amount of \$5,258. A copy of the Final Determination Recommendation is attached.

At this juncture, the following courses of action are available to you:

**1. If You Choose to Appeal the Final Determination and/or Civil Money Penalty**

If you choose to appeal the final determination, you must submit a written petition requesting that the final determination be modified or set aside. This request must be made within thirty (30) days of receipt of this letter and sent to the U.S. District Court for the district in which the committee or you reside or transact business. *See 52 U.S.C. § 30109(a)(4)(C)(iii).* If you did not timely raise a factual argument in a challenge to the Commission's RTB finding, your right to present such an argument in an appeal to the U.S. District Court under 52 U.S.C. § 30109 shall be deemed waived. 11 CFR § 111.38.

**2. If You Choose to Not Pay the Civil Money Penalty and to Not Appeal**

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701, *et seq.* If you do not pay this debt within thirty (30) days and do not appeal the Commission's final determination to the U.S. District Court (see above), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Treasury will contact you to request payment within five (5) days of the receiving the debt. Treasury currently charges a fee of 30 percent of the civil money penalty amount for its collection services. If the age of the debt is greater than or equal to two years old, Treasury will charge a fee of 32 percent of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency. If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

Actions which may be taken by Treasury to enforce recovery of a delinquent debt may also include: (1) offset of any payments, which the debtor is due, including tax refunds and salary; (2) referral of the debt to agency counsel for litigation; (3) reporting of the debt to a credit bureau; (4) administrative wage garnishment; and (5) reporting of the debt, if discharged, to the IRS as potential taxable income. In addition, under the provisions of DCIA and other statutes applicable to the FEC, the debtor may be subject to the assessment of other statutory interest, penalties, and administrative costs.

In accordance with the DCIA, at your request, the agency will offer you the opportunity to inspect and copy records relating to the debt, the opportunity for a review of the debt, and the opportunity to enter into a written repayment agreement.

**3. If You Choose to Pay the Civil Money Penalty**

If you should decide to pay the civil money penalty, please follow the payment instructions below. You should make payment within thirty (30) days of receipt of this letter.

You may remit payment by Automated Clearinghouse ("ACH") withdrawal from your bank account, or by debit or credit card through Pay.gov, the federal government's secure portal for online collections. Visit [www.fec.gov/af/pay.shtml](http://www.fec.gov/af/pay.shtml) to be directed to Pay.gov's Administrative Fine Program Payment form. Please use the details above to complete the required fields.

## **NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS**

### **Partial Payments**

If you make a payment in an amount less than the civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assessed upon making a final determination.

### **Settlement Offers**

Any offer to settle or compromise a debt owed to the Commission will be rejected. This includes a payment in an amount less than the civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assessed upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

The confidentiality provisions at 52 U.S.C. § 30109(a)(12) no longer apply and this matter is now public. Pursuant to 11 CFR §§ 111.42(b) and 111.20(c), the file will be placed on the public record within thirty (30) days from the date of this notification.
