Dear Madam/Sir:

It came to my attention earlier this year that I exceeded my 1999 and 2000 federal contribution limits. I have taken the following steps to correct this oversight.

- 1) On March 3, 1999 a contribution by me to the Republican Federal Committee of Pennsylvania was recorded in the amount of \$5,000. As shown by the enclosed, this contribution was refunded to me by check #1469 on August 23, 2000.
- 2) On August 13, 1999 a contribution by me to the American Renewal PAC was recorded in the amount of \$500. As shown by the enclosed, this contribution was refunded to me by check #1242 dated September 12, 2000.
- 3) On November 8, 1999 a contribution by me to the Friends of Joe Pitts was recorded in the amount of \$250. As shown by the enclosed, this contribution was refunded to me by check #2675 dated April 24, 2000
- 4) On October 27, 1999 a contribution by me to the English Language PAC was recorded in the amount of \$500. As shown by the enclosed, this contribution was refunded to me by check #1502 dated October 1, 2000.
- 5) On May 9, 2000 a contribution by me to the Republican Federal Committee of Pennsylvania was recorded in the amount of \$5,000. As shown by the enclosed, this contribution was refunded to me by check #1552 dated September 29, 2000


I have also enclosed copies of the computer printout from the FEC individual contributor data report to document the specific contributions for which refunds have been made




