Dear Mr. Noble:

The National Republican Congressional Committee, by and through its General Counsel, hereby brings this complaint pursuant to 2 U.S.C. § 437g(a)(1) against Marc A. Flitter, Flitter 2000 Committee and Thomas A. Monohan as Treasurer; Erie County Democratic Party Committee and Ric Coluzzi as Treasurer. The National Republican Congressional Committee is located at 320 First Street, S.E., Washington, D.C. 20003.

I. VIOLATIONS

Marc A. Flitter is a Democrat candidate for United States Congress from the 21st district of Pennsylvania. His campaign committee is Flitter 2000. Flitter currently uses office space provided by The Erie County Democratic Party. Flitter's FEC reports show the following in-kind contributions by The Erie County Democratic Party:

- April 2000 quarterly report shows a \$600 in-kind contribution for January, February, and March 2000 rent, designated for the primary election.
 - July 2000 quarterly report shows a \$600 in-kind contribution for April, May, and June 2000 rent, designated for the general election.
 - October 2000 quarterly report shows a \$600 in-kind contribution for July, August, and September 2000 rent, designated for the general election.
 - Pre-General Election report shows a \$200 in-kind contribution for October rent, designated for the general election.

The Erie County Democratic Party has contributed \$2,000 to Flitter during the current calendar year; however, Erie County has not filed any reports with the Commission for this year, or for any prior years, according to the FEC web site. The Commission regulations are clear. Once a local party organization spends more than \$1,000 per calendar year on contributions or expenditures, it becomes a political committee and must register with the Commission 11 C.F.R. § 100.5(c). Additionally, this activity must be financed with funds that comply with the federal contribution limits and prohibitions. 11 C.F.R. § 102.5(b). Because Erie County has not registered or filed any reports with the Commission, it is impossible to determine the source of the committee's funding.


Furthermore, Erie County would not be considered a multicandidate committee under Commission regulations, and would be subject to a \$1,000 per election contribution limit. 11 C.F.R. § 110.1(b)(1). A contribution includes anything of value given to influence a federal election, including an in-kind contribution. 11 C.F.R. § 100.7(a)(1)(iii). Erie County has currently contributed \$2,000 to Flitter for the current calendar year--\$600 for the primary election and \$1,400 for the general election. As a result, Erie County has made an excessive contribution to Flitter for the general election, and Flitter should be required to refund the amounts in excess of the limits

II. CONCLUSION

For these reasons, and based upon the foregoing, the National Republican Congressional Committee respectfully requests that the Commission find reason to believe that Federal law has been violated and institute appropriate legal action.

The foregoing is correct and accurate to the best of my knowledge, information and belief.


