This is in response to your correspondence dated September 18, 2000, regarding a complaint received by the Federal Election Commission from Mr. John C. LeMenager relative to contributions received by the Richard E. Neal for Congress Committee from Dennis J. Kearney of Winchester, Massachusetts.

The complaint refers to contributions made in May of 1999 (\$1000 - designated to the 2000 Primary Election), and in May of 2000 (\$500 - designated to the 2000 General Election). As the website that Mr. Lemanager obtained this information from does not list the designations of contributions, it is understandable that he was concerned about these contributions being over the \$1000 individual donation limit per election cycle.

Enclosed please find copies of the contributions in question from the FEC reports filed for those reporting periods. I trust that this information will address Mr. Lemanager's concerns.
