III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Timely File 48-Hour Reports)

MAD DOG PAC (“the Committee”) failed to timely file three (3) 48-Hour Reports totaling \$38,401.29 to support fifteen (15) independent expenditures disclosed on the 2020 October Quarterly Report, made up to and including the 20th day before the 2020 General Election (Attachment 2).

On October 15, 2020, the Committee filed its 2020 October Quarterly Report, covering the period from July 1, 2020, through September 30, 2020. The report included a Schedule E (Itemized Independent Expenditures) disclosing twenty-one (21) independent expenditures totaling \$49,888.07, made in opposition to three (3) federal candidates (Images 202010159295161560-70).

On December 9, 2020, a Request for Additional Information (RFAI) was sent to the Committee referencing the 2020 October Quarterly Report. The RFAI noted that the

Committee may have failed to file one (1) or more of the required 48-Hour Reports regarding independent expenditures. A chart was included with the RFAI identifying fifteen (15) independent expenditures, totaling \$38,401.29, for which a 48-Hour Report had not been filed (Images 202012090300095264-66)¹.

On February 24, 2021, the Reports Analysis Division (RAD) Analyst called Erin Geylin, a representative of the Committee, and explained the Committee had failed to respond to the RFAI sent on their 2020 October Quarterly Report regarding missing 48-Hour Reports (Attachment 3).

On February 25, 2021, Blair Schuman, a representative of the Committee, called the RAD Analyst regarding the RFAI referencing the 2020 October Quarterly Report. The Analyst advised Mr. Schuman that the Committee should file the missing 48-Hour Reports as soon as possible (Attachment 3).

On the same day, the Committee filed a 48-Hour Report that disclosed three (3) independent expenditures totaling \$5,198.46, disseminated on July 1, 2020, July 9, 2020, and July 10, 2020 that were questioned in the December 9, 2020 RFAI (Images 202102259429061048-49).

On February 26, 2021, the Committee filed ten (10) 48-Hour Reports that disclosed twelve (12) independent expenditures totaling \$33,202.83, disseminated on July 25, 2020, August 1, 2020, August 5, 2020, August 21, 2020, August 24, 2020, August 25, 2020, August 26, 2020, September 1, 2020, September 6, 2020, and September 16, 2020 that were also questioned in the December 9, 2020 RFAI (Images 202102269429061058-67).

On the same day, the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission) in response to the RFAI referencing the 2020 October Quarterly Report. The Committee stated:

“This is in response to the Commission's Requests for Additional Information dated September 15, 2020, December 9, 2020, December 23, 2020, and February 9, 2021. The 48 Hour Reports and 24 Hour Reports listed in the cited letters have now been correctly filed to more accurately reflect the public record” (Image 202102269429061070).

Also, on the same day, Mr. Schuman called the RAD Analyst and stated the Committee had filed all missing 48-Hour Reports (Attachment 3).

On March 16, 2021, the RAD Analyst attempted to call Claude Taylor, the Committee Treasurer, to discuss the outstanding issues on the 2020 October Quarterly Report. The Analyst then called Mr. Schuman, the most recent point of contact for the Committee, and left a message stating that the Committee's 48-Hour Reports had been received; however, the issue may be referred to another Commission office for potential

further action. The Analyst stated that the Committee may file another FEC Form 99 if they wished to provide any further clarification for the public record (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
