III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Disclose All Financial Activity)

League of Southeastern Credit Unions Federal PAC (“the Committee”) amended its 2020 October Quarterly Report to disclose additional disbursements totaling \$54,846.16, which were not disclosed on the original report (Attachment 2).

On October 15, 2020, the Committee filed the original 2020 October Quarterly Report covering the period from July 1, 2020 through September 30, 2020. The report disclosed \$20.00 in disbursements on Line 21(b) (Other Federal Operating Expenditures) and \$163.84 in disbursements on Line 29 (Other Disbursements (Including Non-Federal Donations)) of the Detailed Summary Page (Image 202010159293983940).

On December 2, 2020, the Committee filed an Amended 2020 October Quarterly Report. The Report disclosed \$20.00 on Line 21(b), \$50,000.00 on Line 22 (Transfers to Affiliated/Other Party Committees), and \$10.00 on Line 29 of the Detailed Summary Page, an increase of \$49,846.16 in total disbursements that were not disclosed in the original report (Image 202012029337450160).

On December 3, 2020, the Committee filed an additional Amended 2020 October Quarterly Report, which disclosed \$20.00 on Line 21(b), \$50,000.00 on Line 22, \$5,000.00 on Line 23 (Contributions to Federal Candidate/Committees and Other Political Committees), and \$10.00 on Line 29 of the Detailed Summary Page, an increase of \$54,846.16 in total disbursements that were not disclosed in the original report (Image 202012039338325339).

On January 5, 2021, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2020 October Quarterly Report, received December 3, 2020. The RFAI requested clarification regarding the substantial increase in disbursements disclosed on the Amended 2020 October Quarterly Report (Images 202101050300100025-26).

On January 27, 2021, Blake Westbrook, a representative of the Committee, called the Reports Analysis Division (RAD) Analyst regarding the RFAI. Among other items, Mr. Westbrook asked how the Committee could adequately respond to the RFAI. The Analyst stated that the Committee could respond by submitting an FEC Form 99 (Miscellaneous Electronic Submission) providing clarification for the public record as to why the disbursements were not reported on the original 2020 October Quarterly Report (Attachment 3).

Later that same day, Mr. Westbrook called the RAD Analyst again to get a better understanding of the amount of increase that was questioned in the RFAI. The Analyst explained that the difference was calculated from the amount reported on the original to the amount reported on the amendment. Mr. Westbrook stated that the Committee would file an FEC Form 99 to explain the discrepancy for the public record (Attachment 3).

Also, on January 27, 2021, the Committee filed an FEC Form 99, which stated:

“In response to the FEC's request for more information on the Amended October Quarterly Report (07/01/2020 - 09/30/2020), the League of Southeastern Credit Unions Federal PAC offers the following response:

The 2020 October Quarterly Report was amended to include the following items that were left off the original report:

- \$50,000 transfer to our connected PAC CULAC
- \$5,000 contribution to Tommy Tuberville for Senate Campaign” (Image 202101279413445953).

On January 29, 2021, the Committee filed an Amended 2020 October Quarterly Report, which disclosed no changes in total disbursements from the previous amendment (Image 202101299417659663).

On March 1, 2021, the RAD Analyst called Mr. Westbrook to inform the Committee that the issue on their Amended October Quarterly Report may be referred to another Commission office for potential further action and advised the Committee could submit an additional FEC Form 99 to provide further clarification for the public record (Attachment 3).

On April 8, 2021, the Committee filed an Amended 2020 October Quarterly Report. The report disclosed no changes in total disbursements from the previous amendment (Image 202104089443138089).

To date, no further communications have been received from the Committee regarding this matter.
