III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Timely File 24-Hour and 48-Hour Reports)

Stronger Foundations, Inc. (“the Committee”) failed to timely file one (1) 48-Hour Report supporting four (4) independent expenditures totaling \$121,074.00 disclosed on the 2020 July Quarterly Report, made up to and including the 20th day before the 2020 Primary Election held in the state of New Jersey and the 2020 General Election. Additionally, the Committee failed to timely file one (1) 24-Hour Report supporting one (1) independent expenditure totaling \$10,500.00 disclosed on the 2020 July Quarterly Report, made after the 20th day but no more than 24 hours before the day of the 2020 Primary Election held in the state of New Jersey (Attachment 2).

On October 14, 2020, the Committee filed its 2020 July Quarterly Report, covering the period from April 1, 2020 through June 30, 2020. The report included a Schedule E

(Itemized Independent Expenditures) disclosing five (5) independent expenditures, totaling \$131,574.00, made in support of one (1) Federal candidate. The Committee failed to file one (1) 48-Hour Report to support four (4) independent expenditures, totaling \$121,074.00, and failed to file one (1) 24-Hour Report to support one (1) independent expenditure, totaling \$10,500.00, for the 2020 Primary Election held in the state of New Jersey and 2020 General Election (Images 202010149285842376-78).

On January 25, 2021, a Request for Additional Information (RFAI) was sent to the Committee referencing the 2020 July Quarterly Report. Among other items, the RFAI noted that the Committee may have failed to file one (1) or more of the required 24-Hour and 48-Hour Reports for independent expenditures disclosed in the report. A chart was included with the RFAI identifying four (4) independent expenditures, totaling \$121,074.00, for which one (1) or more of the required 48-Hour Reports had not been filed, and one (1) independent expenditure, totaling \$10,500.00, for which one (1) required 24-Hour Report had not been filed (Images 202101250300101814-19).

On March 1, 2021, Steve Kleinman, the Committee's attorney, called the Reports Analysis Division (RAD) Analyst in response to the RFAI sent January 25, 2021. He wanted to know if the 24- and 48-Hour Reports were still required and the Analyst confirmed they were (Attachment 3).

On the same date, the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission), which stated, in part:

“With respect to the claimed failure to file the various 48 and 24 hour reports, it is important to understand that these events occurred at the height of the COVID-19 pandemic, which during the relevant time period was particularly devastating in New Jersey, where Stronger is based. In February 2020, Stronger filed its FEC Form 1, which was mailed to your offices via USPS on February 24, 2020. Stronger's representatives confirmed the FEC's receipt of this form on March 2, 2020³. Shortly thereafter, the FEC closed its offices to the public for health and safety reasons and transitioned to remote operations. As such, Stronger did not receive confirmation from the FEC accepting this filing and providing for electronic filing of reports. Stronger's representatives contacted the FEC multiple times by telephone for guidance on filing reports in the absence of this confirmation and was informed to simply maintain its records for submission once its committee number had been assigned and a PIN issued so that all required reports could be filed on-line. Finally, on October 2, 2020, Stronger's Treasurer, working with the FEC's technical support staff, was able to obtain the necessary information to be able to electronically file all outstanding reports, and did so very shortly thereafter. This is reflected on Stronger's FEC Form 1 filing, signed by Treasurer Andrew DiPalma on October 6, 2020, which contains the

following representation: As per conversations with FEC staff, we have been trying to receive our new committee # since it was received by the FEC by mail on 3/2/2020. Given the work from home issues caused by the COVID-19 pandemic we did not receive a new number but were advised by phone our paperwork was received. After several calls, tech support has opened the old committee and advised us to refile - which we are doing. Of course, at that point, the election for which the 48 and 24 hour reports were

due, the New Jersey primary election originally scheduled for June 2, 2020 but moved by Executive Order of Governor Phillip D. Murphy to July 7, 2020, had long past. As such, it appeared superfluous to file these reports considering all of the required information was included in the April 2020 and July 2020 Quarterly Reports. Nonetheless, based on my conversation with you earlier today, Stronger is filing the requested 48 and 24 hour reports so that the record is complete. However, by filing these reports, Stronger is not conceding that it violated the FECA or its associated regulations for the reasons I have explained. Alternatively, while understanding that the FEC does not have the statutory authority to extend filing deadlines, Stronger respectfully requests that the FEC exercise its discretion not to pursue administrative fines against it as it was prevented from filing by reasonably unforeseen circumstances beyond its control. To the extent that further documentation may be required, Stronger is prepared to submit affidavits or other proof of the representations made above” (Images 202103019431309977-79).

On March 2, 2021, Mr. Kleinman called to confirm receipt of its FEC Form 99. The RAD Analyst confirmed the Commission had received the FEC Form 99 on March 1, 2021. Mr. Kleinman stated that the Committee had experienced difficulties and was unable to file the missing 48-Hour Report. The Analyst offered guidance and Mr. Kleinman said he would put the Analyst in contact with the person who files the Committee’s reports (Attachment 3).

Later the same day, Mr. Kleinman called and informed the RAD Analyst that the person who prepares and files the Committee’s reports was unavailable. The Analyst provided a convenient timeframe for a discussion the following day (Attachment 3).

On March 3, 2021, Mr. Kleinman and Kathleen Donahue, the Committee’s Compliance Officer, called the RAD Analyst. Ms. Donahue stated that she was quite familiar with filing 24- and 48-Hour Reports and wanted to know the applicable election for the required 48-Hour Reports cited in the RFAI. The Analyst told her that the 48-Hour Reports were for the 2020 Primary and General Elections. She assured the Analyst that the missing reports would be promptly filed. Mr. Kleinman also stated that he would address the correspondence received from the Commission (Attachment 3).

Later on the same date, Ms. Donahue called with questions about filing via the FECFile software. The Analyst provided instructions for filing the Committee’s 24- and 48-Hour Reports in FECFile (Attachment 3).

Subsequently, on March 3, 2021, the Committee filed one (1) 48-Hour Report to support four (4) independent expenditures, totaling \$127,324.00, disseminated on March 30, 2020, June 3, 2020, and June 30, 2020 (Images 202103039440053496-98), and one (1) 24-Hour Report to support one (1) independent expenditure, totaling \$10,500.00, disseminated on June 3, 2020 (Images 202103039440053500).

On March 10, 2021, the Analyst spoke with Mr. Kleinman about the apparent violations referenced in the RFAI and informed him that the matter could be referred to another Commission office for potential further action. The Analyst advised that the Committee had the option to provide additional information on the public record via an FEC Form 99. Mr. Kleinman stated that he was aware of the potential referral and would respond to all correspondence received by the Committee (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.


