III. BACKGROUND:

**Failure to Provide Supporting Schedules (Failure to Timely File 48-Hour Reports)**

Stop Socialism Now PAC (“the Committee”) failed to timely file one (1) 48-Hour Report totaling \$64,047.50 to support two (2) independent expenditures disclosed on the 2020 12-Day Pre-Runoff Report, made up to and including the 20<sup>th</sup> day before the 2021 Special Runoff Election held in the state of Georgia (Attachment 2).

On December 23, 2020, the Committee filed its 2020 12-Day Pre-Runoff Report, covering the period from November 24, 2020 through December 16, 2020. The report included a Schedule E (Itemized Independent Expenditures) disclosing three (3) independent expenditures totaling \$70,095.00 made in support of or opposition to three (3) federal candidates (Images 202012239393802425-26).

On March 31, 2021, a Request for Additional Information (RFAI) was sent to the Committee referencing the 2020 12-Day Pre-Runoff Report. The RFAI noted that the Committee may have failed to file one (1) or more of the required 48-Hour Reports regarding independent expenditures. A chart was included with the RFAI identifying three

(3) independent expenditures, totaling \$70,095.00, for which a 48-Hour Report had not been filed (Images 202103310300114106-08).

On April 1, 2021, Jason Boles, the Committee's Treasurer, called the Reports Analysis Division (RAD) Analyst regarding the RFAI referencing the Committee's 2020 12-Day Pre-Runoff Report. Mr. Boles stated the Committee would respond to the RFAI by the response due date. The Analyst explained the issue was time sensitive and may be referred to another Commission office for potential further action (Attachment 3).

On April 12, 2021, the Committee filed two (2) 48-Hour Reports to support three (3) independent expenditures, totaling \$70,095.00, disseminated on December 4, 2020 and December 14, 2020 (Images 202104129443247677-78).

On the same date, the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission) in response to the RFAI referencing the 2020 12-Day Pre-Runoff Report which stated, in part:

“We recognize an oversight in the referenced 48-hour Report(s) triggered by the aggregate for the election even though we did properly schedule the disbursements on the regularly filed report. We have filed the proper 48-hour report(s) to correct the oversight” (Image 202104129443247684).

On May 10, 2021, the RAD Analyst called Mr. Boles and explained the Committee may be referred to another Commission office for potential further action for failing to timely file the required 48-Hour Report. The Analyst stated the Committee could provide further clarification on the public record via an FEC Form 99 (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
