III. BACKGROUND:

Excessive, Prohibited and Other Impermissible Contributions (Failure to Refund, Redesignate, or Reattribute Excessive and Prohibited Contributions within the Permissible Timeframe)

GARRET GRAVES FOR CONGRESS (“the Committee”) received excessive and prohibited contributions totaling \$35,800.00, for the 2020 Primary and 2020 General Election, from nine (9) individuals and nine (9) limited liability companies (LLCs). Of this amount, the Committee refunded \$35,000.00 outside of the permissible timeframe, and \$800.00 remains unremedied (Attachment 2).

2019 October Quarterly Report

During the 2019 October Quarterly reporting period, July 1, 2019 through September 30, 2019, the Committee received excessive and prohibited contributions totaling \$850.00 from one (1) individual and one (1) limited liability company (LLC) that

were not refunded, reattributed, or redesignated within the permissible timeframe (Image 201910159164229931, Attachment 2).

On January 20, 2020, a Request for Additional Information (“RFAI”) referencing the 2019 October Quarterly Report was sent to the Committee. The RFAI noted the Committee’s receipt of apparent excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 202001200300053600).

On February 24, 2020, the Committee filed an Amended 2019 October Quarterly Report (Image 202002249203317671) and an FEC Form 99 (Miscellaneous Electronic Submission) in response to the RFAI referencing the 2019 October Quarterly Report. The Form 99 stated, in part:

“First, four of the contributor’s contributions listed in the attachment to the Commission’s letter that appear to exceed federal limits have either been properly redesignated within the appropriate timeframe or the Committee has corrected their election designations. These redesignations and corrections will be shown on the appropriate Amended reports being filed concurrently with this response. One of the contributor’s contributions has been refunded and the contribution refund will appear on the appropriate report.

Second, our Committee has safeguards in place to ensure that all contributions are made by eligible contributors only. Two of the contributions listed on the attachment to the Commission’s letter were made with federally permissible funds. Partnership or sole proprietor attributions have been included on the Amended report being filed concurrently with this response. The remaining contribution listed on the attachment to the Commission’s letter has been refunded and the contribution refunds will be disclosed on the appropriate report” (Image 202002249203317916).

2019 Year-End Report

During the 2019 Year-End reporting period, October 1, 2019 through December 31, 2019, the Committee received prohibited contributions totaling \$7,800.00 from two (2) limited liability companies (LLCs) that were not refunded within the permissible timeframe (Image 202004159219623858, Attachment 2).

On October 1, 2020, an RFAI referencing the Amended 2019 Year-End Report, received April 15, 2020, was sent to the Committee. The RFAI noted the Committee’s receipt of apparent excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 202010010300087342).

On November 5, 2020, the Committee filed an Amended 2019 Year-End Report (Image 202011059336970698) and an FEC Form 99 in response to the RFAI referencing the 2019 Year-End Report. The Form 99 stated, in part:

“This statement is in response to the Commission's letter dated October 1, 2020 regarding two items. First, as is noted in the Commission's letter, two of the referenced contributors were refunded. (See the Committee's April Quarterly Report TRANS ID SB20A.34966 and TRANS ID SB20A.34972). Second, the referenced individual contributor's excessive contribution was properly redesignated within the appropriate timeframe. The redesignation will appear on the Committee's Amended Year End Report being filed concurrently with this response. Please feel free to contact us if you have any further questions” (Image 202011059336970696).

2020 October Quarterly Report

During the 2020 October Quarterly reporting period, July 5, 2020 through September 30, 2020, the Committee received excessive and prohibited contributions totaling \$23,450.00 from seven (7) individuals and three (3) limited liability companies (LLCs) that were not refunded, reattributed, or redesignated within the permissible timeframe (Image 202010159295861991, Attachment 2).

On December 13, 2020, an RFAI referencing the 2020 October Quarterly Report was sent to the Committee. The RFAI noted the Committee's receipt of excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 202012130300095488).

On January 19, 2021, the Committee filed an Amended 2020 October Quarterly Report (Image 202101199405236364) and an FEC Form 99 in response to the RFAI referencing the 2020 October Quarterly Report. The Form 99 stated, in part:

“First, seven of the referenced contributors have been refunded and those contribution refunds will appear either on the Committee's 2020 Year End Report or the 2021 April Quarterly Report. Second, three of the contributions from LLCs (limited liability companies) or business entities were refunded. Those contribution refunds will appear on the Committee's 2021 April Quarterly Report. One of the contributions from LLCs or business entities were made with federally permissible funds and the respective attributions are provided on the Amended report. One contribution was from an individual and not a business entity. The contributor information will be clarified on the Amended report. Please feel free to contact us if you have any further questions” (Image 202101199405236539).

2020 12-Day Pre-General Report

During the 2020 12-Day Pre-General reporting period, October 1, 2020 through October 14, 2020, the Committee received an excessive and prohibited contribution totaling \$200.00 from one (1) individual that was not refunded, reattributed, or redesignated within the permissible timeframe (Image 202010229336386002, Attachment 2).

On December 13, 2020, an RFAI referencing the 2020 12-Day Pre-General Report was sent to the Committee. The RFAI noted the Committee's receipt of apparent excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 202012130300095493).

On January 19, 2021, the Committee filed an Amended 2020 12-Day Pre-General Report (Image 202101199405236510) and an FEC Form 99 in response to the RFAI referencing the 2020 12-Day Pre-General Report. The Form 99 stated, in part:

"First, two of the referenced contributors have been refunded and those contribution refunds will appear on the Committee's 2020 Year-End Report. Second, with respect to the non-federal committee listed, our Committee has safeguards in place to ensure that this committee used federally permissible funds for its contribution. The referenced contributor confirmed to the Committee that it used federally permissible funds for its contribution. Please feel free to contact us if you have any further questions" (Image 202101199405236545).

2020 30-Day Post-General Report

During the 2020 30-Day Post-General reporting period, October 15, 2020 through November 23, 2020, the Committee received prohibited contributions totaling \$3,500.00 from three (3) limited liability companies (LLCs) that were not refunded, reattributed, or redesignated within the permissible timeframe (Image 202012039341230983, Attachment 2).

On January 13, 2021, an RFAI referencing the 2020 30-Day Post-General Report was sent to the Committee. The RFAI noted the Committee's receipt of apparent excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 202101130300100856).

On February 17, 2021, the Committee filed an Amended 2020 30-Day Post-General Report (Image 202102179428290856) and an FEC Form 99 in response to the RFAI referencing the 2020 30-Day Post-General Report. The Form 99 stated, in part:

"First, one of the referenced contributor's excessive contributions was reattributed to a spouse. The reattribution will appear on the Committee's Amended Post-General Report. The other contributor's excessive contribution was partially reattributed to a spouse with the rest refunded. The reattribution will appear on the Committee's Amended Post-Report and the refund will appear on the Committee's 2021 April Quarterly Report.

Second, the contributions from LLCs (limited liability companies) were refunded. Those contribution refunds will appear on the Committee's 2021 April Quarterly Report. Third, with respect to the non-federal committees listed, our Committee has safeguards in place to ensure that these committees used federally permissible funds for their contributions. The referenced contributors confirmed to the Committee that they used federally permissible funds for their contributions” (Image 202102179428290821).

On February 23, 2021, the Reports Analysis Division (RAD) Analyst spoke with Jimmy Marchant, a representative of the Committee, to inform him the Committee could potentially be referred to another Commission office for further action due to excessive and prohibited contributions not refunded within the permissible timeframe. Mr. Marchant stated he would be providing additional remedies during the next reporting period (Attachment 3).

On May 4, 2021, the RAD Analyst spoke with Mr. Marchant again to inform him the Committee would be referred to another Commission office for further action due to excessive and prohibited contribution not refunded within the permissible timeframe. The Analyst confirmed that the Committee disclosed remedies during the 2021 April Quarterly period for some excessive and prohibited contributions, but many were remedied outside the permissible timeframe. The Analyst stated that the Committee could file an FEC Form 99 if there was further information to disclose about the excessive and prohibited contributions (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter (Attachment 3).
