III. BACKGROUND:

Other Violations of the Federal Election Campaign Act (Unauthorized Use of Campaign Funds)

Kern County Republican Central Committee (Fed) (“the Committee”) filed its 2019 Mid-Year Report to disclose the refund of apparent unauthorized disbursements totaling \$218,546.39 (Attachment 2).

On July 31, 2019, the Committee filed its 2019 Mid-Year Report, covering the period from March 1, 2019 through June 30, 2019. The report disclosed two (2) receipts from “Williams, Bryan” totaling \$218,546.39 on Schedule A, supporting Line 17 (Other Federal Receipts) with a transaction description of “Refund of disputed payments” (Image 201907319161327033, Attachment 2).

On November 7, 2019, a Request for Additional Information (RFAI) was sent to the Committee referencing the 2019 Mid-Year Report. Among other items, the RFAI requested clarification regarding the refund of previously unreported contributions disclosed on the report¹ (Image 201911070300050916).

On December 19, 2019, the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission) in response to the RFAI referencing the 2019 Mid-Year Report. The Committee stated:

“We would like to ask for an extension to the deadline of December 12, 2019 to respond to the RFAI issued November 7, 2019 for the mid-year report” (Image 201912199166422153).

On January 21, 2020, the Reports Analyst Division (RAD) Analyst called Mr. Montgomery, the Committee’s contact at the time, and received his voice mailbox. The Analyst left a message requesting a return phone call (Attachment 3).

On January 22, 2020, the RAD Analyst called Mr. Montgomery again and detailed the issue that needed to be addressed, explaining that the matter could be referred to another office at the Commission for potential further action. The Analyst left a message requesting a return phone call. Later, the Analyst received a call from Mr. Montgomery informing them that the Committee’s Counsel would be calling to provide an update (Attachment 3).

Also on January 22, 2020, Charles Bell, the Committee’s Counsel, called the Analyst to discuss the RFAI sent on the 2019 Mid-Year Report. He explained that the Committee had become aware of funds embezzled by a former staffer. Mr. Bell stated he was not aware of the total amount but explained that the Committee had contacted law enforcement. The Analyst informed Mr. Bell that they would be in touch with the appropriate next steps (Attachment 3).

On January 29, 2020, the RAD Analyst called Mr. Bell and asked that he submit an FEC Form 99 explaining the situation as soon as possible. Mr. Bell offered some additional details about the situation, including that the unauthorized use of funds was done by an internal source and that the Committee has implemented new internal controls based on FEC best practices. The Analyst asked that these details be included in the FEC Form 99 (Attachment 3).

¹ This Request for Additional Information was sent for a separate issue than the one included in this referral. The Committee’s response to the RFAI indicated the unauthorized disbursement of Committee funds, which prompted an additional RFAI to be sent on this report.

On January 31, 2020, the RAD Analyst called Mr. Bell and received his voice mailbox. The Analyst left a message requesting a return phone call. Later, on the same day, Mr. Bell returned the RAD Analyst's call and the Analyst informed Mr. Bell that he should contact the Office of General Counsel (OGC) if he wished to make a *sua sponte* submission. The Analyst provided the contact information for OGC (Attachment 3).

On April 7, 2020, the RAD Analyst called Mr. Bell to ask for an update and to confirm that he had spoken with OGC, as no FEC Form 99 had been submitted. Mr. Bell confirmed that he had not and that he had instead been working on assessing the full scope of the embezzlement. The Analyst instructed him to file a FEC Form 99 as soon as possible and to reach out to OGC (Attachment 3).

On April 15, 2020, the Committee filed an additional FEC Form 99 in response to the RFAI referencing the 2019 Mid-Year Report. The Committee stated:

“In response to the Commission’s RFAI, dated November 9, 2019, item 1, the committee’s 2019 Mid-Year Report discloses two refunds from its former treasurer for funds embezzled from the committee. Upon discovery of the former treasurer’s activity, the committee dismissed him, appointed a new treasurer, closed its existing committee bank accounts and opened new bank accounts, and sought and obtained a refund of a substantial amount from the former treasurer. The committee also modified its procedures to comply in a fulsome manner with the FEC’s best practices for management of its accounts. The committee also referred the matter to law enforcement authorities. We are awaiting additional information on the findings of the law enforcement investigation to provide guidance as to any further extent of the treasurer’s activity and whether further restitution will be needed” (Image 202004159219365497).

On April 20, 2020, the RAD Analyst called Mr. Bell and received his voice mailbox. The Analyst left a message asking for a return phone call. Later on the same day, Mr. Bell returned the RAD Analyst's call and the Analyst informed him that the FEC had received the FEC Form 99 he submitted, that the matter could be referred to another office at the Commission for potential further action, and to remind him that he could still self-report to OGC. Mr. Bell indicated that he would (Attachment 3).

Also, on April 20, 2020, an RFAI was sent to the Committee referencing the 2019 Mid-Year Report. The RFAI requested clarification regarding the apparent unauthorized use of committee funds disclosed on the report (Image 202004200300064091).

To date, no further communications have been received from the Committee regarding this matter.
