III. BACKGROUND:

**Excessive, Prohibited and Other Impermissible Contributions (Failure to Refund, Redesignate, or Reattribute Excessive and Prohibited Contributions within the Permissible Timeframe)**

Nancy Mace for Congress (“the Committee”) received excessive and prohibited contributions totaling \$58,200.00 for the 2020 Primary and General Elections from twenty-four (24) individuals, nine (9) limited liability companies (LLC), eight (8) corporations, and one (1) unregistered organization. The Committee refunded these contributions outside of the permissible timeframe (Attachment 2).

### **Amended 2019 July Quarterly Report, Received August 23, 2019**

During the 2019 July Quarterly reporting period, covering June 1, 2019 through June 30, 2019, the Committee received prohibited contributions totaling \$9,250.00 from seven (7) corporations and two (2) LLCs that were not refunded within the permissible timeframe (Image 201908239163101059, Attachment 2).

On August 29, 2019, a Request for Additional Information (RFAI) referencing the Amended 2019 July Quarterly Report was sent to the Committee. The RFAI noted the Committee's receipt of apparent prohibited contributions, among other items, and requested the Committee provide clarification or remedy the contributions cited (Images 201908290300047232-38).

On September 6, 2019, the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission) in response to the RFAI referencing the Amended 2019 July Quarterly Report. The Committee stated, in part:

“[T]he contributions in question from business entities have been a subject of research since the contributions were received. We were not able to verify that these contributions were from non-corporate funds and as such they have been refunded. These refunds will be reflected on our upcoming October Quarterly Report” (Image 201909069163155868).

On October 15, 2019, the Committee filed its 2019 October Quarterly Report (Image 201910159163966862). The report disclosed refunds totaling \$9,250.00 received from seven (7) corporations and two (2) LLCs that were made outside of the permissible timeframe.

### **2020 July Quarterly Report**

During the 2020 July Quarterly reporting period, covering May 21, 2020 through June 30, 2020, the Committee received excessive contributions totaling \$10,000.00 from three (3) individuals that were not refunded, reattributed, or redesignated within the permissible timeframe (Image 202007159244997845, Attachment 2).

On August 16, 2020, an RFAI referencing the 2020 July Quarterly Report was sent to the Committee. The RFAI noted the Committee's receipt of apparent excessive contributions, among other items, and requested the Committee provide clarification or remedy the contributions cited (Images 202008160300082888-95).

On September 21, 2020, the Committee filed an Amended 2020 July Quarterly Report. The report included memo text referencing the Committee's corrective action that stated, in part:

“When our committee receives a contribution that exceeds a donors contribution limit, we attempt to reattribute the excess funds to the donor's spouse, where applicable. If the donor does not respond to the reattribution request within the 60-day window allowed by the FEC, the excess funds are refunded. The excessive donations listed on the RFAI for this report have all been addressed either on this amended report or will be addressed on our next regular filing” (Image 202009219284469461).

On October 15, 2020, the Committee filed a 2020 October Quarterly Report (Image 202010159294767218). The report disclosed a refund of \$2,800.00 to one (1) individual made outside of the permissible timeframe.

On October 22, 2020, the Committee filed a 12-Day Pre-General Report (Image 202010229332960324). The report disclosed refunds totaling \$7,200.00 to two (2) individuals made outside of the permissible timeframe.

## **2020 October Quarterly Report**

During the 2020 October Quarterly reporting period, covering July 1, 2020 through September 30, 2020, the Committee received excessive and prohibited contributions totaling \$28,000.00 from sixteen (16) individuals, five (5) LLCs and one (1) unregistered organization that were not refunded, reattributed, or redesignated within the permissible timeframe (Image 202010159294767218, Attachment 2).

On November 2, 2020, an RFAI referencing the 2020 October Quarterly Report was sent to the Committee. The RFAI noted the Committee's receipt of apparent excessive and prohibited contributions, among other items, and requested the Committee provide clarification or remedy the contributions cited (Images 202011020300090849-57).

On October 22, 2020, the Committee filed a 12-Day Pre-General Report (Image 202010229332960324). The report disclosed refunds totaling \$8,000.00 to three (3) individuals and three (3) LLCs that were made outside of the permissible timeframe.

On December 7, 2020, the Committee filed an Amended 2020 October Quarterly Report. The report included memo text referencing the Committee's corrective action that stated, in part:

“When our committee receives a contribution that exceeds a donors contribution limit, we attempt to reattribute the excess funds to the donors spouse, where applicable., if the donor does not respond to the reattribution request within the 60-day window allowed by the FEC, the excess funds are refunded. The excessive donations listed on the RFAI for James Davis, Neil Johnson and Mark Keller were all refunded and included on the Pre-General Report... The remaining excessive donations will be resolved on the upcoming Year End Report....The remaining LLC contributions have been refunded on the recent filed pre-general report, or will be addressed on the

Year End report....The refund of the South Carolina Association of Nurse Anesthetists contribution will be addressed on the upcoming Year End Report" (Image 202012079366419589).

On April 15, 2021, the Committee filed a 2021 April Quarterly Report (Image 202104159443550872). The report disclosed refunds totaling \$20,000.00 to thirteen (13) individuals, two (2) LLCs, and one (1) unregistered organization that were made outside of the permissible timeframe.

### **2020 12-Day Pre-General Report**

During the 2020 12-Day Pre-General reporting period, covering October 1, 2020 through October 14, 2020, the Committee received excessive contributions totaling \$10,950.00 from five (5) individuals, two (2) LLCs and one (1) corporation that were not refunded, reattributed, or redesignated within the permissible timeframe (Image 202010229332960324, Attachment 2).

On November 2, 2020, an RFAI referencing the 2020 12-Day Pre-General Report was sent to the Committee. The RFAI noted the Committee's receipt of apparent excessive and prohibited contributions, among other items, and requested the Committee provide clarification or remedy the contributions cited (Images 202011020300090858-64).

On December 7, 2020, the Committee filed an Amended 2020 12-Day Pre-General Report. The report included memo text referencing the Committee's corrective action that stated, in part:

"When our committee receives a contribution that exceeds a donors contribution limit, we attempt to reattribute the excess funds to the donors spouse, where applicable., If the donor does not respond to the reattribution request within the 60-day window allowed by the FEC, the excess funds are refunded. The excessive donations listed on the RFAI for this report will be resolved on the upcoming Year End report.... The remaining LLC contributions have been refunded on the recent filed Pre-General report, or will be addressed on the Year End report" (Image 202012079366421618).

On February 11, 2021, the Reports Analysis Division (RAD) Analyst contacted Paul Kilgore, the Committee's Treasurer, to notify him that the unresolved and late remedied excessive and prohibited contributions identified during the cycle may be referred to another Commission office for further action (Attachment 3).

On April 15, 2021, the Committee filed a 2021 April Quarterly Report (Image 202104159443550872). The report disclosed refunds totaling \$10,900.00 of four (4) individuals, two (2) LLCs, and one (1) corporation cited on the 12-Day Pre-General Report.

On June 18, 2021, the Committee filed an Amended 2020 July Quarterly Report to provide memo text that stated, in part:

“Additionally, the excessive General 2020 refund for Bruce Mills in the amount of \$50 was refunded to the donor on 3/31/2020. However, due to itemization threshold limits, this refund did not itemize on our 2021 April Quarterly Report” (Image 202106189449473981).

From June 2021 to November 2021, the RAD Analyst coordinated with Mr. Kilgore and his colleague, Megan Brown, on how best to provide additional clarification and disclose remedies for the contributions in question (Attachment 3).

On November 23, 2021, the Committee filed an Amended 2020 April Quarterly Report to provide memo text that stated, in part: “We incorrectly stated that the refund to Bruce Mills in the amount of \$50 was dated 3/31/2020. This refund was issued on 3/31/2021” (Image 202111239468906041).

To date, no further communications have been received from the Committee regarding this matter.
