III. BACKGROUND:

Independent Expenditure Reporting Problems – Persons Other Than Political Committees (Form 5) (Failure to Timely File 24-Hour Reports)

AMERICAN FEDERATION OF STATE COUNTY AND MUNICIPAL EMPLOYEES AFL-CIO (“AFSCME”) failed to file and timely file three (3) 24-Hour Reports to support forty-three (43) independent expenditures totaling \$27,162.89 disclosed in the 2020 Year-End Report, that were made after the 20th day but more than 24 hours before the 2020 General Election (Attachment 2).

On October 16, 2020, AFSCME filed one (1) 24-Hour Report disclosing fourteen (14) independent expenditures totaling \$1,783,961.13, disseminated on October 15 and 16, 2020 (Images 202010169296999899-904).

On October 17, 2020 AFSCME filed one (1) 24-Hour Report² disclosing five (5) independent expenditures totaling \$17,937.50, disseminated on October 16, 2020 (Images 202010179297145249-51).

On October 18, 2020 AFSCME filed one (1) 24-Hour Report³ disclosing one (1) independent expenditure totaling \$168,498.50, disseminated on October 17, 2020 (Image 202010189297151993).

On October 19, 2020, AFSCME filed one (1) 24-Hour Report disclosing two (2) independent expenditures totaling \$189,053.67, disseminated on October 18, 2020 (Images 202010199297280973-74).

On October 20, 2020, AFSCME filed one (1) 24-Hour Report disclosing twelve (12) independent expenditures totaling \$1,029,388.87, disseminated on October 19, 2020 (Images 202010209297802038-42).

On October 21, 2020, AFSCME filed one (1) 24-Hour Report disclosing twenty (20) independent expenditures totaling \$231,000.49, disseminated on October 20, 2020 (Images 202010219326761654-61).

On October 22, 2020, AFSCME filed one (1) 24-Hour Report disclosing one (1) independent expenditure totaling \$36,711.28, disseminated on October 21, 2020 (Images 202010229335436904-05).

On October 23, 2020, AFSCME filed one (1) 24-Hour Report disclosing six (6) independent expenditures totaling \$69,949.07, disseminated on October 22 and 23, 2020 (Images 202010239336502767-69).

On October 27, 2020, AFSCME filed one (1) 24-Hour Report disclosing three (3) independent expenditures totaling \$21,180.00, disseminated on October 26, 2020 (Images 202010279336592213-14).

On October 28, 2020, AFSCME filed one (1) 24-Hour Report disclosing five (5) independent expenditures totaling \$845,078.02, disseminated on October 27, 2020 (Images 202010289336631439-41).

On October 29, 2020, AFSCME filed one (1) 24-Hour Report disclosing two (2) independent expenditures totaling \$50,494.89, disseminated on October 28, 2020 (Images 202010299336667047-48).

On January 29, 2021, AFSCME filed a 2020 Year-End Report covering the period from October 1, 2020 through December 31, 2020. Schedule 5-E (Itemized Independent Expenditures) of the report disclosed one hundred forty-six (146) independent expenditures

totaling \$6,963,908.18 made in support of or opposition to thirty-nine (39) candidates for federal office (Images 202101299413968515-65).

On April 13, 2021, a Request for Additional Information (RFAI) was sent to AFSCME referencing the 2020 Year-End Report. Among other items, the RFAI noted AFSCME may have failed to file 24-Hour Reports for forty-three (43) of the independent expenditures disclosed on Schedule 5-E (Images 202104130300115535-40).

On April 15, 2021, Claudia Wingfield, the individual responsible for preparing Federal Election Commission reports for AFSCME, called the Reports Analysis Division (RAD) for assistance in responding to the RFAI sent on the 2020 Year-End Report. The RAD Analyst encouraged Ms. Wingfield to file amended reports to disclose appropriate corrective action to address the items noted in the RFAI. The Analyst noted that depending on the response AFSCME provides, RAD may refer AFSCME to another Commission office for further review (Attachment 3).

On May 3, 2021, Ms. Wingfield called the RAD Analyst for further clarification on how best to disclose data corrections for items cited in the RFAI. The Analyst suggested filing an amended FEC Form 5 and/or a FEC Form 99 (Miscellaneous Electronic Submission) (Attachment 3).

On May 18, 2021, AFSCME filed an FEC Form 99 which stated, in part: "Due to the large volume of the Year-End Report we will need more time to clarify the information" (Image 202105189446950691).

On June 15, 2021, the RAD Analyst called Ms. Wingfield in response to the FEC Form 99 filed on May 18, 2021. The Analyst noted RAD had not received AFSCME's amended filing and inquired if RAD could be of any assistance. Ms. Wingfield stated she hoped to file an Amended 2020 Year-End Report soon (Attachment 3).

On June 29, 2021, the RAD Analyst left a voicemail for Ms. Wingfield requesting the organization file their Amended 2020 Year-End Report. On July 15, 2021, Mr. Phillip Green, AFSCME's Assistant Director of Accounting, contacted RAD to notify the Analyst that the necessary corrections were almost complete. Mr. Green indicated AFSCME would file an amendment to the 2020 Year-End Report soon. Mr. Green also mentioned that going forward, he would be the best point of contact for the organization (Attachment 3).

On July 30, 2021, AFSCME filed an Amended 2020 Year-End Report, which disclosed one-hundred and forty-seven (147) independent expenditures totaling \$7,000,619.46 made in support of or opposition to forty-one (41) candidates for federal office. The amendment disclosed data entry corrections to election designations and candidate information, as well as one additional independent expenditure (Images 202107309452403147-97).

On August 3, 2021, AFSCME filed an FEC Form 99 stating, in part:

On August 19, 2021, AFSCME filed one (1) 24-Hour Report disclosing twenty-eight (28) independent expenditures totaling \$23,163.49, disseminated on October 19, 20, and 27, 2021 (Images 202108199466353410-20).

On October 8, 2021, the Analyst called Mr. Green and informed him that AFSCME would be referred for review by another Commission office. The Analyst noted more information would be forthcoming and encouraged Mr. Green to provide any additional statement in an FEC Form 99 (Attachment 3).

To date, no further communications have been received from AFSCME regarding this matter.
