and Melinda Paterson, Treasurer (C00758664)

RESOLUTION TERMS: Certify closure of the Committee's federal account and

terminate its political committee status; and pay a civil

penalty of \$12,625.

Attached for your review is a signed Negotiated Settlement pertaining to ADR 1081 (RAD 22L-16). The ADR Office received this referral from the Reports Analysis Division (RAD) on June 14, 2022.

**SUMMARY:** RAD referred For A Better Colorado and Melinda Paterson (Respondents or the Committee) for four (4) issues.

Respondents failed to timely file one (1) 48-Hour Report totaling \$59,523.90 to support two (2) independent expenditures disclosed in the Amended 2020 October Quarterly Report, received October 26, 2021. The 48-Hour Reports were filed on January 5, 2021 and October 26, 2021, albeit untimely.

Respondents failed to disclose all financial activity on their 2020 October Quarterly Report. On May 5, 2021, the Committee filed an Amended 2020 October Quarterly Report which disclosed \$59,523.90 in additional disbursements.

Respondents failed to disclose all financial activity on their 2020 12-Day Pre-General Report. On October 26, 2021, the Committee filed an Amended 2020 12-Day Pre-General Report which disclosed \$50,030.00 in additional disbursements.

Lastly, Respondents failed to timely file one (1) 24-Hour Report totaling \$50,000.00 to support two (2) independent expenditures disclosed in the Amended 2020 12-Day Pre-General Report, received October 26, 2021. The 24-Hour Report was filed on October 26, 2021, albeit untimely<sup>1</sup>.

During negotiations, the Committee acknowledged its failure to timely disclose the independent expenditures and stated that it was unaware of independent expenditure reporting requirements since this was its first independent expenditure campaign. The Committee additionally notes that it intends to terminate its political committee status upon resolution of this matter.
