The Committee was involved in MUR 7709, which was transferred to ADRO on October 28, 2021. The ADRO matter (ADRO 1069) was closed on August 12, 2022.

XI. OTHER RELEVANT INFORMATION:

The Committee submitted an Amended 2022 April Quarterly Report on January 30, 2023. Review of this amendment revealed potential violations under Standard 6 (Mathematical Discrepancies) for which a Request for Additional Information ([RFAI](#)) was sent to the Committee on March 5, 2023. Since the RFAI response due date has not passed, these potential violations are not included in this referral.

⁶ On 3/22/2023, the Committee filed a [Form 99](#) confirming the fraud was due to an external email hack. Per Standard 30 of the *2021-2022 RAD Review and Referral Procedures*, external fraud is eligible for referral to the RAD Education Program. After the Audit commences, RAD will coordinate with Audit on the timing and necessity of a referral to the RAD Education Program.
