These contributions were received from ten (10) individuals, as detailed below: Schedule A of the Committee's report disclosed the receipt of excessive contributions totaling \$23,800.00 from nine (9) individuals. Schedule A of the Committee's report disclosed the receipt of a \$2.00 contribution from one (1) individual who has a mailing address outside of the United States. The Committee did not establish that it follows the safe harbor guidelines for contributions received from a foreign address outlined in 11 CFR §110.20(a)(7).
