III. BACKGROUND:

**Excessive and Other Impermissible Contributions: Failure to Refund, Redesignate, or Reattribute Excessive Contributions within the Permissible Timeframe**

Rodney for Congress (“the Committee”) received excessive contributions totaling \$3,625.00 for the 2022 Primary and General Elections from multicandidate committees, non-qualified committees, and affiliated committees. The Committee refunded all of these contributions outside of the permissible timeframe.

**2022 July Quarterly Report**

During the [2022 July Quarterly](#) reporting period, June 9, 2022, through June 30, 2022, the Committee received excessive contributions totaling \$3,625.00 from multicandidate committees, non-qualified committees, and affiliated committees that were not remedied within the permissible timeframe.

On September 7, 2022, a [Request for Additional Information \(RFAI\)](#) was sent to the Committee referencing the 2022 July Quarterly Report, filed July 15, 2022. The RFAI

noted the Committee's receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.

On October 15, 2022, the Committee filed the [2022 October Quarterly Report](#) covering the period from July 1, 2022 to September 30, 2022. This report disclosed refunds of \$500.00 in 2022 General Election contributions from a multicandidate political action committee, made outside the permissible timeframe.

On December 6, 2022, the Committee filed an [Amended 2022 October Quarterly Report](#) which disclosed refunds of \$3,125.00 from multicandidate committees, non-qualified committees, and affiliated committees not previously disclosed on the original report. All these refunds were made outside the permissible timeframe.

**Excessive, Prohibited and Other Impermissible Contributions: Failure to Refund, or Redesignate General Election Contributions within the Permissible Timeframe after the Candidate Lost the Primary Election**

Rodney for Congress ("the Committee") received 2022 General Election contributions totaling \$479,783.82 that were not refunded or redesignated within the permissible timeframe from the date Rodney Davis ("the Candidate") lost the 2022 Illinois Primary Election. The Committee refunded \$467,783.82<sup>1</sup> of these contributions outside the permissible timeframe; contributions totaling \$12,000.00 were not remedied.

**2021 April Quarterly Report**

During the [2021 April Quarterly](#) reporting period, January 1, 2021 through March 31, 2021, the Committee received \$71,482.46 in 2022 General Election contributions from individuals that were not remedied within the permissible timeframe.

**2021 July Quarterly Report**

During the [2021 July Quarterly](#) reporting period, April 1, 2021 through June 30, 2021, the Committee received \$32,396.93 in 2022 General Election contributions from individuals and multicandidate political action committees that were not remedied within the permissible timeframe.

**2021 October Quarterly Report**

During the [2021 October Quarterly](#) reporting period, July 1, 2021 through September 30, 2021, the Committee received \$51,309.38 in 2022 General Election contributions from individual, multicandidate political action committees, and federal candidate committees that were not remedied within the permissible timeframe; of that amount, \$373.29 remains unremedied.

<sup>1</sup> \$500.00 of this amount was also included in the excessive contributions total in the previous section of this Referral, as one of the 2022 General Election contributions that was not timely remedied was excessive in addition to being impermissible due to the candidate's Primary Election loss.

### **2021 Year-End Report**

During the [2021 Year-End](#) reporting period, October 1, 2021 through December 31, 2021, the Committee received \$23,300.00 in 2022 General Election contributions from individuals, multicandidate political action committees, and federal candidate committees that were not remedied within the permissible timeframe; of that amount, \$100.00 remains unremedied.

### **2022 April Quarterly Report**

During the [2022 April Quarterly](#) reporting period, January 1, 2022 through March 31, 2022, the Committee received \$181,944.84 in 2022 General Election contributions from individuals, multicandidate political action committees, and federal candidate committees that were not remedied within the permissible timeframe; of that amount, \$5,526.71 remains unremedied.

### **2022 12-Day Pre-Primary Report**

During the [2022 12-Day Pre-Primary](#) reporting period, April 1, 2022 through June 8, 2022, the Committee received contributions totaling \$57,700.21 in 2022 General Election contributions from individuals and multicandidate political action committees that were not remedied within the permissible timeframe.

### **2022 July Quarterly Report**

During the [2022 July Quarterly](#) reporting period, June 9, 2022 through June 30, 2022, the Committee received \$49,150.00 in 2022 General Election contributions from individuals and multicandidate political action committees that were not remedied within the permissible timeframe; of that amount, \$1,000.00 remains unremedied.

On June 28, 2022, the Candidate lost the Illinois 2022 Primary Election.

On September 7, 2022, an [RFAI](#) referencing the 2022 July Quarterly Report was sent to the Committee. The RFAI noted the Committee's receipt of apparent 2022 General Election contributions that were not refunded or redesignated within the permissible timeframe from the date the Candidate lost the 2022 Illinois Primary Election and requested that the Committee take corrective action concerning these contributions.

### **2022 October Quarterly Report**

During the [2022 October Quarterly](#) reporting period, July 1, 2022 through September 30, 2022, the Committee received \$500.00 in 2022 General Election contributions from a multicandidate political action committee that was not remedied within the permissible timeframe.

The October Quarterly Report also disclosed refunds of \$467,783.82 in 2022 General Election contributions from individuals, multicandidate political action committees, and federal candidate committees that were not remedied within the permissible timeframe.

### **2022 Year-End Report**

During the [2022 Year-End](#) reporting period, October 1, 2022 through December 31, 2022, the Committee received a \$5,000.00<sup>1</sup> 2022 General Election contribution from a multicandidate political action committee that was not remedied within the permissible timeframe and remains unremedied.

On March 21, 2023, an [RFAI](#) referencing the 2022 Year-End report was sent to the Committee. The RFAI noted the Committee's receipt of an apparent 2022 General Election contribution that was not refunded or redesignated within the permissible timeframe from the date the Candidate lost the 2022 Illinois Primary Election and requested that the Committee take corrective action concerning this contribution.

Since October 18, 2022, RAD logged eight (8) communications with the Treasurer of the Committee which reflect efforts to help the Committee voluntarily comply with the Act. RAD was able to successfully connect with the Committee on two (2) occasions. RAD informed Thomas Datwyler, Treasurer, of the excessive and outstanding unrefunded 2022 General Election contributions and explained the matters were referable to another Commission office for further Commission action. To date, no further communications have been received from the Committee regarding this matter.
