III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to File and Timely File 24-Hour Reports)

Michigan Liberation Action Fund (“the Committee”) failed to timely file fourteen (14) 24-Hour Reports to support forty-two (42) independent expenditures totaling \$37,537.12 disclosed on the Amended 2022 October Quarterly Report, made after the 20th day but more than 24 hours before the 2022 Primary election held in the state of Michigan. The Committee also failed to file one (1) 24-Hour Report to support four (4) independent expenditures, totaling \$2,882.09, and failed to timely file seventeen (17) 24-Hour Reports to support eighty (80) independent expenditures, totaling \$64,260.02, disclosed on the Amended 2022 30-Day Post-General Report, made after the 20th day but more than 24 hours before the 2022 General Election (Attachment 1).

2022 October Quarterly Report

On October 17, 2022, the Committee filed the original [2022 October Quarterly Report](#) covering the period from July 1, 2022, through September 30, 2022. The report did not disclose a [Schedule E \(Itemized Independent Expenditures\)](#).

On February 1, 2023, the Committee filed an [Amended 2022 October Quarterly Report](#). The report included a [Schedule E](#) disclosing thirty-two (32) independent expenditures, totaling \$42,899.58, made in support of one (1) federal candidate.

On February 15, 2023, a [Request for Additional Information \(RFAI\)](#) was sent to the Committee referencing the Amended 2022 October Quarterly Report, received February 1, 2023. The RFAI noted that the Committee may have failed to file one (1) or more of the required 24-Hour Reports of independent expenditures. A chart was included with the RFAI identifying independent expenditures, totaling \$37,537.12, for which 24-Hour Reports had not been filed (Attachment 1).⁶

On March 22, 2023, the Committee filed an additional [Amended 2022 October Quarterly Report](#). The report included a [Schedule E](#) disclosing forty-eight (48)⁷ independent expenditures, totaling \$42,899.58, made in support of one (1) federal candidate.

Also on March 22, 2023, the Committee filed [sixteen \(16\) 24-Hour Reports](#) to support the expenditures disclosed on the Amended 2022 October Quarterly Report, received March 22, 2023 (Attachment 1).⁸

On March 23, 2023, the Committee amended one (1) [24-Hour Report](#) supporting three (3) expenditures disseminated on July 22, 2022 totaling \$2,681.23 (Attachment 1).

Also on March 23, 2023, the Committee amended one (1) additional [24-Hour Report](#) supporting three (3) independent expenditures disseminated on July 25, 2022 totaling \$2,681.23 (Attachment 1).⁹

⁶ Four (4) expenditures, totaling \$5,362.46, disclosed on Schedule E of the Amended 2022 October Quarterly Report, received February 1, 2023, were disseminated on August 1, 2022 and August 2, 2022, after the applicable 24-Hour reporting period of July 14, 2022 through July 31, 2022 and were not included in the RFAI chart.

⁷ The Amended 2022 October Quarterly Report, received on March 22, 2023, disclosed no change to the total amount of independent expenditures that were disclosed on the Amended 2022 October Quarterly Report received on February 1, 2023.

⁸ Six (6) expenditures, totaling \$5,362.46, disclosed on two (2) of the 24-Hour Reports filed on March 22, 2023 were not required, as they reflect expenditures that were disseminated on August 1, 2022 and August 2, 2022, after the applicable 24-Hour reporting period of July 14, 2022 through July 31, 2022 for the Michigan Primary Election.

⁹ The original 24-Hour Reports filed on March 22, 2023 each disclosed two (2) unique expenditures and one (1) duplicate expenditure rather than three (3) unique expenditures disseminated on July 22, 2023 and July 25, 2023 (as disclosed on Schedule E of the Amended 2022 October Quarterly Report). The 24-Hour Reports were each amended to correctly disclose three (3) unique expenditures.

2022 30-Day Post-General Report

On December 20, 2022, the Committee filed the original [30-Day Post-General Report](#), covering the period from October 20, 2022, through November 28, 2022. The report included a [Schedule E \(Itemized Independent Expenditures\)](#) disclosing sixty-nine (69) independent expenditures totaling \$77,179.77, made in support of two (2) federal candidates.

On February 1, 2023, the Committee filed an [Amended 2022 30-Day Post-General Report](#). The report included a [Schedule E](#) that disclosed no changes from the original report.

On February 15, 2023, [an RFAI](#) was sent to the Committee referencing the Amended 2022 30-Day Post-General Report, received February 1, 2023. The RFAI noted that the Committee may have failed to file one (1) or more of the required 24-Hour Reports of independent expenditures. A chart was included with the RFAI identifying independent expenditures, totaling \$67,142.11, for which 24-Hour Reports had not been filed (Attachment 1).¹⁰

On March 22, 2023, the Committee filed an additional [Amended 2022 30-Day Post-General Report](#). The report included a [Schedule E](#) disclosing ninety-two (92)¹¹ independent expenditures, totaling \$77,179.84, made in support of two (2) federal candidates.

Also on March 22, 2023¹², the Committee filed [twenty-two \(22\) 24-Hour Reports](#) to support the expenditures disclosed on the Amended 2022 30-Day Post-General Report, received March 22, 2023 (Attachment 1).

On March 23, 2023, the Committee amended one (1) [24-Hour Report](#) to support four (4) independent expenditures disseminated on October 22, 2022, totaling \$2,882.09 (Attachment 1).¹³

Since March 2, 2023, Reports Analysis Division (RAD) logged two (2) communications with a representative of the Committee which reflect efforts to help the

Committee voluntarily comply with the Act regarding the matters referenced above. RAD advised that missing 24-Hour Reports be filed for independent expenditures disclosed on the Committee's reports, and notified Matthew Hollerbach, Administrative Manager for the Committee, that the late and non-filed 24-Hour Reports referenced in the RFAs regarding the Amended 2022 October Quarterly and 30-Day Post-General Reports would be referred to another office at the Commission for further review. The Committee was also advised that an FEC Form 99 (Miscellaneous Electronic Submission) could be filed to provide additional clarification for the public record (Attachment 2). To date, no further communications have been received from the Committee regarding these matters.
