III. BACKGROUND:

A. Excessive, Prohibited and Other Impermissible Contributions: Failure to Refund, Redesignate, or Reattribute Excessive Contributions within the Permissible Timeframe

Mark Kelly for Senate ("the Committee") received excessive 2022 Primary and General Election contributions totaling \$81,881.97 from individuals, a partnership, a limited liability company (LLC), and multicandidate political action committees that were not remedied within the permissible timeframe. Of this amount, the Committee refunded \$75,456.97 outside of the permissible timeframe, and \$6,425.00 remains unremedied (Attachment 1).

2022 April Quarterly Report

During the <u>2022 April Quarterly</u> reporting period, January 1, 2022 through March 31, 2022, the Committee received excessive contributions totaling \$3,464.50 from individuals that were not remedied within the permissible timeframe (Attachment 1).

On May 4, 2022, a <u>Request for Additional Information (RFAI)</u> was sent to the Committee referencing the 2022 April Quarterly Report. The RFAI noted the Committee's receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.

The Committee disclosed remedies made outside of the permissible timeframe, totaling \$3,464.50, for excessive contributions received during the 2022 April Quarterly period (Attachment 1).

2022 July Quarterly Report

During the <u>2022 July Quarterly</u> reporting period, April 1, 2022 through June 30, 2022, the Committee received excessive contributions totaling \$22,007.00 from individuals, multicandidate political action committees, and an LLC that were not remedied within the permissible timeframe (Attachment 1).

On August 17, 2022, an <u>RFAI</u> was sent to the Committee referencing the 2022 July Quarterly Report. The RFAI noted the Committee's receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.
