III. BACKGROUND:

Excessive, Prohibited and Other Impermissible Contributions: Failure to Refund or Redesignate Excessive and Prohibited Contributions within the Permissible Timeframe

Zinke for Congress ("the Committee") received excessive and prohibited 2022 General Election contributions totaling \$49,956.90 from individuals, a multicandidate political action committee (PAC), unregistered organizations, limited liability companies (LLCs), and apparent corporations that were not remedied within the permissible timeframe. Of this amount, the Committee refunded \$37,355.40 outside of the permissible timeframe, and \$12,601.50 remains unremedied (Attachment 1).

2022 October Quarterly Report

During the <u>2022 October Quarterly</u> reporting period, July 1, 2022 through September 30, 2022, the Committee received excessive and prohibited contributions totaling \$47,165.40 from individuals, a multicandidate PAC, unregistered organizations, LLCs, and apparent corporations that were not remedied within the permissible timeframe (Attachment 1).

On December 8, 2022, a <u>Request for Additional Information (RFAI)</u> was sent to the Committee referencing the 2022 October Quarterly Report. The RFAI noted the Committee's receipt of apparent excessive and prohibited contributions and requested that the Committee take corrective action concerning these contributions.

The Committee disclosed remedies made outside of the permissible timeframe, totaling \$36,105.40, for excessive and prohibited contributions received during the 2022 October Quarterly period. Excessive and prohibited contributions totaling \$11,060.00 remain unremedied (Attachment 1).

2022 12-Day Pre-General Report

During the <u>2022 12-Day Pre-General</u> reporting period, October 1, 2022 through October 19, 2022, the Committee received excessive and prohibited contributions totaling \$815.00 from individuals and unregistered organizations that were not remedied within the permissible timeframe (Attachment 1).

On December 8, 2022, an <u>RFAI</u> was sent to the Committee referencing the 2022 12-Day Pre-General Report. The RFAI noted the Committee's receipt of apparent excessive and prohibited contributions and requested that the Committee take corrective action concerning these contributions.

The Committee disclosed remedies made outside of the permissible timeframe, totaling \$500.00, for prohibited contributions received during the 2022 12-Day Pre-General period. Excessive contributions totaling \$315.00 remain unremedied (Attachment 1).

2022 30-Day Post-General Report

During the <u>2022 30-Day Post-General</u> reporting period, October 20, 2022 through November 28, 2022, the Committee received excessive contributions totaling \$1,976.50 from individuals that were not remedied within the permissible timeframe (Attachment 1).

On January 11, 2023, the Committee filed an <u>FEC Form 99 (Miscellaneous Electronic Submission)</u> in response to the RFAIs referencing the 2022 October Quarterly and 12-Day Pre-General Reports. The Form 99 stated:

"Our committee is aware of the contribution limits and prohibitions for political committees. We have in place systems that monitor and rectify these transactions when they occur. Our committee had a transition to a different treasurer during this timeframe that led to some of these exceptions. Where refunds are required for excessive contributions, contributions from prohibited entities or contributions from unregistered organizations, they were made on 12-12-22 and will be reflected on the committee's Year-End report.

Some of the items listed have already been rectified and do not require further action.

Let's Get to Work PAC is a multi-candidate qualified committee (C00692327).

Missoula County Republicans contribution has been verified as federally permissible funds.

ONeal Electric is a partnership, and the contribution has been verified as federally permissible.

Beaverhead County Republican Central Committee contribution has been verified as federally permissible.

The Montana Gas & Oil PAC contribution has been verified as federally permissible."

On January 25, 2023, an <u>RFAI</u> was sent to the Committee referencing the 2022 30-Day Post-General Report. The RFAI noted the Committee's receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.

On February 15, 2023, the Committee filed an <u>FEC Form 99</u> in response to the RFAI referencing the 2022 30-Day Post-General Report. The Form 99 stated:

"We are in receipt of the letter regarding the above reference report. Please see below for our complete response. We have obtained documentation confirming that the possibly corporate contribution in question was a partnership, not incorporated, and federally permissible.

We are aware of the temporarily excessive contributions. The excessive portion of the great majority of these contributions has already been refunded and reported on the committee's Year-End report. For the few that were still within the 60-day window to remedy, the corrective action will be reported on the Committees Q1 2024 report. For the donations that require refunds, those were issued on 1-7-23 and will be reflected on that report.

The committee did void previously uncashed refund checks totaling \$2200. The original donors did not cash the refund checks issued. For those

donations, the committee will disgorge the funds to the treasury and that transaction will be reflected on the Q1 2024 report. The remaining voided check was not for an excessive contribution refund. It was for field consulting and the individual volunteered his time instead.

The contribution from the unregistered organization was refunded on 12-12-22 and reported on the committees Year-End 2022 report.

The memos for two transfers from the Zinke Victory Fund did not pull onto the report as they should. Also, there were memos that were below the itemization threshold for the transfer in which they did pull. Please see these transactions. When accounted for, the memo total exceeds the transfer amounts.

The Committee disclosed remedies made outside of the permissible timeframe, totaling \$750.00, for prohibited contributions received during the 2022 30-Day Post-General period. Excessive contributions totaling \$1,226.50 remain unremedied (Attachment 1).

Since December 12, 2022, the Reports Analysis Division (RAD) logged fourteen (14) communications with a representative of the Committee which reflect efforts to help the Committee voluntarily comply with the Act. RAD was able to connect with the Committee on nine (9) occasions and notified Paul Kilgore, Treasurer, that the Committee would be referred to another Commission office for further review (Attachment 2). To date, no further communications have been received from the Committee regarding this matter.
