III. BACKGROUND:

Excessive, Prohibited and Other Impermissible Contributions (Failure to Refund, Redesignate, or Reattribute Excessive Contributions within the Permissible Timeframe)

Catherine Cortez Masto for Senate (“the Committee”) received excessive contributions totaling \$38,496.72 for the 2022 Primary and General Elections from individuals. The Committee refunded all of these excessive contributions outside of the permissible timeframe (Attachment 1).

2021 Year-End Report

During the [2021 Year-End](#) reporting period, October 1, 2021 to December 31, 2021, the Committee received excessive contributions totaling \$10,650.00 from individuals that were not remedied within the permissible timeframe (Attachment 1).

On February 22, 2022, a [Request for Additional Information \(RFAI\)](#) was sent to the Committee referencing the 2021 Year-End Report. The RFAI noted the Committee’s receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.

On March 29, 2022, the Committee filed an [FEC Form 99 \(Miscellaneous Electronic Submission\)](#) which stated, in part,

“This is in response to your letter dated February 22, 2022 concerning the Year-End Report (10/01/2021 – 12/31/2021) for Catherine Cortez Masto For Senate (the “Committee”).

...For each of the contributions listed in this section of the RFAI they have either been refunded and will appear on the April Quarterly Report (01/01/2022-03/31/2022) or have had their contribution redesignated to General 2022 and will appear on the amended Year-End Report (10/01/2021-12/31/2021) to be filed.”

The Committee disclosed refunds totaling \$10,650.00 for the excessive contributions received during the 2021 Year-End period that were previously cited in the RFAI. All of these refunds were made outside of the permissible timeframe.

2022 April Quarterly Report

During the [2022 April Quarterly](#) reporting period, January 1, 2022 to March 31, 2022, the Committee received excessive contributions totaling \$8,285.77 from individuals that were not remedied within the permissible timeframe (Attachment 1).

On May 17, 2022, an [RFAI](#) was sent to the Committee referencing the 2022 April Quarterly Report. The RFAI noted the Committee’s receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.

On June 21, 2022, the Committee filed an [FEC Form 99](#) which stated,

“This is in response to your letter dated May 17, 2022 concerning the April Quarterly Report (01/01/2022 – 03/31/2022) for Catherine Cortez Masto For Senate (the “Committee”).

...The contributions referenced in the RFAI... have been refunded or redesignated as outlined by FEC rules and procedures. The Pre-Primary Report (04/01/2022 – 05/25/2022) filed on 06/02/2022 noted the refunded contributions. Additionally, contributions redesignated to the 2022 General will appear on the amended April Quarterly Report (01/01/2022 – 03/31/2022) and will be at a future date.”

The Committee disclosed refunds totaling \$8,285.77 for the excessive contributions received during the 2022 April Quarterly period that were previously cited in the RFAI. All of these refunds were made outside of the permissible timeframe.

2022 July Quarterly Report

During the [2022 July Quarterly](#) reporting period, May 26, 2022 to June 30, 2022, the Committee received excessive contributions totaling \$4,110.00 from individuals that were not remedied within the permissible timeframe (Attachment 1).

On August 16, 2022, an [RFAI](#) was sent to the Committee referencing the 2022 July Quarterly Report. The RFAI noted the Committee's receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.

On September 20, 2022, the Committee filed an [FEC Form 99](#) which stated, in part,

"This is in response to your letter dated August 16, 2022, concerning the July Quarterly Report (05/26/2022 - 06/30/2022) (the "Report") for Catherine Cortez Masto for Senate (the "Campaign").

...The contributions referenced in Section 1 have already been, or are in the process of being, refunded or redesignated as outlined by FEC rules and procedures. The Report noted that refunds or redesignations were in process, and that any such refunds or redesignations would appear on the Campaign's October Quarterly Report."

The Committee disclosed refunds totaling \$4,110.00 for the excessive contributions received during the 2022 July Quarterly period that were previously cited in the RFAI. All of these refunds were made outside of the permissible timeframe.

2022 12-Day Pre-General Report

During the [2022 12-Day Pre-General](#) reporting period, October 1, 2022 to October 19, 2022, the Committee received excessive contributions totaling \$7,938.95 from individuals that were not remedied within the permissible timeframe (Attachment 1).

On November 6, 2022, an [RFAI](#) was sent to the Committee referencing the 2022 12-Day Pre-General Report. The RFAI noted the Committee's receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.

On December 12, 2022, the Committee filed an [FEC Form 99](#) which stated,

"This is in response to your letter dated November 6, 2022, concerning the 12 Day Pre-General Report (10/01/2022 - 10/19/2022) (the "Report") for Catherine Cortez Masto for Senate (the "Campaign").

In accordance with FEC rules, the contributions referenced in your letter have either been refunded and reported as such on the Post-General Report

(10/20/2022 - 11/28/2022) filed on 12/08/2022, or will be refunded and reported as such on the Year End Report filed on 1/31/2023. The Campaign will also file amendments to address any duplicate contacts.”

The Committee disclosed refunds totaling \$7,938.95 for the excessive contributions received during the 2022 12-Day Pre-General period that were previously cited in the RFAI. All of these refunds were made outside of the permissible timeframe.

2022 30-Day Post-General Report

During the [2022 30-Day Post-General](#) reporting period, October 20, 2022 to November 28, 2022, the Committee received excessive contributions totaling \$7,512.00 from individuals that were not remedied within the permissible timeframe (Attachment 1).

On December 21, 2022, an [RFAI](#) was sent to the Committee referencing the 2022 30-Day Post-General Report. The RFAI noted the Committee’s receipt of apparent excessive contributions and requested that the Committee take corrective action concerning these contributions.

On January 25, 2023, the Committee filed an [FEC Form 99](#) which stated,

“This is in response to your letter dated December 21, 2022, concerning the 30 Day Post-General Report (10/20/2022 - 11/28/2022) (the “Report”) for Catherine Cortez Masto for Senate (the “Campaign”).

In accordance with FEC rules, the contributions referenced in your letter have been refunded and will be reported as such on the Year End Report (11/29/2022 - 12/31/2022) due on 1/31/2023. The Campaign will also file amendments to address any duplicate contacts.”

The Committee disclosed refunds totaling \$7,512.00 for the excessive contributions received during the 2022 30-Day Post-General period that were previously cited in the RFAI. All of these refunds were made outside of the permissible timeframe.

Since May 12, 2023, RAD logged five (5) communications with a representative of the Committee which reflect efforts to help the Committee voluntarily comply with the Act. RAD was able to successfully connect with the Committee on one (1) occasion by phone and two (2) occasions via email and notified the Committee that the untimely refunded excessive contributions would be referred to another Commission office for further review (Attachment 2).
