**I. STATEMENT OF FACT**

***“A formal complaint should contain a clear and concise recitation of the facts describing the violation of a statute or law over which the Commission has jurisdiction.” (11 C.F.R. § 111.4)***

A. I reviewed the Q2 and Q3 filings for Gary Grasso, Republican candidate for US House of Representatives for the 6<sup>th</sup> Congressional District of Illinois, Committee ID C00799247 named as “GRASSO FOR CONGRESS 6.” These filings are available here: Q2

**I, complainant Patricia A. Davis, allege that the above-named candidate did not truthfully file his regularly-scheduled Q2 (filed 7/9/2024) and Q3 (filed 10/15/2024) as regarding his repayment of his loans to his committee, or lack thereof.**

On its July 2024 Quarterly statement (Q2), the committee shows the candidate loaned his committee \$100,000 on 1/14/2022 and another \$150,000 on 6/8/2022. The Q2 shows the total amount of these two loans, \$250,000. See <https://docquery.fec.gov/cgi-bin/forms/C00799247/1794780/sc/10>

However, on its October 2024 Quarterly statement (Q3), the committee has not declared that the \$150,000 loan was repaid, only the \$100,000 loan is declared as unpaid and still owed. See <https://docquery.fec.gov/cgi-bin/forms/C00799247/1825970/sc/10>

***What has happened to that \$150,000 loan to the committee?***

B. I reviewed the Q2 and Q3 filings for this committee’s “Cash On Hand.”

**I, complainant Patricia A. Davis, allege that the above-named candidate did not truthfully file his regularly-scheduled Q2 (filed 7/9/2024) and Q3 (filed 10/15/2024) as regarding the committee’s “Cash On Hand” totals.**

On its July 2024 Quarterly statement (Q2) the committee reports \$1,558.58 cash on hand at the end of the reporting period.

However, on its October Quarterly statement (Q3) the committee shows \$54,511.25 cash on hand at the end of the reporting period. But the committee shows no receipts or any other influx of money, a discrepancy of \$62,952.67. No amendments have been filed to date.

***How does this committee explain the income discrepancy with no receipts?***
