To Whom It May Concern:

I am filing a complaint against Congressman Sam Farr from the 17th District in the State of California. The following appear to be violations of campaign law.

1. Mr. Farr reports on your web site that at the end of the 2000 Congressional campaign he had cash on hand in the amount of \$48,944. For the 2002 campaign he reports that on 5/17/2001 he repaid a loan to himself in the amount of \$10,000. This would seem very unlikely. On 7/16/2001 he reports that he made a contribution of *excess funds* to the Democratic Campaign Committee in the amount of \$7,500. On 8/20/2001 he again reports that he made a contribution of excess funds to the Democratic Campaign Committee in the amount of \$7,500. Why would \$15,000 dollars in excess funds be available to return if in fact his campaign needed a personal loan from Mr. Farr in the amount of \$10,000? This is a man that has been in office for ten-years and has never shown that he has contributed a penny to his campaign. I believe that this repayment of a supposed loan from Mr. Farr to his campaign *must be investigated*. There is not a single incumbent that has been there for ten-years that has to make loans to his already deep pockets. A repayment of a loan that never took place for \$10,000 from his campaign to himself is fraud. He never lists that he made a contribution to his campaign for \$10,000.
2. Beginning on 4/15/2002 Mr. Farr began making payments every 2 weeks to his local campaign chair (Plasha Fielding) in the amount of \$1,703. Every two weeks like clockwork. No problem there, however on the same date that these payroll checks were made to her, they also made a payment to River City Business Service for \$35 dollars for payroll services. Still no problem. *However, on these same dates a check was made to River City Payroll Services for \$987.00 and this amount was listed as payroll taxes*. Is it legal to issue a payroll check to the campaign chair that has *no withholding taxes*, and then turn around and *pay those taxes for that person out of campaign funds*? These payroll taxes grew in amounts as her salary increased over the length of the campaign. His campaign shows that he paid State Compensation Insurance Fund expenses, and these as an employer would seem to be legal campaign expenses. However, paying the individuals entire tax from campaign funds is fraud.
3. After the campaign was over on November 5, 2002, Mr. Farr's expenditures show that 13 days later someone went to Circuit City Computer Stores and purchased two computers (both exactly the same amount, \$2,016.00) one listed for Plasha Fielding and the other does not designate whom it was for. Two computers after

the election was over. Gifts? Is this legal? If it was a gift, it should have been listed as a gift.

Thank you for checking these questions I have. I appreciate your checking into this matter. I have attached and highlighted all expenditures that I have referred to in this document.

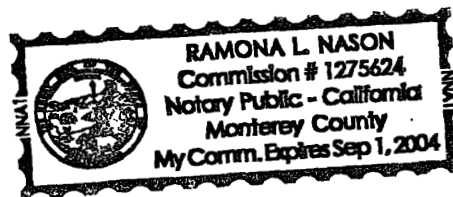
