Re: Complaint

Dear Chairman Smith:

I am filing this complaint against the Westchester Coalition for Legal Abortion, Inc. (WCLA), and their Federal Political Action Committee PAC # C00202804 operating under the name ProChoice Voter.

My complaint is based upon two separate apparent violations of law. The first is that a check of your website disclosed that no October 15, 2003 Finance Report was filed. The report is now 90 days late.

My second complaint relates to an interest free loan ProChoice Voter received from WCLA in 2000. As of June 30, 2003, three years later, the interest free loan remains outstanding. The reported amount is \$23,955.66. The year end 2002 report disclosed under itemized deductions that two separate amount were paid to WCLA, \$2,309.95 on 12/2/02. and \$3,000.00 on 12/27/02. These items are disclosed to be reimbursements for "calls, promotion of prochoice candidates", presumably for the 2002 election cycle. The loan balance was reduced by this identical amount. If funds were spent in 2002 for 2002 political activity, reducing the loan balance is a violation of law. I call for an investigation of WCLA's 2002 Federal political activity to determine what laws, if any, have been broken.


ProChoice Voter is a captive PAC. It is apparent that no effort is being undertaken to fundraise to pay back the loan. As such, the loan is a sham. WCLA


undertook illegal federal political activity in 2000. The failure to fully repay the loan by this time must not be ignored.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your report discloses the receipt of funds, disclosed as a loan, from an apparent connected organization (pertinent portion(s) attached). 2 U.S.C. §441b prohibits the receipt of funds from national banks, corporations, and labor organizations. Under 11 CFR §114.5(b)(3), however, a separate segregated fund may be reimbursed for any solicitation or other administrative expense provided that the reimbursement is made no later than thirty days after the expense was paid by the separate segregated fund; however, your committee is registered as a nonconnected committee. A nonconnected committee is a political committee that is not a party committee, an authorized committee of a candidate or a separate segregated fund established by a corporation, labor organization or member organization. 11 CFR §100.5(a) and 106.6(a)

If the receipt in question was incompletely or incorrectly disclosed, you should amend your original report with the clarifying information. Please provide further clarifying information regarding the date(s) on which the committee made payments for any solicitation or other administrative expenses. To the extent that the reimbursement was made beyond thirty days, your committee must transfer the funds to an account not used to influence federal elections or refund the full amount to the apparent connected organization in accordance with 11 CFR §103.3(b). Commission recommends that you inform the apparent connected organization in writing to provide them with the option of receiving a refund or granting written authorization of a transfer-out to protect the donor's interest.

Please inform the Commission of your corrective action immediately in writing and provide a copy of your check for the transfer-out or refund. In addition, any transfer-out or refund made should be disclosed on Schedule B supporting Line 22 or 28 of the report covering the date on which the transaction was made.

Although the Commission may take further legal action concerning the acceptance of prohibited funds, prompt action by your committee to refund or transfer-out the amount will be taken into consideration.

-Your report discloses a loan from Westchester Coalition for Legal Abortion, and notes that "loan proceeds paid independent expenditures directly." The receipt of the loan is itemized on Line 13 of the Detailed Summary Page, and included in the Line 19 total; however, the independent expenditures made by your committee have not been included in the Line 30 total. Please note that if your committee makes loan repayments in addition to the reported independent expenditures, and reports both of these categories of disbursement, it may cause inflated disbursement totals. 11 CFR §104.3(b)(iii) and 104.3(b)(vii) Please amend your report to clarify this discrepancy.

-The total listed on Line 20, Column B of the Detailed Summary Page appears to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B total. Please amend your report and any subsequent reports that may be affected by this correction.

-Please provide the totals for Lines 11(a)(i), 11(a)(ii), 11(iii), 11(d) and 17, Column B of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.

-The Summary Page discloses \$3,055.00 on Line 6(c), but the Detailed Summary Page shows the Line 19 total to be \$10,887.00. These figures should be the same. Please amend your report accordingly.

-Line 10 of the Summary Page of your report discloses a total of \$7,932.00 in Debts and Obligations Owed by the Committee. The sum of the entries itemized on Schedule C, however, indicates the total to be \$17,692.00. Please amend your report to clarify the discrepancy.

-Please provide a Schedule A to support the entry reported on Line 13 of the Detailed Summary Page. All loans and loan repayments received by your committee must be itemized on Schedule A regardless of the amount loaned or repaid. 2 U.S.C. §434(b)(3)(E)

-Your report discloses no payments for administrative expenses. Administrative expenses are payments made for the purpose of operating a political committee including, but not limited to, rent, utilities, salaries, telephone service, office equipment and supplies. Any such payments to a person aggregating in excess of \$200 in a calendar year must be disclosed on Schedule(s) B, supporting Line(s) 21(b) of the Detailed Summary Page. 2 U.S.C. §434(b)(5) If these expenses are being paid by a connected organization, your Statement of Organization must be amended to reflect this relationship. 2 U.S.C. §433(b)(2) In addition, if expenses have been incurred but not paid in a reporting period, the activity should be disclosed as a debt on Schedule D, if the obligation is \$500 or more, or outstanding for sixty days or more. 11 CFR §104.11

Any goods or services provided to your committee by a person, except volunteer activity (i.e., a person's time), would be considered an in-kind contribution from that person, and would be subject to the disclosure requirements of 2 U.S.C. §434(b)(3) and 11 CFR §104.13, and the limitations and prohibitions of 2 U.S.C. §§441a and 441b.

Clarification regarding administrative expenses should be disclosed during each two year election cycle beginning with the first report filed in the non-election year. Please verify that all expenses referenced above (i.e.; rent, salaries, utilities, etc.) have been adequately disclosed. If these services have been provided by volunteers, please confirm this in writing.

-A political committee that has established a federal account and a non-federal account must allocate between its federal and non-federal account all expenses for administrative costs, generic voter drives and fundraising programs or events. 11 CFR §106.6(b)(2)


