Dear Mr. Jordan:

I write on behalf of Gotham Construction Company, LLC ("Gotham"). On March 31, 2004 Gotham received your letter in connection with the above-referenced complaint. The complaint alleges that approximately 40 entities violated the Federal Election Campaign Act (the "Act") by being corporations that contributed to "Citizens for Tracy E. Boyland". The Gotham contribution amount at issue is \$2000.

Gotham is a limited liability company and has not elected to be treated as a corporation under the Internal Revenue Code. Because Gotham is taxed as a partnership and not a corporation, it is my understanding that Gotham is not prohibited from making otherwise legal contributions to Federal campaigns. However, after receiving your letter, to avoid any confusion and the risk of violating the Act, Gotham requested and received a refund from the Boyland campaign. A copy of the refund check is attached.

Gotham respectfully requests that no penalty be assessed against it. If I can provide you with any additional information, please let me know. Thank you.


