Please be advised that my firm represents E-Z Pay, Inc. in connection with the above entitled matter.

I am writing to you in answer to your letter dated March 24, 2004 concerning a formal complaint made by Congressman Major R. Owens, against Citizens for Tracy E. Boyland.

Enclosed herewith please find Statement of Designation of Counsel which has been signed by Kojo Badu, President of E-Z Pay, Inc.

Mr. Badu has advised me that some time during October, 2003, a representative of council woman, Tracy E. Boyland, contacted his office to solicit a contribution for her election campaign. At that time, Tracy E. Boyland was running for re-election to New York City Council, which was scheduled for November, 2003. Mr. Badu agreed to make a contribution and did, in fact, contribute \$250.00 from E-Z Pay, Inc. to her campaign. At that time, Mr. Badu believed that the money was to be used for a New York City Council Election, not a Federal Congressional Election.

Upon receipt of the letter from the Federal Election Commission in March, 2004, Mr. Badu contacted Ms. Boyland, and advised her of the letter and requested the return of the \$250.00. The money then was immediately returned by Ms. Boyland to E-Z Pay, Inc.

At no time did Mr. Badu and/or E-Z Pay, Inc. intentionally violated the Federal Election Law.
