
II. IDENTITY OF RESPONDENT

On or about the week of March 1, 2004 The Republican Liberty Caucus of Texas sent a direct mail piece to homes in Williamson County, Texas using soft money on behalf of a federal candidate. The direct mail piece did not include a disclaimer stating who paid for it. The mailing was done on behalf of Wes Riddle, candidate for the Republican nomination in U.S. Congressional District 31 (Texas). This came to my attention via a friend showing me the direct mail piece (attached).


