I am charging the Dean for American campaign at P.O. Box 1228 Burlington, VT 05402 with failing to report contributions totaling \$200 or more from me. The first donation was for \$25.00 and was given online to the Dean for American campaign on 10/23/03. The second was for \$175.00 and was given on 11/7/03. I complied with the law on both contributions regarding my address, citizenship, and occupation so they could be reported for matching funds. Both were well before the threshold deadlines for matching funds and in excess of the amount required to be filed under FECA. 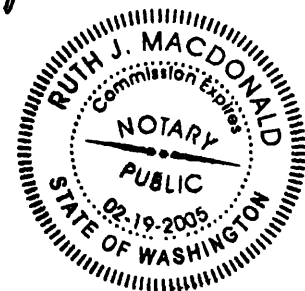
