Re: ADR 195 (MUR 5476)

Dear Mr. O'Neill:

On July 13, 2004, the Federal Election Commission ("Commission") notified the National Organization For Women PAC and Terry O'Neill, Treasurer ("Respondents") of a complaint alleging certain violations of the Federal Election Campaign Act of 1971, as amended. A copy of the complaint was enclosed with the notification.

After considering the circumstances of this matter, the Commission determined to exercise its prosecutorial discretion and to take no action against the Respondents. In its memorandum to the Commission, dated October 19, 2004, this office stated:

**ADR 195/MUR 5476:** The New York Attorney General's Office ("NYAG"), Charities Bureau referred this matter to the Commission for possible FECA violations. NYAG's review of the Harold and Marian Coleman Charitable Foundation, Inc. (the "Foundation"), disclosed the Foundation made donations during the fiscal years ending 1998-2003 to various organizations thought to be political committees registered with the FEC.

Respondent Carol Kaufman, Director/President of the Foundation, contends that it was never her intent to send donations prohibited under the law. She contributed to various organizations and received a "no goods or services letter." Virtually all of the organizations she contributed to, as outlined in the complaint, are either not political committees as defined in the FECA, or the Foundation contributed to the non-federal account of the committee as confirmed by counsel for those organizations. Counsel for the party committees contend the contributions were not prohibited as they were prior to BCRA. Three of the five political committees that received prohibited contributions from the Foundation stated they refunded the contribution(s) as soon as they were made aware of the corporate connection. The fourth committee terminated in February 2004, and the fifth committee did not file a response.
