To Whom It May Concern:

I am filing a complaint against James Lee Feldkamp and the Jim Feldkamp for Congress Committee in Oregon's 4th Congressional District for delinquent reporting of contributions by his campaign during the 48-hour pre-primary period.

On May 14, 2004, the Jim Feldkamp for Congress Committee filed a 48 Hour Report for the pre-primary period. Oregon's primary election occurred on May 18, 2004. In his campaign report, eight contributions were accurately filed within the required 48-hour period. However, nine contributions were not reported in a timely manner within the 48-hour period, as required by Federal Election rules.

In the table on page 65 of the *FEC Guide for Congressional Candidates and Committees*, 48 Hour Notices ("reporting contributions of \$1000 or more") must be reported to the FEC if contributions are received "less than 20 days but more than 48 hours before the election." Those contributions, as reported by the Jim Feldkamp for Congress Committee are in violation of this rule. Those contributions are as follows:

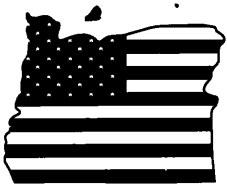

The above contributions all were required to be reported within 48 hours of receipt. However, Mr. Feldkamp waited until the Friday before Election Day and well after many Oregonians already had voted due to Oregon's all vote by mail elections. The vote by mail election window begins seventeen days before election day. In the most egregious example, Feldkamp waited two weeks before filing the required report. [SEE Aaron Jones Contribution above, 4/30/04]. As noted on the Federal Election Committee's website, "The Federal Campaign Act does not permit the Commission to grant extensions of filing deadlines under any circumstances. Filing late reports could result in enforcement action by the Commission." (<http://www.fec.gov/pages/report.htm>)
