

COMPLAINT

Janine Selendy and Friends of Selendy for Congress, by campaign manager, Michael J. Morey, as and for Janine Selendy and Friends of Selendy for Congress respectfully alleges upon information and belief that:

AS FOR A FIRST CAUSE OF ACTION

1. Michael Jaliman, potential Democratic candidate, is soliciting support for a possible candidacy on the letterhead of Innovation Consultants, a company that is incorporated in New York State. (See attached Letter labled "A"). Said solicitation is in direct violation of the Federal Election Campaign Act of 1971 (herein referred to as "Act").

2. Innovation Consultants, through use of their letterhead, is offering their goods and services to Michael Jaliman for use in his campaign. Such solicitation can be defined as an "in-kind" contribution, i.e. "a contribution of goods, services or property offered for free or at less than the usual and normal charge." (Title II of the Code of Federal Regulations (CFR) 100.52(d))


3. Contributions from incorporated businesses are not permitted. (CFR 114.2(a) and (b)) Therefore, Innovation Consultants in-kind contributions to potential candidate, Michael Jaliman are in violation.


AS AND FOR A SECOND CAUSE OF ACTION

4. Michael Jaliman has exceeded the five thousand dollar threshold (\$5,000.00) in expenditures, which would require him to file with the Federal Election Commission as a candidate. ((CFR) 100.72(b) and 100.131(b))

5. Michael Jaliman has made clear his intent to campaign and has exceeded the necessary limit by sending out numerous mailings (See "A"), making numerous phone calls, petitioning to gain ballot access (See "B"), paying for campaign assistance, travel throughout the 19th Congressional District and to the Democratic National Convention in Boston, and actively campaigning as a "candidate for Congress". Therefore, he is in violation of FEC policies by not filing.

WHEREFORE, the undersigned respectfully requests the Federal Election Commission investigate the prospective campaign of Michael Jaliman and the above-mentioned violations.

Dear Neighbor:

Hello! My name is Michael Jaliman and I am running for Congress for our 19th Congressional District. Allow me to introduce. I moved to Putnam County with my family from Long Island in July 2000, attracted by pristine nature, a safe environment, quality education, and proximity to NYC and Stewart airport. We feel blessed to call this beautiful county home. My decision to run for Congress came in part in wanting to safe guard some of things we hold precious about this beautiful lower Hudson Valley Watershed.

One concern we might share (which offers political opportunity for Democrats to elect Democrats to the County Legislature) is the rapid increase in property assessments. Dear Fellow Democrat:
