It was nice talking with you this morning.

As discussed, Klayman for Senate (a/k/a Friends of Larry Klayman) received the complaint in the above-referenced matter on Monday, September 27, 2004, by certified mail. Under the Federal Election Commission's (FEC) procedures a response would therefore be due by Tuesday, October 12, 2004. The complaint was forwarded to counsel on September 28, 2004, by Federal Express.

While our primary election has been held in Florida, counsel is engaged in a number of time sensitive matters for other clients and our treasurer is currently engaged in preparing the next quarterly report. In addition, there is an upcoming holiday, Columbus Day.

On behalf of the treasurer, Mr. James R. Graham, and Klayman for Senate we therefore request a two week extension of time, which we understand, from our conversation, is a reasonable amount of time to seek.

Accordingly, we respectfully request until and including October 26, 2004, a two week extension, to respond to the complaint.


