Gentlemen.

Please accept this letter as a formal complaint concerning a \$1,000 donation given to the John Kerry Campaign on June 20, 2003 which listed me as donor. I have not donated any money to the Kerry campaign, yet my name is listed in the July, 2003 campaign report.

The listing shows Maureen Haller, 147 Huron Ave. Holyoke, Mass. 01040, Homemaker. I moved from this address in November of 2002 and there was no other Maureen Haller living at that address after November 2002.

My husband (Charles Haller, Jr.) has called the Kerry campaign starting with their Boston office (617-367-1551) on April 2, 2004 and he was told by a John Dimanno that they would check in this matter, My husband asked for a copy of the check showing my signature. We did not hear anything back from the Boston campaign office and on April 14, 2004, my husband called the Boston office. At that time, when he asked to speak to John Dimanno, he was informed that there was no one by that name working in the Boston office. The person who answered suggested that perhaps he was in the Washington office and to call that office. My husband called the Washington office (Tel # 202-712-3000) and was told that there was no one by that name in the Washington office. The person my husband talked to was a person by the name of Ezra who stated he would take the request and would have it checked. My husband gave our address and telephone number.

A week later, April 21, 2004, we had not heard back from Ezra and my husband called the Washington office again, (202-712-3000), this time talking to a woman by the name of Becky. My husband outlined the problem and requested a copy of the check with my name on it. Becky stated that she would have this checked and would get back to us.

On May 3, 2004, still no response from the Washington office, my husband called the office again (202-712-3000), and was told that Peter Nichols, Chief Financial officer was handling this request and my husband's call was transferred to Mr. Nichols' phone where he left a voice mail to have Mr. Nichols call and give us the result of his investigation.

Another week passed and no message was received from Mr. Nichols. On May 11, 2004, my husband called Mr. Nichols again and was transferred to Mr. Nichols' line and again he left a voice mail outlining the problem again and asked Mr. Nichols to please call back and let us know why my name was used. My husband also stated that we felt that we were getting the run-around, we were becoming frustrated buy the non replies and that if we did not hear back from him , we would be filing a formal complaint with the Federal Election Commission.

On June 3, 2004, my husband called the FEC to find out the procedure to filing a complaint. As of this date we still have not heard from the Kerry campaign, thus the need to file this complaint. I trust that you will be able to get the information that I requested, namely, why my name was used and a copy of the check submitted on my behalf.

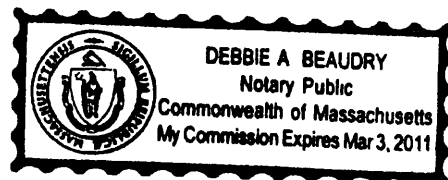



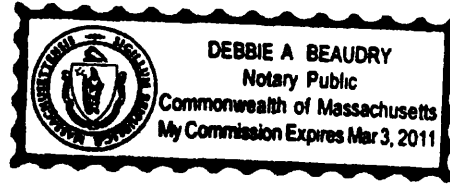
