Dear Mr. Jordan:

I am in receipt of your correspondence stamped with the date of August 6, 2004. As I understand the complaint received from one Michael Schroeder, it was filed against the committees for Sarbanes and Stabenow (the "Committees"). Notwithstanding the same, we are pleased to respond to your letter.

Mr. Schroeder states in his letter of July 26, 2004 that the Committees accepted "illegal soft money donation from *Friends of Lou Papan*, a California State Assembly committee that accepts donations from corporations and at levels in excess of Federal contribution limits." Neither of these allegations is correct.

With respect to the amount of contributions from *Friends of Lou Papan*, as you can see from the complaint, they do not exceed \$1,000 in any calendar year. In fact in 2003, the *Friends of Lou Papan* contribution was limited to \$250 and in 2004, the *Friends of Lou Papan* contribution was limited to \$750. Accordingly, the contributions are within the limitations prescribed by 11 C.F.R. 102(b).

With respect to the soft money allegation, the subject *Friends of Lou Papan* contributions were not from an account that contains soft money. As such, they are not soft money contributions.

The *Friends of Lou Papan* Committee maintains **two separate bank accounts**. The *Friends of Lou Papan* Committee designates one account for contributions to State races and the other account for contributions to Federal races. These accounts are maintained at the Peninsula Bank of Commerce, located at 1001 Broadway Avenue, Millbrae, CA 94030, Tel. (650) 697-4333. The account numbers are as follows:
