Recommendation to approve Settlement Agreement

Attached for your review is a signed negotiated ADR Settlement Agreement pertaining to ADR 225 (RR 04L-17), National Right to Life PAC and Amarie C. Natividad, Treasurer ("Respondents" or "Committee"). This case was opened on January 24, 2005 and was assigned to the ADR Office on March 3, 2005.

SUMMARY: RAD referred the National Right to Life PAC and Amarie C. Natividad, Treasurer ("Respondents" or "Committee") after they filed an Amended 2003 Year-End Report on April 8, 2004 to disclose additional unitemized contributions of \$125,099.76. This was a 74.6% increase in unitemized contributions disclosed in the original 2003 Year-End Report filed on January 29, 2004.

In response to a Request for Additional Information sent by RAD, the Committee stated that the additional receipts were due to the fact that Respondents had not completed a reconciliation of their books at the time the original report was due. Respondents state that the Committee's compliance problems began when its bank's technology failed to read most of the data on remittance documents. Respondents further state that they have taken a number of steps to ensure that complete disclosure reports are filed timely.

RECOMMENDATIONS:

1. Approve the attached settlement agreement of the National Right to Life PAC and Amarie C. Natividad, Treasurer.
2. Approve the appropriate letters.
3. Close the file on this matter.
