Recommendation to Close the File

**SENSITIVE**

On January 26, 2005, the ADR Office (ADRO) received from OGC/CELA a complaint, MUR 5501, to review and determine its appropriateness for ADR processing. Based on that review, we determined that the case, **ADR 232**, is inappropriate for ADR and recommend that the case be closed. Following the procedures approved by the Commission on March 3, 2003, this matter will be closed by ADRO if the Commission approves the recommendation in this memorandum. The Office of General Counsel (OGC) concurs in the description of this matter and also concurs that this matter will not be returned to OGC for further action.

**Summary:** Complainant contends that the Commission has allowed “illegal, insurgent organizations” (i.e., the named Respondents) to destroy the U.S. political process which “if allowed to continue will ... degenerate the electoral process”. Counsel for Respondents contends that the complaint is without merit, lacking statutory or regulator specificity and should be dismissed.

Attached for the Commission’s review is the ADR Case Analysis Report on **ADR 232** along with copies of the EPS Rating and ADR Rating Sheets.

**Recommendations:**

1. Take no further action and close the file as to all respondents.
2. Send the appropriate letters.

**Summary of Complaint:** Complainant contends that the Commission has allowed "illegal, insurgent organizations" (i.e., the named Respondents) to destroy the U.S. political process which "if allowed to continue will ... degenerate the electoral process".

**Respondents' Replies:** Counsel for Respondents contends that the complaint is without merit, lacking statutory or regulator specificity and should be dismissed.

**Alleged Violations:** The complaint fails to identify any specific violation of the FECA or Commission regulations.

**Analysis:** 11 C.F.R. 111.4(d)(3) requires that complaints filed with the Commission should contain a clear and concise recitation of the facts which describe a violation of a statute or regulation over which the Commission has jurisdiction. The subject complaint contains no description of any violation of the FECA or the Commission's regulations -- accordingly the matter should be dismissed.
