To whom it may concern;

This letter is to inform the Office of the General Counsel of a possible violation of Federal Election Commission Law. Specifically, "sale and use law"; 2 U.S.C. 438 (a) (4).

Complainant: Zachary M Long, Treasurer "Friends of Bob Anderson"

Facts that support violation: In recent months after the set April 15th FEC filing as well as the decision of Vermont candidate Robert G. Anderson to step down from this year's congressional race, all contributors on our itemized list (contributors over \$200.00) were solicited by the political committee "Friends of Greg Parke". They were thanked in paragraph two of the letter for their recent contribution of X dollars, which was the actual amount they contributed to "Friends of Bob Anderson". They were then told in paragraph 15 that they had already received an initial letter form the Parke Campaign, this statement was also false. In paragraph 16 they were referred to as generous contributors to the Parke campaign, another false statement. In paragraph 23 and 26 of said letter each person was asked to give at least the same amount that they contributed "the previous time" which was actually to the Anderson campaign and not the Parke Campaign. Finally in paragraph 27 they were asked if possible if they could double their contribution, for many people this would be yet another violation because they had already contributed \$2,000 to the Anderson campaign or by doubling the contribution it would put them over the election cycle limit of \$2,000. There is only one place where any political or commercial committee could get these names addresses and the exact amount that was contributed to the "Friends of Bob Anderson" committee and that is off the Federal Elections Commission website. The law clearly states that the use and sale of said information is prohibited by Federal elections law.



Complainant's Statement: As Treasurer of the political committee "Friends of Bob Anderson", Bob and the committee as a whole were taken back by the time and energy that we have had to put into explaining to close friends and family that number one their money did not go to Greg Parke's campaign like the fund raising letter sent by "Friends of Greg Parke" indicates, and no we did not sell or give away their personal information. Included are as many of the letters that we currently have and twelve or more are in the process of sending their letter to us so we can forward them to the FEC board. Please take special note that the amount given is in bold type, and that no matter what the amount was, the amount was identical to the amount from the itemized list of donors over \$200.00 from the Anderson Report, and it was asked to be doubled even if this donation would be in violation of total amount given per cycle (\$2,000). We believe this could be a oversight or an honest mistake, but aside from this we feel the duty to protect the process and correct this wrong for not only our campaign, but for The Parke campaign, other national Vermont campaigns, and all of our devoted contributors and supporters.





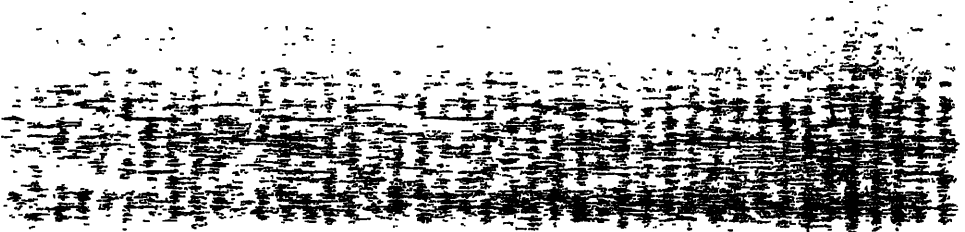
