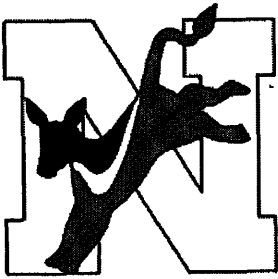

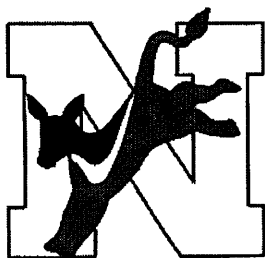

Please accept this letter as my official request for a Federal Election Commission (FEC) investigation into multiple FEC violations by the **Jeff Fortenberry for United States Congress** Committee, the Nebraska Republican Party and possibly by unnamed third parties.

Alleged Violations:

1. Billboard/Outdoor Advertising Facility with no authorization or disclaimer.

On August 31, 2004, I observed a new billboard with Jeff Fortenberry's image and campaign logo. The billboard is located on the corner of 10th/R Streets and the on-ramp to Highway 34 in downtown Lincoln, Nebraska. It remains on display as of today and I've enclosed a picture taken on this date, September 1, 2004 as supporting documentation. This is clearly an outdoor advertising facility expressly advocating for Jeff Fortenberry for Congress. FEC regulations require that any public communication by a political committee contain a disclaimer to state who paid for the communication. 11 C.F.R. § 110.11(a)(1). A billboard ("outdoor advertising facility") is considered a public communication. 11 C.F.R. § 100.26.

As the attached picture indicates, there is no disclaimer on the above mentioned billboard. Therefore, it is impossible to

ascertain whether the Fortenberry campaign has paid for this billboard or whether a third party has paid for it. The failure of the entity who paid for the billboard to provide the appropriate disclaimer deprives the general public with the information required by federal law to determine whether the billboard was appropriately paid for and authorized by the candidate who benefits from the advertising.

If this billboard was produced by the Fortenberry campaign, then the campaign has violated 2 U.S.C. § 441d by failing to state whether it had paid for the billboard. If the billboard was paid for by a third party, then that third party has violated the federal campaign laws, and the FEC should initiate an investigation as to whether the Fortenberry campaign had coordinated this activity with that organization which may have resulted in both an illegal and/or excessive contribution to the Fortenberry campaign.

2. Failure to disclose operating expenditures/in-kind contributions

The Jeff Fortenberry for Congress campaign headquarters is adjacent to and within the same structure as the Nebraska State Republican Party headquarters. It is my understanding that the building was purchased by the State Republican Party during this election cycle. A review of the Fortenberry campaign's disclosure reports with the FEC fail to show any rent or utility payments during the 2004 election cycle. Further, I believe that the space that is currently occupied by the Fortenberry campaign is part of the building owned by the Nebraska State Republican Party. Furthermore, I believe that this building was purchased solely with non-federal funds that do not meet the prohibitions and limitations of federal law. In addition, the Nebraska Republican Party has failed to disclose any in-kind contributions to the Fortenberry Campaign for rent or utilities. A photograph of the facility is enclosed with this complaint. The address of the Fortenberry HQ is 1620 N Street, Lincoln, NE (the State Party is adjacent - 1610 N Street).

Therefore, based upon information and belief, the Fortenberry campaign and the Nebraska State Republican Party have violated 2 U.S.C. §§ 434, 441a and 441b by failing to disclose both an excessive and illegal in-kind contribution from the Nebraska Republican Party to the Fortenberry campaign.

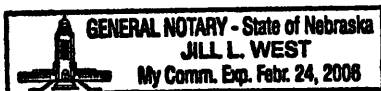
