statement of candidacy in accordance with millionaire's amendment.

Dear General Counsel:

It is my opinion that Michael Jaliman, candidate for Congress in the 19th Congressional
District of New York, and candidate committee "Michael Jaliman for US House of
Representatives" has, and continues to purposely and egregiously violate Federal
Election Campaign. I strongly urge you to consider the following facts, which clearly
support these claims.

During the New York State 2004 primary election the Jaliman campaign produced a web
site, produced and distributed at least two direct mail pieces and placed multiple pre-
recorded phone messages in New York's 19th Congressional district. As you know,
Federal law states that an individual becomes a candidate for federal office—and thus
triggers registration and reporting under the Act—when campaign activity exceeds
\$5,000 in either contributions or expenditures. The Jaliman primary campaign activity
appears to have at least reached this threshold, but to date the campaign has not filed any
financial reports with the FEC.

As you know, any public communication made by a political committee, even those that
do not contain a solicitation or express advocacy, must include a disclaimer. The
aforementioned website and direct mailings have not included the "paid for" disclaimer
language on its communications. This is yet another violation of Federal Campaign law
by the candidate and his campaign.

The Jaliman campaign has been actively involved in a federal campaign, exceeded the
\$5000 threshold, has yet to file a statement of candidacy with the Commission as well as
distribute said statement in accordance with the millionaires amendment.

Attached are copies of the mail pieces that were distributed by the Jaliman campaign, a
tape of the automated calls and a print out of the campaign web site. All of these items
have a cost associated with their production and distribution, as well as require proper
"paid for" disclaimer language.

Based on the facts outlined, I respectfully request an investigation into these violations of



He was a member of an alliance that successfully fought to prevent an antigay ordinance in Madison, Wisconsin. He organized Citizens for Human Rights, a pro-choice advocacy group that successfully lobbied to sustain the veto of an anti-abortion bill in Wisconsin. He also provided strategy that prevented the construction of a sewage plant off the coast of Massachusetts.

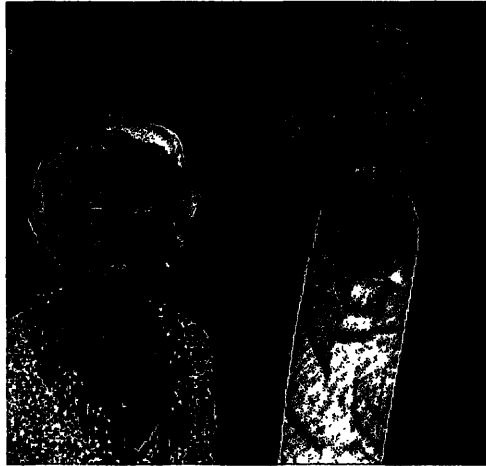

Sounding the Alarm of a Looming Economic Crisis

Mr. Jaliman has taken on the mission of warning the American people of the ticking economic time bomb of the Medicare and Social Security Systems' shortfall of tens of thousands of billions of dollars. According to Mr. Jaliman, "In a rare and unfortunate display of bipartisanship, leaders of both parties are ignoring this looming catastrophe." "Consider the math: even today, with the U.S. government running a budget deficit of \$521 billion, a looming shortfall of tens of thousands of billions (tens of trillions) is a staggering amount. This sum of money is too vast to borrow. The U.S. government's pension obligations of the American people are many times larger than the entire national debt or the combined value of all of the stocks listed on the N.Y. Stock Exchange. Where will the government get this kind of money to continue to pay its obligations to retirees?"

This looming domestic crisis could lead to tragedy for many Americans who depend on Medicare and Social Security for their retirement. For the first time in history the Medicare Program will run a deficit next year. In a staggering example of gross financial mismanagement, the government has spent money that people paid into their retirement system to finance budget deficits. Current Bush administration economic plans for a second term continue to use retirement payments to fund deficits.

The Bush economic plan for cutting dividend taxes and increasing spending was an expensive short-term stimulus that defers the nation's economic problems to the future. It creates large deficits and leaves little money for the government to meet its obligations to retirees or to provide opportunities for Americans who are not wealthy. While the economy may currently appear to be stable, such appearances are deceptive. Present short-term conditions of economic growth will not last without decisive action by our leaders. The Bush Administration's own budget analysis states, "Long-run budget projections show clearly that the [federal] budget is on an unsustainable path." Says Mr. Jaliman, "Under the Bush economic plan, the budget deficit will grow to a staggering 10 percent of the entire economy, endangering the financial well being of our nation. Yet political leaders from both parties have failed to act. My mission is to awaken the American people to the economic danger which faces our nation."

As a member of Congress, Jaliman will ask the Comptroller General of the United States to notify all Americans who have paid into the system of this situation by sending them an annual statement describing the financial health of the retirement and Medicare systems, akin to statements sent out by private retirement plans and mutual funds. He will also call for a Congressional investigation into the long-term financial health of our government to deal with a looming domestic crisis before it turns into a catastrophe for Americans who count on Medicare and Social Security for retirement.

"If corporate leaders neglected critical financial issues in such an irresponsible manner, they would certainly be fired, if not indicted," Mr. Jaliman said. "If the government were a private corporation running a large pension plan, it would be under investigation by regulators and facing court-ordered receivership. The American people must be educated about the potential consequences to their daily lives and to the nation from government mismanagement of financial obligations. Though finance and economics are not sexy issues that sell papers, I implore the media to undertake the critical public service of educating the public."

A Path Out of the Iraq Quagmire

We must disengage from Iraq as rapidly as possible, while giving Iraq the ability to stabilize itself without a American military presence. Maintaining massive numbers of American troops in Iraq does not serve our nation's strategic interests. The US is bogged down in a debilitating conflict. Whether one's original position was for or against the Iraq War, the following should be clear: Saddam Hussein has been captured, Iraqi weapons of mass destruction are not a threat, and the nation of Iraq will not be our new democratic friend in the Middle East. It is time to plan to bring home most of our forces, while still protecting our friends in the Kurdish region, by implementing a reasonable, workable plan to stabilize Iraq.

Our present course of conduct in Iraq can only lead to ongoing American casualties and additional exorbitant expense for the American taxpayer. It will not create the free and democratic Iraq espoused by the Bush administration.

We must recognize the basic reality ignored by virtually all Westerners since Messrs. Sykes and Picot, acting on behalf of the British and French governments, arbitrarily drew the boundaries of Iraq during World War I from remnants of the Ottoman Empire. This reality is that Iraq comprises at least three mutually antagonistic peoples—the Shites, the Sunnis, and the Kurds—who have been held together solely by the force of dictatorship. The only workable solution is to divide the country into self-governing ethnic cantons—the Swiss Model—and two separate Cantons for Baghdad, inside of an Iraqi free trade and economic zone. Such smaller political units will be able to maintain security and govern their communities by themselves because each will be charged with a manageable job and the cooperation of their local ethnic constituents, obviating the need for the U.S. to maintain a massive military presence to prop up a central Iraqi government. Such Cantons would include one or more Cantons in the Sunni triangle, Kurdistan, the Shiite region, the lands of the Turkoman, a federal district of Baghdad, and a Canton for the Shiite enclave of Sadr City. Oil wealth would be administered by both the Canton and the Central Government which—as in the Swiss model—would be charged with customs, international relations, and maintaining internal free trade. The Cantons would be individually responsible for security and for making and enforcing the internal

Applying my extensive experience in formulating policy, I have developed plans to stabilize Iraq, resolve the Israeli-Palestinian conflict, and wage a war of ideas in the Islamic world to isolate Al Qaeda and prevent Islamic societies from becoming breeding grounds for terrorists.

- My solution to the Iraq quagmire would divide Iraq into a number of ethnically-based cantons, much like Switzerland. This innovative plan to stabilize Iraq and rapidly withdraw American troops has been presented to Dean, Clinton, and Carter, as well as Kerry. As a Congressional candidate, I can place this plan on the national agenda.

- I have developed a new approach to resolve the Israeli-Palestinian Conflict. In brief, the plan calls for an international administration from the European Community (with a lead role for Britain and Turkey) to take over the administration of Palestine to develop its institutions to build a viable state genuinely committed to live in peace with Israel. The U.S. would provide political guaranties, and the international community would provide funding. This plan has received support from prominent leaders and experts involved with the region including Israeli Foreign Minister Peres, aides to Arafat, Prince Turki the Saudi Intelligence Minister, and Dennis Ross the Bush and Clinton Mideast negotiator.

"The situation in Iraq now is similar to that in Yugoslavia a decade ago, with warring ethnic communities and

Western nations idealistically attempting to maintain elements of the pre-Tito status quo— instead of accepting the reality that Yugoslavia was made up of mutually antagonistic ethnic communities with a history of enmity that went back centuries. The ill-conceived Western policy in Yugoslavia led to unnecessary bloodshed and suffering. We will see similar bad results in Iraq unless we consider a new policy—and quickly."

laws in their regions.

Troubled Iraq, nurtured on decades of psychopathic rule, is not a suitable candidate for an instantaneous Western style democracy; the Bush mission in Iraq cannot be accomplished, and it is not worth the ongoing waste of American lives and money to "hold the course" on Iraq. The best the administration could accomplish with its plans for a national democratic government is a Shiite regime friendly to Iran that dominates the entire nation.

Implementing the Canton System for Iraq will enable the US to withdraw troops and to wage a more cost-effective and appropriately targeted battle against Islamist terrorism, and plan our actions with deeper understanding of the peoples of this region and with greater cooperation from NATO and other allies, as we redeploy resources being ill-spent in the Iraq War to the War against Al Qaeda, the group that represents the real threat to our nation, both at home and abroad.

I invite the political parties in the United States, the American public, Iraqi leaders, and all interested parties to respond to these ideas for a Canton System for Iraq.

Position Summary

As a survivor of the terrorist attacks on 9-11, I am shocked and outraged that the Republican Leader of the House of Representatives Tom DeLay together with other pro-NRA Republican members of the House blocked the renewal of the assault weapon ban. 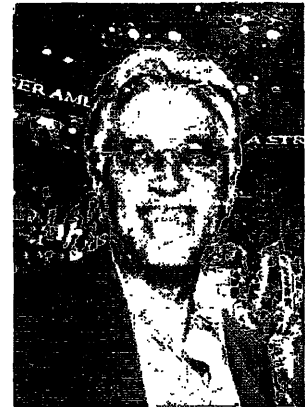

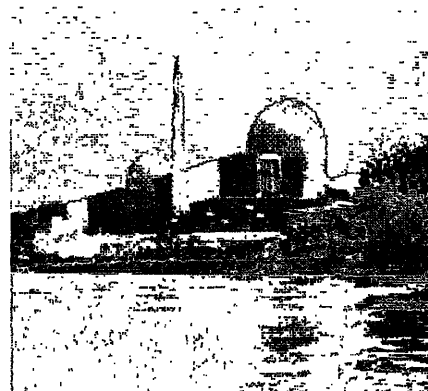

A huge part of the justification for the upkeep of Indian Point is simply the financial benefit to a few select groups of people (Buchanan township residents pay little or no property tax, and have a well-funded school system; Entergy's corporate managers and employees certainly benefit; the New York area would, of course, have to acquire electrical power from other sources if Indian Point were closed). This limited financial benefit is set against the "extremely unlikely" possibility of a Chernobyl or China-syndrome type disaster, which would presumably kill those same citizens of Buchanan who seem perfectly willing to take the risk, as well as thousands more people within a few miles of the plant. As it would also expose potentially millions of people within a 30-50 mile radius of Indian Point to radiation ranging from unhealthy to lethal, no one is talking about this in the same economic terms. The 9-11 hijackers flew right over Indian Point, electing to crash into the World Trade Center where, as a result, an area around a half-mile radius of "Ground Zero" was shut down for months, and perhaps tens of thousands of residents of Downtown Manhattan were evacuated for a period of months, and the total damage (besides around 3,000 dead) will probably be in the hundred billion dollar range.

Hypothetically, had those same terrorists decided, instead, to crash into Indian Point, if the jet-liner loaded with fuel breached the reactor, a comparable number of people would have died immediately from the explosions, with a somewhat larger number shortly thereafter from radiation effects...but the economic toll would probably have crippled the United States economy. Potentially, the entire New York metropolitan area might have had to be evacuated – and the most economically important city in the world would have had to shut down. Given recent events, and just how potentially vulnerable we are to terrorist assaults, this is not preposterous – and yet, because one small town gets tax breaks, the USA is supposed to accept this level of risk – as a nation!

New Industries, New Jobs

Speaking of his plan for national economic policy Mr. Jaliman said, We must consciously plan the new industries that will provide jobs for the American people. He says that he will use his team-building and problem-solving skills to forge bipartisan consensus to promote new technologies in

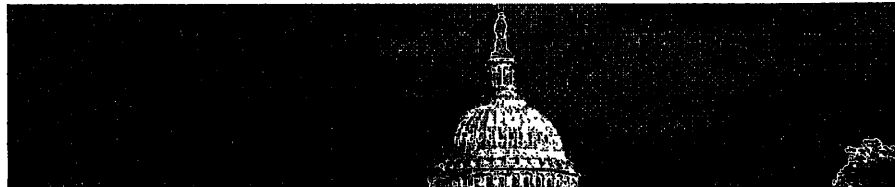
